#### **CHAIRMAN'S STATEMENT**

# **Profitability Sustained**

During the third quarter of 2007, CK Life Sciences Int'l., (Holdings) Inc. ("CK Life Sciences" or the "Group") continued to progress in line with its growth strategies.

During the first three quarters of 2007, CK Life Sciences reported a 12% growth in total revenue to nearly HK\$1.7 billion. Profit attributable to shareholders was approximately HK\$130 million, nearly 4 times that of the same period last year, and is already in excess of the profit reported for the full 12 months of 2006 (2006 full year profit: HK\$102 million).

The Board of Directors has not declared any dividend for the period under review (2006: Nil).

#### **Health Sales Over HK\$1 Billion**

Our health-related business achieved sales of more than HK\$1 billion in the first three quarters. Progress was made in enhancing the market penetration of our nutraceutical brands. The *VitaGain* range was further extended with new products that feature popular ingredients, while *AG Natural Health* has established itself as one of the top Western nutraceutical brands in Hong Kong.

The geographical reach of our health-related business, which spans Hong Kong, the Netherlands, Canada and the United States, was extended to Australia in the third quarter. The acquisition of Lipa Pharmaceuticals Limited ("Lipa"), the leading Australian contract manufacturer of complementary healthcare products, was completed in early November and the company is now a wholly-owned subsidiary of CK Life Sciences. Through this acquisition, CK Life Sciences has made its first foray into the Australian nutraceutical sector and will now focus on business growth in this market.

#### **Environmental Sales Around HK\$350 Million**

Sales for the Group's environmental-related business amounted to about HK\$350 million for the first three quarters. Satisfactory performances were reported in Mainland China, Malaysia and Australia.

#### Firm Financial Foundation

With a strong financial position, CK Life Sciences is well-placed to pursue its growth strategies, which include the expansion of existing businesses, implementation of R&D programmes and achieving growth through acquisition. Cash and cash equivalent on hand amounted to over HK\$1,500 million, while borrowings were below HK\$400 million as at 30 September 2007.

### Subsequent Event

In October, CK Life Sciences announced the acquisition of Accensi Pty Ltd ("Accensi") for a consideration of A\$30 million (approximately HK\$210 million). Accensi is the largest independent toll manufacturer of crop protection products in Australia. The acquisition is expected to be completed by the end of November 2007.

### **Prospects**

With the acquisitions of Lipa and Accensi, our health and environmental-related businesses will be expanded, revenue base boosted and profitability enhanced.

We will continue to pursue new acquisition opportunities, while also nurture the organic growth of our current businesses.

In terms of R&D, we look forward to continued developments in the future. We already have a skin cancer treatment product that has undergone US FDA Phase II clinical trials and a pain management product that is proceeding to Phase III clinical trials in Canada.

We are confident that we can build on this momentum to deliver enhanced returns to our shareholders.

# **CORPORATE GOVERNANCE**

The Board of Directors ("Board") and the management of the Company are committed to the maintenance of good corporate governance practices and procedures. The corporate governance principles of the Company emphasize a quality Board, sound internal controls, and transparency and accountability to all shareholders. The Company has applied the principles and complied with all code provisions and, where applicable, the recommended best practices of the Code on Corporate Governance Practices ("Code on CG Practices") as set out in Appendix 15 of the GEM Listing Rules throughout the nine months ended 30 September 2007.

### (1) Board Composition and Board Practices

The Board is collectively responsible for the oversight of the management of the business and affairs of the Group with the objective of enhancing shareholders value. The Board consists of a total of nine Directors, comprising five Executive Directors, one Non-executive Director and three Independent Non-executive Directors. One-third of the Board are Independent Non-executive Directors and at least one of them has appropriate professional qualifications, or accounting or related financial management expertise as required by the GEM Listing Rules. All Directors (including Non-executive Directors) are subject to retirement by rotation once every three years in accordance with the Company's Articles of Association and the Code on CG Practices.

The positions of the Chairman of the Board ("Chairman") and the Chief Executive Officer are held by separate individuals with a view to maintaining an effective segregation of duties respecting management of the Board and the day-to-day management of the Group's business.

All Directors have made active contribution to the affairs of the Board and the Board has always acted in the best interests of the Group. In addition to regular Board meetings, the Chairman has meetings with the Non-executive Directors (including the Independent Non-executive Directors) without the presence of Executive Directors at least once every year.

The Company Secretary is responsible to the Board for ensuring that Board procedures are followed and for ensuring that the Board is briefed on all legislative, regulatory and corporate governance developments and that the Board has regard to them when making decisions. The Company Secretary and the Compliance Officer are also directly responsible for the Group's compliance with the continuing obligations of the GEM Listing Rules, Codes on Takeovers and Mergers and Share Repurchases, Companies Ordinance, SFO and other applicable laws, rules and regulations.

The Company has adopted the model code on securities transactions by directors of listed issuers set out in Chapter 5 of the GEM Listing Rules as its own code of conduct regarding Directors' securities transactions, effective 31 March 2004.

#### (2) Internal Controls

The Company has an internal audit function in place to provide an independent assessment of the Group's internal control system and review of its effectiveness in accordance with the Code on CG Practices. The Internal Audit Department prepares its audit plan using a risk based methodology in consultation with, but independent of, the management for review by the audit committee of the Company ("Audit Committee"). The audit work focuses on financial, functional and information technology areas within the audited business units and those areas of the Group's activities with significant perceived risks. An integral part of the internal audit function is to monitor and ensure effective implementation of these internal control systems.

#### (3) Audit Committee

The Company established the Audit Committee on 26 June 2002 and has formulated its written terms of reference in accordance with the provisions set out in the Code on CG Practices. The Audit Committee comprises three Independent Non-executive Directors, namely, Professor Wong Yue-chim, Richard (Chairman of the Audit Committee), Mrs. Kwok Eva Lee and Mr. Colin Stevens Russel. The principal duties of the Audit Committee include the review and supervision of the Group's financial reporting system and internal control procedures, review of the Group's financial information and review of the relationship with the external auditors of the Company.

The Group's third quarter report for the nine months ended 30 September 2007 has been reviewed by the Audit Committee.

#### (4) Remuneration Committee

According to the Code on CG Practices, the Company established its remuneration committee ("Remuneration Committee") on 1 January 2005 with a majority of the members being Independent Non-executive Directors. The Remuneration Committee comprises the Chairman of the Board, Mr. Li Tzar Kuoi, Victor (Chairman of the Remuneration Committee), and two Independent Non-executive Directors, namely, Mrs. Kwok Eva Lee and Mr. Colin Stevens Russel.

The principal responsibilities of the Remuneration Committee include making recommendations to the Board on the Company's policy and structure for the remuneration of Directors and senior management, and reviewing the specific remuneration packages of all Executive Directors and senior management by reference to corporate goals and objectives resolved by the Board from time to time.

#### (5) Investor Relations and Communication with Shareholders

The Company establishes different communication channels with shareholders and investors, including (i) printed copies of financial reports, circulars, notices of general meetings and proxy forms required under the GEM Listing Rules, and shareholders can select to receive such documents by electronic means; (ii) the annual general meeting provides a forum for shareholders to raise comments and exchange views with the Board; (iii) updated and key information of the Group is available on the website of the Company; (iv) the Company's website offers a main communication channel between the Company and its shareholders and investors; (v) regular press conferences and briefing meetings with analysts from the investment sectors are set up from time to time on updated performance information of the Group; (vi) the Company's Branch Share Registrar deals with shareholders for share registration matters; and (vii) Corporate Affairs Department of the Company handles enquiries from shareholders and investors generally.
