- To be valid, this form of proxy together with any power of attorney or other authority (if any) under which it is signed or a notarially g certified copy of such power or authority must be deposited at the branch share registrar and transfer office of the Company, Computershare Hong Kong Investor Services Limited, Rooms 1712-1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Hong Kong not later than 48 hours before the time of the meeting or any adjourned meeting.
