Zhejiang Shibao Holding is an investment holding company established in the PRC on 28 May 2003 and is owned as to 40% by Mr. Zhang, 20% by Zhang Bao Yi (son of Mr. Zhang), 20% by Tang Hao Han (son-in-law of Mr. Zhang), 15% by Zhang Lan Jun (daughter of Mr. Zhang) and 5% by Zhang Shi Zhong (brother of Mr. Zhang).
2. Mr. Zhang holds 40% interest in the registered capital of Zhejiang Shibao Holding, which in turn directly holds 165,387,223 Domestic Shares of the Company. As Mr. Zhang is entitled to exercise or control the exercise of one-third or more of the voting power at general meetings of Zhejiang Shibao Holding, Mr. Zhang is taken or deemed to be interested in all of the 165,387,223 Domestic Shares held by Zhejiang Shibao Holding. These Shares represent the same interest and therefore duplicate between Zhejiang Shibao Holding and Mr. Zhang.
