(C)	Each holder of Domestic Shares who has the right to attend and vote at the Domestic Shares Class Meeting is entitled to appoint in writing one or more proxies, whether a shareholder or not, to attend and vote on his behalf at the Domestic Shares Class Meeting.		
(D)	The instrument appointing a proxy must be in writing under the hand of the appointor or his attorney duly authorised in writing. If that instrument is signed by an attorney of the appointor, the power of attorney authorising that attorney to sign, or other documents of authorisation, must be notarially certified.		
(E)	To be valid, the form of proxy, and if the form of proxy is signed by a person under a power of attorney or other authority on behalf of the appoint or a notarially certified copy of that power of attorney or other authority, must be delivered to the Company's address stated above, not less than 24 hours before the time for holding the Domestic Shares Class Meeting or any adjournment thereof.		
(F)	If a proxy attends the Domestic Shares Class Meeting on behalf of a shareholder, he should produce his identification and the instrument signed be the proxy or his legal representative, which specifies the date of its issuance. If the legal representative of a legal person share holder attends the Domestic Shares Class Meeting, such legal representative should produce his identification and valid documents evidencing his capacity as suc legal representative. If a legal person share holder appoints a representative of a company other than its legal representative to attend the Domestic Shares Class Meeting, such representative should produce his identification and an authorization instrument affixed with the seal of the legal person
