If this form of proxy is signed by an attorney or officer of the appointer, the power of attorney authorizing that attorney to sign, or other document of authorization must be notarially certified.
- Any member entitled to attend and vote at a meeting of the Company or a meeting of the holders of any class of shares in the Company shall be entitled to appoint another person as his proxy to attend and vote instead of him. A proxy need not be a member but must attend the meeting in person to represent you. A member who is the holder of two or more shares may appoint more than one proxy to represent him and vote on his behalf at the Domestic Shares Class Meeting. Where a member appoints more than one proxy, his proxies may only vote in a poll.
- In the case of joint holders, the vote of the senior who tenders a vote whether in person or by proxy will be accepted to the exclusion of the votes of the other joint holders. For this purpose seniority is determined by the order in which the names stand in the Register of Members of the Company in respect of the joint holding.
- To be valid, this form of proxy and the power of attorney or other authority (if any) under which it is signed or a notarially certified copy of such power or attorney, shall be deposited at the principal place of business in the PRC of the Company, at Floor 9, Gangao Tower, 18 Zhengzhou Road, He Ping District, Tianjin, PRC not less than 24 hours before the time appointed for holding the Domestic Shares Class Meeting or adjourned meeting.
