Note A:

On 16 September 2009, the Company entered into the Assets Acquisition Agreement (details of which are set out in the announcement of the Company dated 5 October 2009 (the "Announcement") and the circular of the Company dated 31 December 2010) with 天津市燃氣集團有限公司(Tianjin Gas Group Company Limited) ("Tianjin Gas"), pursuant to which the Company conditionally agreed to acquire from Tianjin Gas the Transferred Assets (as defined in the Announcement) at the consideration of RMB620,736,991.84. The Company will allot and issue 689,707,800 Domestic Shares (the "Consideration Shares") to Tianjin Gas to satisfy the above consideration. On 15 February 2011, the Company passed a resolution relating to the grant of a specific mandate to the board of directors of the Company ("Specific Mandate") for the allotment and issue of 689,707,800 Domestic Shares to Tianjin Gas pursuant to the Assets Acquisition Agreement at the EGM held on 15 February 2011. The Company has not issued any Consideration Shares as at 28 February 2011, subject to the satisfaction of all the conditions precedent under the Assets Acquisition Agreement.
