HIGHLIGHTS

- The Group recorded a turnover of approximately RMB32,373,000 for the six months ended 30th June, 2011 (2010 : approximately RMB36,419,000), representing a decrease of approximately 11% as compared with that of the corresponding period in 2010.
- The Group recorded a loss attributable to owners of the parent of approximately RMB7,758,000 for the six months ended 30th June, 2011 (2010 : loss of approximately RMB3,869,000), representing an increase of approximately 101% as compared with that of the corresponding period in 2010.
- The Directors do not recommend the payment of an interim dividend for the six months ended 30th June, 2011 (2010 : Nil).

1. BASIS OF PRESENTATION

The Group's unaudited condensed consolidated results have been prepared in accordance with the Hong Kong Financial Reporting Standards and Hong Kong Accounting Standards and interpretations issued by the Hong Kong Institute of Certified Public Accountants. The unaudited condensed consolidated results have been prepared on the historical cost basis. The accounting policies adopted in preparing the unaudited condensed consolidated results for the six months ended 30th June, 2011 are consistent with those followed in the preparation of the Group's annual financial statements for the year ended 31st December, 2010. The condensed consolidated results are unaudited but have been reviewed by the Company's audit committee.

2. TURNOVER

Turnover represents revenue from business solutions development, application software, network and data security products, and the sale of distributed products. Turnover is stated net of sales tax and returns. Revenue from provision of business solutions development, application software and network and data security products are recognised when delivery or acceptance has occurred, the fee is fixed and determinable, evidence of an arrangement exists, collection of the receivable is probable and no significant post-delivery obligations remain. Sales of distributed products are recognised when goods are delivered and title has passed.

7. LOSS PER SHARE

The calculation of the basic loss per share for the six months ended 30th June, 2011 is based on the unaudited net loss of approximately RMB7,758,000 (2010: net loss of approximately RMB3,869,000) and the weighted average number of shares during the six months ended 30th June, 2011 was 480,000,000 shares (2010: 480,000,000 shares).

The calculation of the basic loss per share for the three months ended 30th June, 2011 is based on the unaudited net loss of approximately RMB2,498,000 (2010: net loss of approximately RMB373,000) and the weighted average number of shares during the three months ended 30th June, 2011 was 480,000,000 shares (2010: 480,000,000 shares).

Diluted loss per share is not presented for the six months and three months ended 30th June, 2011 and 2010 as there were no potential dilutive shares in issue during the relevant periods.

The Company has conditionally adopted a share option scheme which enables the Company to grant options to selected participants as incentives or rewards for their contribution to the Group. The Directors may, at their discretion but on the basis of their contribution to the development and growth of the Group, make an offer to certain persons to subscribe for the Company's H shares.

During the period, no option was granted by the Company.

MANAGEMENT DISCUSSION AND ANALYSIS

Results and financial review

For the six months ended 30th June, 2011, the Group recorded a turnover of approximately RMB32,373,000 (2010 : approximately RMB36,419,000), representing an decrease of approximately RMB4,046,000 or 11% as compared to the corresponding period last year. Gross profit decreased by RMB4,002,000 or 73% to RMB1,452,000. The Group recorded a loss of RMB7,758,000 which represents a significant increase as compared with the loss of approximately RMB3,869,000 for the corresponding period in 2010.

For the six months ended 30th June, 2011, the revenue for the Group has decreased from RMB36,419,000 to RMB32,373,000. The revenue are mainly consisting of the sales and distribution of computer and electrical products and accessories which made up of 68.5% of the total sales or RMB22,192,000, and this is followed by 21.9% of total sales or RMB7,088,000 for business solutions development, 9.6% or RMB3,093,000 for application software.

Sales and distribution of computer and electrical products and accessories has increased in revenue by RMB1,846,000 or 9.1%, as compared to RMB20,346,000 for the previous year. The revenue of business solutions development decreased by RMB8,792,000 or 55.4%, as compared to RMB15,880,000 for the previous year.

However, the revenue of application software business increased by RMB2,900,000 or 15 times from RMB193,000 for the previous year, which is mainly contributed by payments for some completed projects in development.

Gross profit decreased by RMB4,002,000 or 73.4% from RMB5,454,000 to RMB1,452,000. Gross profit margin has decreased to 4.5% for the year, as compared to 15% for the previous financial year.

Administrative expenses increased by RMB260,000 or 7.8% to RMB3,603,000 from RMB3,343,000 for the corresponding period last year. Research and development expenses decreased by RMB315,000 or 8.3% to RMB3,473,000, as compared to RMB3,788,000 for the previous year. The decrease is mainly due to the cost for the initial stage of Macau project. Distribution expenses has increased from RMB2,553,000 for the previous year to RMB3,440,000 for the current year.

In future the Company main focus is still on the cost control in order to continuously monitor the cost in achieving the targeted profit. The management will try it bests to reduce unnecessary expenses, improve the productivity of the management staff and also take active measures to monitor its financial position.

Financial resources and liquidity

As at 30th June, 2011, shareholders' funds of the Group amounted to approximately RMB70,943,000 (as at 31st December, 2010 : approximately RMB81,932,000). Current assets amounted to approximately RMB94,201,000 (as at 31st December, 2010 : approximately RMB92,016,000), of which approximately RMB56,847,000 (as at 31st December, 2010 : approximately RMB59,724,000) were bank balances and cash. The Group had no non-current liabilities and its current liabilities amounted to approximately RMB37,381,000 (as at 31st December, 2010 : approximately RMB27,155,000), which mainly comprised of creditors and bill payables and accrued expenses. The Group's net assets per share are approximately RMB0.15 (as at 31st December, 2010 : approximately RMB0.18).

As at 30th June, 2011, the Group has bank balances and cash amounting to approximately RMB56,847,000 with a current ratio of approximately 252%. The Directors believed that the Group's financial position is healthy.

As at 30th June, 2011, the Group has a gearing ratio (liabilities over total assets) of approximately 35% (as at 31st December, 2010 : approximately 24%).

Capital structure

There has been no change to the capital structure of the Company during the six months ended 30th June, 2011.

Gearing ratio

The Group expresses its gearing ratio as a percentage of long-term debts over equity. The Group had a gearing ratio of zero since the Group did not have any long-term debts. The Group generally finances its operations with equity funding and bank borrowings.

Foreign exchange expenses

During the six months ended 30th June, 2011, as the Group's sales and purchases were substantially denominated in Renminbi, the Board considers that the potential foreign exchange exposure of the Company is minimal.

Employee information and remuneration policies

As at 30th June, 2011, the Group employed permanent staff of approximately 128 (2010 : 114). For the six months ended 30th June, 2011, the remuneration for the employees (including the Directors' emoluments) amounted to approximately RMB5,186,000 (2010: approximately RMB4,850,000). The Group's remuneration and bonus policies are principally determined with reference to the qualification, experience and performance of individual employee.

Material acquisitions or disposals

During the six months ended 30th June, 2011, the Group had no material acquisitions and disposal of subsidiaries and affiliated companies.

Charges on Group's assets

As at 30th June, 2011, the Group had no charges on Group's assets.

Details of future plans for material investments or capital assets

As at 30th June, 2011, the Group had no future plans for material investments or capital assets.

Contingent liabilities

As at 30th June, 2011, the Group had no material contingent liabilities (2010 : Nil).
