On 7 January 2011, the Company entered into the Sale and Purchase Agreement (as disclosed in the Company's announcement of 7 January 2011), pursuant to which the Company will issue convertible bonds in the principal amount of HK\$113,740,000. Based on the initial conversion price of HK\$0.04 per conversion share (subject to adjustment), an aggregate of 2,843,500,000 new shares will be allotted and issued upon exercise of the conversion rights attached to the convertible bonds. Completion of the agreement is subject to the terms and conditions as set out in the announcement.
