This announcement is made by China City Railway Transportation Technology Holdings Company Limited on a voluntary basis.

The Board is pleased to announce that in each of September 2012 and October 2012, the Company's wholly-owned subsidiary, ERG BJ, was awarded with the Tenders in relation to certain aspects of works related to the construction of Phase II of the railway transport command centre of Beijing Subway with a total contract sum of approximately RMB113 million and RMB50 million respectively.

The Phase II Project was tendered by Beijing Metro Network and designed to meet the demand for better network-level control over railway operations, enabling more efficient railway network-level transport control and expanding the scale and functions of the fare clearing and settlement systems of Beijing Subway. Serving as one of the contractors of the Phase II Project, ERG BJ will provide the following services under the Tenders: (i) setting up of the ICC System for Beijing Subway; (ii) expanding the capacity of the existing ACC System and TCC System of Beijing Subway, in particular, to enhance the ability of the current TCC System of Beijing Subway for accommodation and management of 19 line-level control centres; and (iii) providing system hardware and software and related technical services to the testing and inspection centre of the AFC System of Beijing Subway.

According to the research report prepared by Huicong Research which was commissioned by the Company in relation to, amongst other things, the PRC public transport systems industry for inclusion in the prospectus of the Company dated 3 May 2012, it is expected that the total value of all contracts relating to the construction of urban railway transportation information system in Beijing will reach approximately RMB8.3 billion between 2011 and 2015. On 5 September 2012, the NDRC announced that 25 plans covering urban transport and railway construction across various cities in the PRC with a total investment cost of close to RMB840 billion have been approved. With the increasing number of urban railway transportation construction projects or plans being approved in Beijing and across the PRC, it is expected that there will be more development opportunities for the Group in the future.

The Directors consider the Group's success in securing the Tenders demonstrates its competitive edge in the industry. Looking ahead, the Group will strive to maintain its market share in Beijing by maintaining its existing customers, further improving its existing software system and developing more software solutions; and expanding its customer base to capture the demand in the urban railway transportation industry in other parts of the PRC.
