1. Principal accounting policies

The unaudited quarterly report has been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") and with the applicable disclosure requirements of the Rules Governing the Listing of Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited. The accounting policies adopted are consistent with those set out in the annual financial statements for the year ended 31 March 2012.

The quarterly report is unaudited, but has been reviewed by the audit committee of the Company.

The Group principally operates in the People's Republic of China (the "PRC") with its business activities principally transacted in RMB, the results of the Group are therefore prepared in RMB.

2. Turnover

The Group is principally engaged in the provision of school network integration services and information technology related services in the PRC and proprietary investments, private equity investments, financial advisory, asset management services and money Lending.

Turnover represents the revenue from its principal activities which are mainly the provision of services provided to customers. The amount of each significant category of revenue recognised in turnover during the period is as follows:

MANAGEMENT DISCUSSION AND ANALYSIS

FINANCIAL REVIEW

The revenue of the Group from continuing operations decreased approximately 35.46% for the nine months ended 31 December 2012 as compared with the same period in 2011. The main reason was due to the government imposing tighter requirements and controls of school network integration services leads to the decrease in revenue

The cost of sales of the Group from continuing operations decreased approximately 40.33% for the nine months ended 31 December 2012 as compared with the same period in 2011. The main reason was due to the decrease in revenue of school network integration services.

The administrative expenses from continuing operations had decreased approximately 46.44%, for the nine months ended 31 December 2012 as compared with the same period in 2011. The main reason of the decrease was the Group had not additional expenses and loss relevant to the disposal of a subsidiary.

Liquidity and Financial Resources

As at 31 December 2012, the shareholders' funds of the Group amounted to approximately RMB18.40 million. Current assets amounted to approximately RMB28.96 million of which approximately RMB5.10 million were cash and bank balances and approximately RMB23.86 million were trade receivables, inventory, prepayment, deposit and others receivables. The Group's current liabilities amounted to approximately RMB23.44 million.

Capital Structure

Movements in capital structure of the Company during the period are set out in note 7 to the third quarterly report. The capital of the Company comprises only ordinary shares. The Company and the Group has RMB43.21 million loan.

Significant Investments

As at 31 December 2012, the Group did not have any significant investments (2011: nil).

管理層討論及分析

財務回顧

本集團截至二零一二年十二月三十一日九個月來自持續經營業務之收益較二零一一年同期下降約35.46%。營業額下降之主要原因為學校網絡整合服務由於政府實施更嚴謹的規定和監控導致收入減少。

本集團截至二零一二年十二月三十一日九個月來自持續經營業務之銷售成本較二零 一一年同期下降約40.33%,下降之主要原因是學校網絡整合服務的營業額之下降。

本集團截至二零一二年十二月三十一日九個月來自持續經營業務之行政開支較二零 一一年同期下降約46.44%。下降之主要原因為今年本集團未有因出售附屬公司而增加的相關費用與虧損。

流動資金及財務資源

於二零一二年十二月三十一日,本集團之股東資金約為人民幣1,840萬元。流動資產約為人民幣28,960萬元,其中約人民幣5,100萬元為現金及銀行結餘,另約人民幣23,860萬元為應收貿易賬款、存貨預付款項、按金及其他應收賬款。本集團之流動負債約為人民幣23,442萬元。

資本架構

本公司於期內之資本架構變動載於第三季 度業績報告附註7。本公司資本僅由普通股 組成。本公司及本集團有人民幣4,321萬元 之貸款。

重大投資

於二零一二年十二月三十一日,本集團並 無任何重大投資(二零一一年:無)。

Charge of Assets

The Group did not have any charge on its assets as at 31 December 2012 (2011: nil), except that:

A loan of RMB12,180,000 (HK\$15,000,000) with interest rate of 5% per annum to be matured on 31 March 2013 in which the Company will deposit RMB8,100,000 (HK\$10,000,000) into the Escrow Account maintained by a law firm as the Escrow Agent for security of the loan.

A loan of RMB30,495,000 (HK\$37,556,000) with interest rate of 5% per annum to be matured on 31 December 2013 in which the Borrower shall charge 40% of the issued shares in the capital of one subsidiary as security of the loan. However, the borrower of above loan was assigned to the substantial Shareholder, Shiny Ocean Holdings Limited at 24 December 2012.

Capital Commitment

As at 31 December 2012, the Group did not have any material capital commitments.

Foreign Exchange Exposure and Hedging Policy

Since most of the income and expenses as well as assets and liabilities of the Group are denominated in Renminbi, the Board considers that the Group has no material foreign exchange exposure and no hedging policy has been taken.

Contingent Liabilities

As at 31 December 2012, the Group did not have any material contingent liabilities.

Human Resources

As at 31 December 2012, the Group had 45 full time employees in the PRC and Hong Kong. Staff remuneration packages are determined by reference to prevailing market rates. Staff benefits include mandatory provident fund, personal insurance and discretionary bonus which are based on their performance and contribution to the Group.

BUSINESS OUTLOOK

Business Review

For the nine months ended 31 December, 2012, the Group's revenue was mainly generated from integration of school networks. The revenue has decreased because the government has imposed tighter control and requirements. However, the cost of sales has also decreased, resulting in an improvement in gross profit margin. The administrative expenses had also decreased because the Group did not incur additional expenses and loss relevant to the disposal of subsidiary.

Prospect and Outlook

The environment of the school network integration services business continues to be competitive. The Group will continue to review its existing operations and strive to adapt to the environment. The Group will continue to look for good opportunities to conduct and further develop the money lending business. As announced, the voluntary conditional offer to acquire all of the issued shares, and to cancel the entire outstanding share Options and Warrants have been completed. In view of the uncertainties of the general economic environment, the Group will continue to monitor and strive to improve the Group's financial position. The Group will continue to explore new directions to diversify the business market risk and allocate resources into new businesses should attractive opportunities arise. After the recent change in the composition of the board of the Group, the current Board members have extensive experience in various industrial and business sectors. The Group intends to diversify into trading business in the future as the diversification can provide new business opportunities and generate additional revenue to the Group. The Group will continue to review our product line and strategically search for potential M&A and investment opportunities that could diversify its existing business portfolio and broaden its source of income in order to generate solid and sustainable return for our Shareholders

業務展望

業務回顧

截至二零一二年十二月三十一日止九個月,本集團的營業額主要來自學校網路整合業務。營業額的減少是由於政府已實施更嚴謹的控制及規定。然而,銷售成本亦有所下降,以致毛利率有所改善。行政支出亦有所下降,此乃由於本集團沒有因出售附屬公司事項而產生額外費用及虧損。

前景展望

學校網路整合服務行業的經營環境的競爭 性仍然強勁。本集團會繼續檢討現有的營 運並致力適應其營商環境。本集團會繼續尋 找良好的機會進行及繼續發展借貸業務。 如公告所指,就收購全部已發行股份及註銷 全部尚未行使之購股權及認股權證而提出 之自願性有條件收購建議已經完成。鑒於總 體經濟環境的不確定性,本集團會繼續監測 及致力改善本集團的財務狀況。本集團將繼 續探索新方向以分散業務市場風險及在具 吸引力之機會出現時分配資源至新業務。 最近本集團董事會的組成發生變動後,現 時的董事會成員在多個工商界別擁有豐富 經驗。本集團鋭意於未來作多元化發展,進 軍貿易業務,因為多元化發展能為本集團帶 來新商機,並產生額外收益。本集團會繼續 檢討其產品線及策略性尋覓可多元化現有 業務組合及擴闊其收入來源的潛在收購及 投資機會,為股東帶來豐厚及可持續回報。
