On 20 February 2013 at 17:19 p.m., the Company was informed by Boss China, a subsidiary of the Company established in the Beijing, PRC that Zhenjiang Intermediate People's Court went to the bank account of Boss China and frozen RMB 23.5 millions, for a half-year period starting from today. Document No.: (2013) Zhenjiang People's Court Executive Board No. 57 - assistance freezing notice (2013), the first instance of Zhenjiang People's Court written order No. 17. Boss China has appointed its PRC legal adviser to Zhenjiang to understand the situation, study and take appropriate steps to protect its rights.
