THE COOPERATION AGREEMENT

On 5 March 2015, after trading hours, Jixiang Information Technology, a wholly-owned subsidiary of the Company, and Shanghai Saiguo entered into the Cooperation Agreement, pursuant to which Jixiang Information Technology and Shanghai Saiguo have agreed to cooperate with each other to hold the mobile and online Silk Road Knowledge Quizzes Competition in 2015.

This is a voluntary announcement made by the Company.

THE COOPERATION AGREEMENT

On 5 March 2015, after trading hours, Jixiang Information Technology, a wholly-owned subsidiary of the Company, and Shanghai Saiguo entered into the Cooperation Agreement, major terms of which are set out below:

Date:

5 March 2015

Parties:

- (1) Jixiang Information Technology; and
- (2) Shanghai Saiguo.

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, save that Shanghai Saiguo is owned as to 3% by Mr. Zhang Xiongfeng, the Chairman and an executive Director, each of Shanghai Saiguo and its ultimate beneficial owners is an Independent Third Party. Shanghai Saiguo is a company incorporated in the PRC which principally engaged in (i) carrying on children educational activities by coordination with various government agencies, educational institutions, social organisations and international enterprises; and (ii) the provision of integrated marketing services and public relations activities.

Subject matter of the Cooperation Agreement:

Pursuant to the Cooperation Agreement, Jixiang Information Technology and Shanghai Saiguo have agreed to cooperate with each other in a children educational activity namely Silk Road Knowledge Quizzes Competition launched by 全國少年兒童「雙有」活動組委會 (in English, for identification purpose, the activity organizing committee of the China Shuanyou for the Youth and Children). Primary school students in the PRC are the target participants of the Silk Road Knowledge Quizzes Competition.

Jixiang Information Technology shall be responsible for, among others, (i) design, development and production of the web version and mobile application of the program ("**Program**") namely "我是小小中國通一絲路文化之旅" (in English, for identification purpose, "I Am Little Chinese Hand – Silk Road Cultural Tour") used in the Silk Road Knowledge Quizzes Competition; and (ii) maintaining the system and server of the Program.

Shanghai Saiguo shall be responsible for, among others, (i) providing the documents and contents of the quizzes to Jixiang Information Technology for inclusion in the Program; (ii) promotion of the Silk Road Knowledge Quizzes Competition in target schools; and (iii) liaising and communicating with relevant government authority and organizer in relation to the Silk Road Knowledge Quizzes Competition.

Term of the Cooperation Agreement:

The term of the Cooperation Agreement commences on the date of the Cooperation Agreement to 31 October 2015, with the Silk Road Knowledge Quizzes Competition to be held from 20 May 2015 to 20 September 2015.

Other terms of the Cooperation Agreement:

Jixiang Information Technology shall own all copyrights and intellectual property of the output designed and developed by it (including but not limited to the Program written for the Silk Road Knowledge Quizzes Competition). Shanghai Saiguo shall own all copyrights and intellectual property in relation to the quizzes provided to Jixiang Information Technology for the purpose of the activity.

During the term of the Cooperation Agreement, Jixiang Information Technology may promote the Silk Road Knowledge Quizzes Competition to suitable advertisement sponsors and Jixiang Information Technology shall be entitled to the income (including but not limited to monetary and physical sponsorship items) therefrom solely.

Both Jixiang Information Technology and Shanghai Saiguo shall bear its own costs incurred and may on its own initiative promote the Silk Road Knowledge Quizzes Competition to any suitable sponsors. Any revenue or income generated from sponsorship shall belong to the relevant party and sharing of such revenue or income between Jixiang Information Technology and Shanghai Saiguo is not required.

REASONS FOR AND BENEFITS OF THE COOPERATION

The Group is principally engaged in (i) mobile-online game business and provision of games related integral marketing services; (ii) money lending business; (iii) provision of medical diagnostic and health check services; and (iv) securities investments business.

The Directors consider that the Cooperation would act as a starting point of the Group to explore potential business opportunity in building an educational platform through developing mobile applications and computer softwares. It is also believed that, through the Cooperation, the Group may develop sustainable business relationship with Shanghai Saiguo and create commercial value for future cooperation with Shanghai Saiguo.

The Board considers that the terms of the Cooperation Agreement are normal commercial terms and are fair and reasonable and the entering into of the Cooperation Agreement is in the interests of the Company and the shareholders of the Company as a whole.
