POSITIVE PROFIT ALERT

The Board wishes to inform the shareholders of the Company and potential investors that based on the information currently available to the Board, the Group is expected to record a significant increase of profit attributable to owners of the Company for the three months ended 31 March 2015 of over 500% as compared to profit attributable to owners of the Company for the corresponding period in 2014.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.

This announcement is made by U Banquet Group Holding Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company and potential investors that based on the information currently available to the Board, the Group is expected to record a significant increase of profit attributable to owners of the Company for the three months ended 31 March 2015 of over 500% as compared to profit attributable to owners of the Company for the corresponding period in 2014.

The Board considers that the significant increase of profit attributable to owners of the Company for the three months ended 31 March 2015 was mainly due to the following reasons:

- (i) increase in revenue from Chinese restaurants operations of approximately HK\$7.1 million which includes approximately HK\$4.1 million contributed by wedding banquet services when compare to the corresponding period in 2014;
- (ii) 100% profit contribution from distribution of goods business for the three months ended 31 March 2015 since the acquisition of 49.995% interest in each of General Corporation Limited and Smart Award Limited which took place on 4 September 2014; and
- (iii) receipt of approximately HK\$0.9 million franchise income for the three months ended 31 March 2015 from a franchisee pursuant to a franchise agreement (three months ended 31 March 2014: HK\$ Nil).

The Company has yet to finalise its unaudited consolidated financial results for the three months ended 31 March 2015. Information contained in this announcement is only based on a preliminary review of the unaudited consolidated financial statements of the Group and information currently available. It is not based on any data or information being confirmed or reviewed by the Company's Audit Committee or auditors.

Further details of the Group's financial information and performance for the three months ended 31 March 2015 will be disclosed in the forthcoming first quarterly results announcement to be published by the Company in May 2015.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
