Mobile TV service will provide ultra-clear TV channels which include movie channel, shopping channel, education channel and financial channel etc.

CreatComm Technology has more than 50 of PRC / US patents on WIFI communication and provides customers over 30km of remote transmission around WIFI technology. CreatComm Technology implement "Core Technology + Product Sales + Information Services" business model and the core team members are selected for the notional people plan.
