

- 以證券持有人(包括香港結算代理人(如 適用))的名義登記新發行證券或轉讓或 受讓證券;
- 存置或更新本公司證券持有人的名冊;
- 核實證券持有人的身份;
- 確定本公司證券持有人的受益權利,例如股息、供股和紅股等;
- 分發本公司及其附屬公司的通訊;
- 編製統計數據和股東資料;
- 披露有關資料以便就權益索償;及

3. 轉交個人資料

- 本公司委任的代理,例如財務顧問、收款銀行和海外證券登記總處;
- (如證券申請人要求將證券存入中央結算 系統)香港結算或香港結算代理人;其 將會就中央結算系統的運作使用有關個 人資料;
- 向本公司或香港股份過戶登記分處提供 與其各自業務營運有關的行政、電訊、 電腦、付款或其他服務的任何代理、承 包商或第三方服務供應商;
 - 聯交所、證監會及任何其他法定監管機 關或政府部門或法例、規則或法規另有 規定者;及
- 證券持有人與其進行或擬進行交易的任何人士或機構,例如彼等的銀行、律師、會計師或股票經紀等。

4. 個人資料的保留

本公司及其香港股份過戶登記分處將按收集個人資料所需的用途保留證券申請人及持有人的個人資料。無需保留的個人資料將會根據《條例》銷毀或處理。

5. 查閱和更正個人資料

證券持有人有權確定本公司或香港股份過戶 登記分處是否持有其個人資料,並有權索取 有關該資料的副本並更正任何不準確資料。 本公司和香港股份過戶登記分處有權就處理 任何查閱資料的要求收取合理費用。
