Such decrease in profit was mainly due to the fact that the decrease in precipitation in Shouning County, Zhouning County and Fuan City in Fujian Province during the three months ended 31 March 2017.

The information contained in this announcement is only based on the preliminary assessment by the management of the Company of the unaudited first quarterly financial results of the Group for the three months ended 31 March 2017 and is not based on any figure or information which has been audited or reviewed by the Company's auditors and the audit committee of the Company and is subject to possible adjustments upon further review. The Company is in the process of finalising the unaudited first quarterly financial results of the Group for the three months ended 31 March 2017. Details of the Group's financial information and performance will be disclosed when the Group's unaudited first quarterly financial results for the three months ended 31 March 2017 are announced, which is expected to be on 15 May 2017.
