Personal Information Collection Statement

The main provisions of the Personal Data (Privacy) Ordinance (Cap. 486 of the Laws of Hong Kong) (the "Ordinance") came into effect in Hong Kong on December 20, 1996. 1. Reasons for the collection of your personal data
