

# 3. 轉交個人資料

- 向本公司或其香港股份過戶登記分處提供與 其各自業務營運有關的行政、電訊、電腦、 付款或其他服務的任何代理、承包商或第三 方服務供應商,
- 聯交所 證監會及任何其他法定監管機關或 政府部門或遵照其他法例、規則或規例;及
- 證券持有人與其進行或擬進行交易的任何人 土或機構,例如彼等的銀行、律師、會計師 或股票經紀等。

# 4. 個人資料的保留
