- (基於遵照法例、規則或法規的規定)聯 交所、證監會及任何其他法定監管機關 或政府部門或其他對象;及
- 證券持有人與其進行或擬進行交易的任何人士或機構,例如彼等的銀行、律師、 會計師或股票經紀等。

### 4. 個人資料的保留

本公司及其香港證券登記處將按收集個人資料所需的用途保留證券申請人及持有人的個人資料。無需保留的個人資料將會根據條例銷毀或處理。

# 5. 查閱和更正個人資料

證券持有人有權確定本公司或香港證券登記處是否持有其個人資料,並有權索取有關該資料的副本並更正任何不準確資料。本公司和香港證券登記處有權就處理有關要求收取合理費用。所有查閱資料或更正資料的要求應按招股章程「公司資料」一節所披露或不時通知的本公司註冊地址向公司秘書或本公司的香港證券登記處屬下的個人資料私隱條例事務主任提出。
