CHANGE OF COMPANY NAME AND STOCK SHORT NAME

Reference is made to the announcement of Xi'an Haitiantian Holdings Co., Ltd.* (西安海天天實業股份有限公司) (formerly known as Xi'an Haitian Antenna Holdings Co., Ltd.* (西安海天天綫控股股份有限公司)) (the “**Company**”) dated 10 May 2017 and the circular of the Company dated 15 May 2017 (the “**Circular**”) in relation to, among other things, the Proposed Change of Company Name. Capitalised terms used herein shall have the same meanings as those defined in the Circular unless otherwise stated.

CHANGE OF COMPANY NAME

The Board is pleased to announce that the Chinese name of the Company has changed from “西安海天天綫控股股份有限公司” to “西安海天天實業股份有限公司” and the English name of the Company adopted for identification purpose has been changed from “Xi'an Haitian Antenna Holdings Co., Ltd.” to “Xi'an Haitiantian Holdings Co., Ltd.”.

The use by the Company of the new name “西安海天天實業股份有限公司” has been approved by Xi'an Administration for Industry and Commerce (西安市工商行政管理局), which has issued the business licence bearing the new name on 16 October 2017. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 31 October 2017.

CHANGE OF STOCK SHORT NAME

The stock short names for trading in the H Shares on the Stock Exchange will be changed from “HT ANTENNA HOLD” to “HAITIANTIAN” in English and from “海天天綫控股” to “西安海天天” in Chinese with effect from 9:00 a.m. on 13 November 2017. The stock code of the Company remains as “8227”.

SHARE CERTIFICATES

The change of Company's name will not affect any of the rights of the Shareholders. All existing share certificates of the Company in issue bearing the previous name of the Company will continue to be effective and as documents of title to the shares of the Company and will continue to be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of the existing share certificates for new share certificates under the new name of the Company. New share certificates will be issued under the new name of the Company with effect from 13 November 2017.
