2. 用途

證券持有人的個人資料可作以下用途及以任何方式持有、處理及/或保存：

- 處理閣下的申請及退款支票(如適用)、核實是否符合本申請表格及招股章程載列的條款與申請手續以及公佈公開發售股份的分配結果；
- 遵守香港及其他地區的適用法例及法規；
- 以證券持有人(包括香港結算代理人(如適用))的名義登記新發行證券或轉讓或受讓證券；
- 存置或更新本公司的證券持有人名冊；
