Determination of Offer Price and allocation of Public Offer Shares

The Offer Price is expected to be fixed on or around Monday, 12 February 2018. Applicants are required to pay the maximum Offer Price of HK\$0.33 for each Public Offer Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee.
