5. You must be outside the United States, not be a United States Person (as defined in Regulation S under the U.S. Securities Act) and not be a legal or natural person of the PRC.
6. Unless permitted by the GEM Listing Rules, you cannot apply for any Public Offer Shares if you:
 - are an existing beneficial owner of Shares in the Company and/or any of its subsidiaries;
 - are a Director or chief executive officer of the Company and/or any of its subsidiaries;
 - are a core connected person (as defined in the GEM Listing Rules) of the Company or will become a core connected person of the Company immediately upon completion of the Share Offer;
 - are a close associate (as defined in the GEM Listing Rules) of any of the above; or
 - have been allocated or have applied for any Placing Shares or otherwise participated in the Placing.

B. If you are a nominee

C. Effect of completing and submitting this Application Form

By completing and submitting this Application Form, you (and if you are joint applicants, each of you jointly and severally) for yourself or as an agent or a nominee on behalf of each person for whom you act:

Offer Price and allocation of Public Offer Shares

The Offer Price is fixed at HK\$0.60. Applicants are required to pay the Offer Price of HK\$0.60 for each Public Offer Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee.

Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.

The allocation of Offer Shares between the Public Offer and the Placing is subject to reallocation, as described in the paragraph headed "Structure and conditions of the Share Offer — The Public Offer — Reallocation" in the Prospectus. The Joint Lead Managers (for themselves and on behalf of the Underwriters) may reallocate the Offer Shares from the Placing to the Public Offer to satisfy valid applications under the Public Offer in accordance with the Guidance Letter HKEx-GL91-18 issued by the Stock Exchange.
