Company overview

China Wan Tong Yuan (Holdings) Limited (stock code: 8199), founded in Langfang, Hebei in November 2007, is a leading burial service provider in Langfang, with operations covering cemetery operation business, funeral ceremony services, and cemetery maintenance services. Wan Tong Yuan has now developed 20 tomb areas featuring traditional and artistic-style graveyards, which can meet different demands of customers. Wan Tong Yuan is named from "Garden with phoenixes perching on everlasting plane trees", indicating a blessed place for the departed. Wan Tong Yuan dedicated itself to building a venue for keeping the memory and feeling, a cemetery compatible with the natural environment, which shall be accountable as an enterprise cemetery.



Development history

2017.2 It was obtained the 2007.11 2017.3 title of "Secretary -General Unit" by the Youth Working operating subsidiary, was established in Association. 2017.3 2014.7 Langfang Wantong 2017.9 became an indirect wholly-owned subsidiary of our company through the Reorganization.

Financial overview

A funeral refers to the manner and ceremony for disposing human remains, which is the result of social advancement, as well as an integral part of traditional Chinese culture. China is renowned for being a nation of ceremonies, and the Chinese attach great importance to funerals. Our company mainly engages in selling cemeteries in Langfang, and providing other services related to funeral and cemetery maintenance service. Langfang is one of cities with the fastest growth in Hebei Province, and boosted by the Beijing-Tianjin-Hebei Metropolitan Integration, we plan to achieve whole-industry chain development centered on funerals, and establish a diversified development system to foster the rapid development of the company.



Funeral services

Our funeral services consist of (1) cemetery sales, including the usage rights for cemeteries, tombstones and other products for cemetery use; and (2) arrangements and holding of funeral rites, design & construction of cemeteries, and tombstone engraving inscription and ceramic photo and other services for landscapes. The funeral service is divided into traditional and artistic funeral services on the basis of cemetery types.

Cemetery maintenance services

Cemetery maintenance services are an integral part of our burial services, which can maintain a beautiful cemetery landscape. We regularly tidy and patrol the cemetery regularly to ensure a clean and safe environment for visitors. We also regularly maintain our facilities to ensure they are fully functional.



Enterprise governance reinforcement

Wan Tong Yuan was listed successfully on the Stock Exchange of Hong Kong Ltd. (SEHK) in 2017, which means that Wan Tong Yuan's diversified funeral management concept has been recognized by all sectors of society. Therefore, by taking this as an entry point, we will vigorously lead customers and suppliers for further development.

By strictly following the regulations and requirements of standard documents related to the Hong Kong Stock Exchange, combined with practical conditions of Wan Tong Yuan, we have established a relatively perfect framework of corporate governance, and further enhanced the governance level to ensure sustainable, steady and sound development by formulating well-defined institutional systems and work procedures.

Shareholders' General Meeting

We shall convene shareholders' general meetings in strict accordance with the Corporation Law, Articles of Association, Rules of the Procedure of Shareholders Meeting and Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited to ensure that all shareholders can enjoy their legal rights and interests.

Board of Directors

The Board of Directors, as the authoritative decision-making body of Wan Tong Yuan, shall be responsible for supervising and managing business and the decision-making direction. The Board of Directors has established three board committees, comprising the Audit Committee, the Remuneration Committee and the Nomination Committee, which can provide support for decision-making to enhance work efficiency. By actively implementing the diversification strategy of the Board of Directors, out of 6 board members generated by voting, there are three independent non-executive directors as well as experts in management and finance, fully utilized the different expertise, skills and experience of the directors. In 2017 the Board of Directors held 6 board meetings and 3 committee meetings.

Compliance operation

Robust and effective management mechanisms are not only the foundation of enterprise stability, but also the key for providing value for the interested parties. By establishing and maintaining a well-structured enterprise management system and procedures, proactively promoting legal construction, strictly following commercial ethics and accelerating the construction of anti-corruption system, Wan Tong Yuan can ensure sustainable and sound operation.

- In accordance with open pricing principle, all commodities and services pricing will be disclosed with open and transparent, and was shown on the display wall in service area.

Operation level improvement

Sound operating performance is the foundation of the enterprise, which is also a key precondition for enterprises achieving sustainable development. By making the listing in Hong Kong Stock Exchange as an opportunity, we systematically reconsolidate the internal management system, optimize service measures, fully enhance the management level for achieving efficient promotion of economic benefits. The revenue of the main business in 2017 has been up to RMB 38.617 million.



With all-around funeral service for meeting different funeral demands of customers

Different from other funeral enterprises which can only provide basic funeral services or certain /limited service, we can provide customers with a variety of funeral services according to different preferences and budget amounts, and also further expand the market by attracting local customers who prefer to pay a premium for special or customized services as well as customers from neighboring cities with decreasing cost-effective graveyards available.

Dedicated, experienced and stable management team

We believe that a dedicated, experienced and stable management team can help us to build a long-run development blueprint and sustainably navigate the business strategies and business implementation plans by paying close attention to market trends and customer preferences by virtue of profound insight into the industry.

Master the strategic development positions

We operate "Wan Tong Yuan" Cemetery, there are other potential customers recommended by Langfang third-party funeral services providers via online cooperation. At the same time, the accumulated local customs, preferences and other funeral knowledge in Langfang also provide a powerful support for launching in Langfang and the Beijing-Tianjin-Hebei Region funeral service market.

Diversified products

In order to meet the different funeral demands of customers, we can provide comprehensive funeral service portfolios and customize special landscape designs and gravestones. As of the end of 2017, we have built 20 tomb areas featuring traditional and artistic-style graveyards, including 18 traditional graveyards with consistent or slightly different design landscapes by means of uniform planning, and two artistic tombs employing special designs and construction materials, which means that customers can select the location, size, design and layout of graves, as well as types and styles of all gravestones and decorations.





Quality control

We attach great importance to the quality of products in the tomb area. We not only check the tombstone before use, but also reject defective tombstone products. We also regularly inspect cemeteries and tombstones and carry out quality maintenance during operation, so as to ensure the quality of funeral services. In order to ensure that quality control is in place, we have established a quality management team to supervise the quality control procedures for the implementation of funeral services, and understand and resolve quality complaints through an after-sales service communication mechanism. There were no major complaints from customers or local authorities throughout the year.

Protection of intellectual property rights

We fully protect intellectual property and maintain a good public image. As of the end of 2017, we submitted 17 trademark applications in total, of which 8 were successfully registered in mainland China and 1 in Hong Kong. We have not suffered any major claims or disputes that infringe trademarks or other intellectual property rights in the year.

Quality service

We deepen customer segmentation, customer needs and other research, serve the living and are kind to the dead with more meticulous and intimate services based on the specific needs of customers.



Ceremonial services

· Funeral service

We provide both traditional and artistic funeral services. Traditional funeral service refers to the use of standardized and prefabricated cemetery or tombstones in the same designated tomb area. Artistic funeral service refers to the use of uniquely designed tombstone, and also offers a wide range of customized services.

· Funeral rite and ceremony


Before we bury bone ashes in the cemetery, we hold personalized funeral rite and ceremony in accordance with the requirements of customers, and pay tribute to the deceased.

· Cemetery maintenance services

We will clean and patrol the cemetery regularly to ensure a clean and safe environment for tomb sweepers.

Funeral service processes

We continue to optimize funeral service processes, so that customers can have a convenient and intimate service experience.



01 View the cemetery layout

Guide our customers in site visits, so that customers can understand the layout of the cemetery and the optional cemetery, and recommend specific service types and customization suggestions according to the customer's requirements.

02 Choose funeral services and make contracts (non-customized funeral services)

The customer selects a specific funeral service and several value-added services, and signs the sales contract.

03 Design cemetery and tombstone (customized funeral services)

Provide existing standard tombstone and cemetery design for customers of traditional funeral services to choose; assist in the design of the tombstone and cemetery landscape for clients who opt for customized funeral services.

04 Build the tombstone and cemetery landscapes (customized funeral services)

Customize the tombstone and cemetery landscapes according to the style and design style elected by customers. Depending on the style and customized complexity of the tombstones and cemetery, this takes around 45 days to complete.

05 Engraving and funeral rites

Assist customers to choose engraving details, dates and eremonies for the burial, arrange tombstone engraving inscriptions and ceramic photos, hold funeral rites, provide logistical arrangements and other value-added services.

06 Post-funeral service

Check the tombstone periodically and repair it when necessary; ther post funeral services, such as grave-sweeping activities and the supply of flowers and offerings.

Service satisfaction improvements

We actively promote the standardized and transparent management of business processes, and fully safeguard the interests of customers, so as to provide customers with reliable and satisfactory services.

Transparent consumption

We make the tombs, porcelain images, inscriptions, and burial service prices on the display boards and announce them to customers, so that customers can avail themselves of our services clearly and safely, and ensure that as a consumer, every customer can have the full right to know about the products or services they select.

Privacy protection

We attach great importance to safeguarding the private inform ation of customers, encrypt customer data files, and manage them using specialist personnel. In principle, non-contractors cannot look through any tomb-related information, which effectively guarantees the confidentiality of customer information and is widely recognized by customers. There were no customer information leakage events in the year.

Customer satisfaction poll

In order to fully understand the customer's satisfaction with our services, we have specifically added a column for customer evaluation on the notice of the burial service. This helps us to understand the customer's demands and satisfaction in a timely manner and continuously improve the service level.

Environmental management reinforcement

Wan Tong Yuan actively implements the green development concept of "green hills and clear waters are invaluable assets", and bravely undertakes the responsibility of environmental protection. While enhancing operation and management capabilities, it aims to build a green, low-carbon funeral service, integrates environmental protection into the overall operation of the company, vigorously promotes green offices to reduce energy consumption, and comprehensively achieves green and sustainable development by promoting the construction of the cemetery environment.

Follow the environment Regulations

Our operation has strictly followed the relevant environmental protection laws and regulations in the funeral industry, including discharge supervision, sewage discharge, waste management and disposal, storage and treatment, and has fulfilled the obligations of environment.

There were no major environmental pollution events throughout the year.

Environmental protection input increase

We have continuously strengthened the management of funeral services and facilities, and have installed the environmentally friendly incinerators to burn paper banknotes and other offerings during the period of tomb-sweeping activity. We have updated and transformed obsolete cremation equipment to reduce pollution of the environment to the greatest extent.

Clean and beautiful park

We have well designed the cemetery to be like similar park landscapes, and with the flower beds, lawns and woods, the tomb areas and cemetery have been perfectly integrated with the surrounding landscape to provide visitors a comfortable and tranquil environment; meanwhile, we have also periodically cleaned and patrolled the cemetery to maintain a clean and beautiful cemetery landscape.

Carry out green office

We have devoted to promoting environmental sustainability, following the principles of recovery and reduction and encouraging the employees to use double-sided printing and copying in daily office work, and have established the paper recycling bins and popularized the use of recycled paper. At the same time we have also reduced energy consumption by turning offidle lighting equipment and electric appliances.



Green funeral and burial promotion

In 2016, nine governmental departments jointly released the *Guidance Opinions on Driving Land-saving and Eco-burials*, further promoting the concepts of green funerals and ecological funerals in the eyes of the ordinary people. As a practitioner of the green funeral services, Wan Tong Yuan has always been based on green development. It has made land-saving innovations through many ways, and has introduced various ecological burials, such as tree burials and wall burials. This gives funeral services more green environmental association to ensure that cemetery and natural environment becomes increasingly harmonious. In 2017, the company's green funeral business accounted for 22.5% of the total.



[CASE] Support land-saving ecological burial and promote ecological civilization construction

In traditional Chinese culture, the funeral thought of "burials bring peace to the deceased" has always been the mainstream thought. Since the introduction of cremation in China, more and more people have turned their funeral to ecological burial and other forms. In order to better promote the understanding of ecological burials amongst public, during the Tomb-sweeping Festival of 2017, the company held a signing activity for "supporting land-saving and ecological burials and promoting the construction of ecological civilization". By popularizing the knowledge of ecological funerals to the public, the public's misunderstanding of green burials is eliminated. The activity was recognized by the general public, while many citizens also gave their signatures in front of the signature board.



Resource usage and emissions

We strictly abide by the *Environmental Protection Law* and the laws, regulations, and standards concerning air, water, and soil pollution prevention. In daily operations, we continuously improve the usage benefits of energy and water resources, strengthen the management of various emissions, and strive to enhance environmental benefits, so as to lead the company towards sustainable development

Emission management reinforcement

We pay close attention to environmental management in operation, properly the waste water, exhaust gas and solid waste generated during the operating process, strictly control the emissions and do our best to reduce the negative impact of the company's operations on the environment and achieve green development.

Exhaust gas emission reduction

Wan Tong Yuan's exhaust gas emissions mainly come from firecrackers, and burning incense, and tin foil during the grave-sweeping process. In recent years, through the promotion of civilized sacrifices and environmental protection incinerators, souvenir dust has been greatly reduced. Other exhaust gas emissions are mainly from the direct emissions of fossil fuels (gasoline and diesel). The main components include sulfur dioxide, nitrogen oxides, and particulate matter.

Promotion of energy saving and carbon reduction

The greenhouse gas generated by Wan Tong Yuan is mainly produced by direct energy (diesel and gasoline) and purchased electricity, and its main component is carbon dioxide. We attach great importance to the harm caused by greenhouse gas emissions to the environment, actively promote emission reduction management in the park, and effectively reduce greenhouse gas emissions during operation by implementing a number of improvement measures.

The emission of nitrogen oxides is **77.42** kg

The emission of particulate matter is

7.52 k

0.12 kg





Planted green vegetation

We have continuously improved planting to reduce the greenhouse gas emission by greening trees in the cemetery. In 2017, we planted 17,605 green vegetation in large area, and paved and planted 1,500 m² lawns on the bare land.



Introduced energy saving vehicles

In order to better achieve energy conservation and emission reduction, we have introduced environmental protection battery carts in the park to be used for picking up the visitors, so as to reduce the amount of fossil energy used. In 2017, we introduced 2 energy-saving environmental protection vehicles.





Greenhouse gas emissions

Note: Category 1 refers to direct carbon dioxide emissions from stationary sources (except electric power) and mobile sources (vehicles) fuels burning. Category 2 includes the indirect carbon dioxide emissions caused by the purchased electricity.

Solid waste management reinforcement

We strictly comply with relevant national laws and regulations, classify, store, and legally dispose of solid waste such as household garbage, kitchen waste, and ritual items generated during operation, so as to ensure that our company's waste discharge complies with environmental standards, and thus reduce negative impacts on the environment.

Rational use of resources


Rational use of resources is of great importance for the sustainable development of the company. In the daily operation, we take the concept of resource saving and utilization, actively promote the improvement measures of energy management and water resource management, and strive to support the development of the company with minimum resource consumption.

Energy use

The energy consumed during the company's operations mainly include purchased electricity, diesel oil, and gasoline, which are used for the company's automobiles and daily office. In 2017, the company consumed 2,591.38L of diesel, 6,218.02L of gasoline, and 145,065kWh of the purchased electricity.

Water resource use

During operation, the main water resources of Wan Tong Yuan are the daily living and office water usage for the park staff, the greenery water of the cemetery and the customers' gravesweeping water. This waste water can be directly discharged without filtration. We use the constructed free life pond to collect, store and reuse rainwater and snow water, so as to achieve the goal of saving water resources. In 2017, the company's office water was about 200t.



Equal employment

The company strictly enforces the requirements of the *Labor Law, Labor Contract Law* and other relevant laws, and always adheres to the principle of equality, openness, and fair recruitment. Problems such as gender discrimination or ethnic discrimination are not allowed. It also implements various regulations to avoid child labor and forced labor, and recruits talented people for the company, so as to provide a fair competitive environment for candidates. In 2017, the signing rate of employee labor contract was 100%, and each employee can enjoy 11 days of paid vacation.



Salary and welfare

In order to realize the win-win goal "employees receives more income, the company gains more profits, and society achieves steady development", we constantly explore a more scientific compensation and welfare system, so as to provide decent work for employees and guarantee employees' basic rights in a comprehensive way.


Employee training



Our suppliers mainly include tombstones, ceramic photos, road engineering inside the cemetery and internal decorations.
