Highlight 摘要

The Group recorded a revenue of approximately HK\$50.1 million for the three months ended 30 June 2018, representing an increase of approximately HK\$12.2 million or 32.4% as compared to the three months ended 30 June 2017.

The Group recorded a profit attributable to the owner of the Company of approximately HK\$3.2 million for the three months ended 30 June 2018, representing an increase of approximately HK\$8.1 million as compared to the Group's net loss of approximately HK\$4.9 million for the three months ended 30 June 2017.

The increase of the Group's profit for the three months ended 30 June 2018 was mainly due to the increase of gross profit for the three months ended 30 June 2018 as compared with the gross profit for the three months ended 30 June 2017; and the recognition of the Listing expenses of approximately HK\$7.0 million in connection with the listing of the Company's shares on GEM (the "Listing") for the three months ended 30 June 2017 but no such expenses for the three months ended 30 June 2018. Excluding the one-off Listing expenses, the profit attributable to the owner of the Company would have been HK\$3.2 million and HK\$2.0 million for the three months ended 30 June 2018 and 2017 respectively, representing an increase of approximately 55.3% as compared to the three months ended 30 June 2017.

The Board does not recommend the payment of any dividend for the three months period ended 30 June 2018.

截至2018年6月30日止三個月，本集團錄得收益約50.1百萬港元，較截至2017年6月30日止三個月增加約12.2百萬港元或32.4%。

截至2018年6月30日止三個月，本集團錄得本公司擁有人應佔溢利約3.2百萬港元，較截至2017年6月30日止三個月本集團虧損淨值約4.9百萬港元增加約8.1百萬港元。

本集團截至2018年6月30日止三個月的溢利增加主要由於截至2018年6月30日止三個月的毛利較截至2017年6月30日止三個月的毛利增加；及於截至2017年6月30日止三個月就本公司股份於GEM上市（「上市」）確認上市開支約7.0百萬港元，但截至2018年6月30日止三個月並無有關開支。扣除一次性上市開支後，截至2018年及2017年6月30日止三個月，本公司擁有人應佔溢利分別為3.2百萬港元及2.0百萬港元，較截至2017年6月30日止三個月增加約55.3%。

董事會不建議派付截至2018年6月30日止三個月期間的任何股息。

1. GENERAL INFORMATION

The Company was incorporated in the Cayman Islands under the Companies Law as an exempted company with limited liability on 30 March 2016. The registered office of the Company is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands and principal place of business in Hong Kong is Unit 3304, 33/F, Tower 1, Enterprise Square Five, 38 Wang Chiu Road, Kowloon Bay, Kowloon, Hong Kong. The Company's immediate and ultimate holding company is Grand Tycoon Limited, a company incorporated in the British Virgin Islands ("BVI"). Grand Tycoon Limited is controlled by Mr. Fong Chun Man ("Mr. Fong"), a Director of the Company.

The Company is an investment holding company and its subsidiaries are principally engaged in the business of the sale and transportation of diesel oil and related products in Hong Kong.

The unaudited condensed consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is the functional currency of the Company and its principal subsidiaries and all values are rounded to the nearest thousands (HK\$'000), except when otherwise stated.

2. BASIS OF PREPARATION AND PRINCIPAL ACCOUNTING POLICIES

The unaudited condensed consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), Hong Kong Accounting Standards ("HKASs") and Interpretations (hereinafter collectively referred to as the "HKFRS") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and the disclosure requirements of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) (the "Hong Kong Companies Ordinance"). In addition, the unaudited condensed consolidated financial statements include applicable disclosures required by the GEM Listing Rules. The principal accounting policies used in the unaudited consolidated first quarterly results of the Group for the three months ended 30 June 2018 (the "First Quarterly Results") are consistent with those adopted in the preparation of the Group's annual financial statements for the year ended 31 March 2018.

In the current period, the Group has applied all new amendments to HKFRSs that are mandatorily effective for the accounting period beginning on or after 1 April 2018.

1. 一般資料

本公司為投資控股公司，其附屬公司主要在香港從事銷售及運送柴油燃料及相關產品。

除另有所指外，未經審核簡明綜合財務報表以本公司及其主要附屬公司的功能貨幣港元（「港元」）呈列，而所有價值湊整至最接近千位（千港元）。

2. 編製基準及主要會計政策

未經審核簡明綜合財務報表乃根據所有由香港會計師公會（「香港會計師公會」）頒佈的適用香港財務報告準則（「香港財務報告準則」）、香港會計準則（「香港會計準則」）及詮釋（下文統稱為「香港財務報告準則」）以及香港法例第622章香港公司條例（「香港公司條例」）之披露規定編製。此外，未經審核簡明綜合財務報表包括GEM上市規則的適用披露規定。編製本集團截至2018年6月30日止三個月的未經審核綜合第一季度業績（「第一季度業績」）所用的主要會計政策與編製本集團截至2018年3月31日止年度的年度財務報表所用者貫徹一致。

於本期間，本集團已應用於2018年4月1日或之後開始的會計期間內強制生效的所有香港財務報告準則的新修訂。

BUSINESS REVIEW

The Group principally carries on the business of the sale and transportation of diesel oil and related products in Hong Kong. The Group also supplies marine diesel oil used for construction vessels and lubricant oil used for construction machinery and vehicles. Most of the Group's customers are construction companies which require diesel oil to operate their construction machinery and vehicles. The Group had a fleet of eleven diesel tank wagons of various capacity and a marine oil barge as at 30 June 2018.

The Group has recorded a revenue of approximately HK\$50.1 million for the three months ended 30 June 2018, representing an increase of approximately HK\$12.2 million or 32.4% as compared to the three months ended 30 June 2017. The increase was mainly due to increase in demand from customers upon the commencement of customer's project in November 2017 and the demand of marine diesel oil from a new customer.

Meanwhile, the Group has executed strict control on costs and expenses. The Group recorded a profit attributable to the owners of the Company of approximately HK\$3.2 million for the three months ended 30 June 2018. The increase was mainly due to the increase of gross profit for the three months ended 30 June 2018 as compared with the gross profit for the three months ended 30 June 2017; and the recognition of the Listing expenses of approximately HK\$7.0 million in connection with the Listing for the three months ended 30 June 2017 but no such expenses for the three months ended 30 June 2018. Excluding the one-off Listing expenses, the profit attributable to the owners of the Company would have been increased by approximately 55.3% as compared to the three months ended 30 June 2017.

業務回顧

本集團主要在香港進行柴油及相關產品的銷售及運輸業務。本集團亦提供工程船舶的船用柴油以及工程機器及汽車的潤滑油。本集團的客戶大多數為需要柴油以操作其工程機械及汽車的工程公司。本集團於2018年6月30日擁有十一架不同容量的柴油貯槽車及一艘船用柴油駁船。

截至2018年6月30日止三個月，本集團錄得收益約50.1百萬港元，較截至2017年6月30日止三個月增加約12.2百萬港元或32.4%。有關收益增加乃主要由於客戶需求在客戶項目於2017年11月展開後增加及新客戶對船用柴油的需求增加所致。

同時，本集團對各項成本及費用進行嚴格監控。截至2018年6月30日止三個月，本集團錄得本公司擁有人應佔溢利約3.2百萬港元。有關增幅主要由於截至2018年6月30日止三個月的毛利較截至2017年6月30日止三個月的毛利增加；及於截至2017年6月30日止三個月就上市確認上市開支約7.0百萬港元，但截至2018年6月30日止三個月並無有關開支。扣除一次性上市開支後，本公司擁有人應佔溢利原應較截至2017年6月30日止三個月增加約55.3%。

The Board believes that market trend of sales of diesel oil and marine diesel oil market in Hong Kong remains optimistic mainly due to the stable and high level investment in public infrastructure including the railway network, development of marine construction projects including Central Wanchai Bypass and Island Eastern Corridor Link and the Hong Kong International Airport's third runway project together with the recovery of logistics industry in Hong Kong, coupled with the opening of Hong Kong-Zhuhai-Macau Bridge in the future which is expected to drive up logistics companies' demand for diesel oil and marine diesel oil.

In view of the challenging business environment and keen competition in the diesel oil sales market in Hong Kong, our Group will continue to deploy more resources on talent recruitment and strengthen our business development and marketing strategy on diesel oil and will also proactively seek potential business opportunities that will broaden our sources of income and enhance value to the shareholders.

FINANCIAL REVIEW

Revenue

The Group's revenue increased by approximately HK\$12.2 million or approximately 32.4% from approximately HK\$37.8 million for the three months ended 30 June 2017 to approximately HK\$50.1 million for the three months ended 30 June 2018.

Revenue from the sales of diesel oil, marine oil and lubricant oil accounted for approximately HK\$47.8 million, HK\$2.1 million and HK\$0.2 million, representing approximately 95.5%, 4.1% and 0.3%, respectively, of the Group's total revenue for the three months ended 30 June 2018. For the three months ended 30 June 2017, the revenue from the sales of diesel oil, marine oil and lubricant oil accounted for approximately HK\$37.1 million, HK\$0.5 million and HK\$0.3 million, representing approximately 98.0%, 1.2% and 0.8%, respectively, of the Group's total revenue. Sales of diesel oil remained the largest contributor to the Group's revenue. The increase was mainly due to the increase in demand upon the commencement of customer's project in November 2017.

The increase in the Group's revenue was primarily due to the increase in the Group's sales of diesel oil and marine diesel oil. Increase in demand of marine diesel oil was attributable to the demand of a new customer during the three months ended 30 June 2018.

未來前景

董事會認為香港柴油及船用柴油銷售市場的市場趨勢仍樂觀，主要由於公共基建（包括鐵路網絡）的投資穩定維持於較高水平、海事工程項目（包括中環灣仔繞道和東區走廊連接路以及香港國際機場第三跑道項目）的開發以及香港物流業的復甦所致，加上未來港珠澳大橋啟用，預計將可帶動物流公司對柴油及船用柴油的需求。

鑒於香港柴油銷售市場營商環境挑戰重重且競爭激烈，本集團將繼續投放更多資源於招募人才以及加強於柴油方面的業務發展及市場營銷策略，並將積極尋找可擴大本集團收入來源及增加股東價值的潛在商機。

財務回顧

收益

本集團的收益由截至2017年6月30日止三個月約37.8百萬港元增加約12.2百萬港元或約32.4%至截至2018年6月30日止三個月約50.1百萬港元。

來自柴油、船用柴油及潤滑油銷售的收益分別約為47.8百萬港元、2.1百萬港元及0.2百萬港元，分別佔截至2018年6月30日止三個月本集團總收益約95.5%、4.1%及0.3%。截至2017年6月30日止三個月，來自柴油、船用柴油及潤滑油銷售的收益分別約為37.1百萬港元、0.5百萬港元及0.3百萬港元，分別佔本集團總收益約98.0%、1.2%及0.8%。柴油銷售收益仍是本集團總收益的最大貢獻者。增加主要由於客戶項目於2017年11月展開後需求增加所致。

本集團收益增加乃主要由於本集團柴油及船用柴油銷售收益增加。船用柴油需求增加乃由於截至2018年6月30日止三個月新客戶的需求所致。

Cost of sales

Cost of sales primarily consists of diesel oil costs, marine diesel oil costs, lubricant oil costs, direct labour costs and depreciation. The purchase cost for the diesel oil, marine diesel oil costs and lubricant oil costs depends on the domestic purchase price offered by the Group's oil suppliers, with reference to the price indices such as Europe Brent spot crude price.

For the three months ended 30 June 2018, the Group's cost of sales was approximately HK\$44.3 million, representing an increase of approximately 33.4% from approximately HK\$33.2 million for the three months ended 30 June 2017. Such increase was in line with the overall increase in revenue.

Gross profit and gross profit margin

The gross profit represented the Group's revenue less cost of sales. The Group's gross profit slightly increased by approximately HK\$1.2 million from approximately HK\$4.6 million for the three months ended 30 June 2017 to HK\$5.8 million for the three months ended 30 June 2018. The Group's gross profit margin decreased slightly from 12.1% for the three months ended 30 June 2017 to 11.5% for the three months ended 30 June 2018.

Profit/(loss) for the period

As a result of the foregoing, the Group's net profit increased by approximately HK\$8.1 million from a loss of approximately HK\$4.9 million to a profit of approximately HK\$3.2 million for the three months ended 30 June 2018, and the Group's net profit margin increased from net loss margin approximately 13.1% to net profit margin of 6.3% during the same periods. The increase in the net profit and net profit margin for the three months ended 30 June 2018 was mainly due to the decrease in the recognition of Listing expenses during the Reporting Period.

銷售成本主要包括柴油成本、船用柴油成本、潤滑油成本、直接勞工成本及折舊。柴油採購成本、船用柴油成本及潤滑油成本取決於本集團燃油供應商提供的當地採購價，並經參考歐洲布倫特原油現貨價格等價格指標。

截至2018年6月30日止三個月，本集團的銷售成本約為44.3百萬港元，較截至2017年6月30日止三個月約33.2百萬港元增加約33.4%。銷售成本增加與收益整體增加情況一致。

毛利及毛利率

毛利指本集團的收益減銷售成本。本集團的毛利由截至2017年6月30日止三個月約4.6百萬港元輕微增加約1.2百萬港元至截至2018年6月30日止三個月約5.8百萬港元。本集團的毛利率由截至2017年6月30日止三個月約12.1%輕微減少至截至2018年6月30日止三個月約11.5%。

期內溢利／(虧損)

由於上述原因，本集團的純利由虧損約4.9百萬港元增加約8.1百萬港元至截至2018年6月30日止三個月約3.2百萬港元，而本集團的純利率於同期由淨虧損率約13.1%增加至錄得純利率6.3%。截至2018年6月30日止三個月純利及純利率增加主要由於於報告期間確認上市開支減少。

LIQUIDITY AND CAPITAL RESOURCES

Financial Resources and Liquidity

The Group finance its operations through cash generated from operating activities. The Group recorded net current assets of approximately HK\$80.5 million as at 30 June 2018.

As at 30 June 2018, the Group's current assets amounted to approximately HK\$92.3 million and the Group's current liabilities amounted to approximately HK\$11.8 million. Current ratio was approximately 7.8 as at 30 June 2018. Current ratio is calculated based on total current assets at the end of the period divided by total equity at the end of the period.

As at 30 June 2018, the maximum limit of the banking facilities available to the Group was amounted to approximately HK\$20.0 million and none of the banking facilities was utilized.

CAPITAL STRUCTURE

For the three months ended 30 June 2018, the capital structure of the Group consisted of equity attributable to the owners of the Company of approximately HK\$90.9 million. The share capital of the Group only comprises of ordinary shares.

The Shares were listed on the GEM of the Stock Exchange on the Listing Date. There has been no change in the capital structure of the Group since then.

FOREIGN CURRENCY EXPOSURE RISKS

The Group operates mainly in Hong Kong and is exposed to foreign exchange risk arising from various currency exposures, primarily with respect to the financial assets with Malaysian ringgit. Foreign exchange risk arises when future commercial transactions, recognised assets and liabilities are denominated in a currency that is not the group entities' functional currency. The Group however did not engage in any derivatives agreements and did not commit to any financial instrument to hedge its foreign exchange exposure during the three months ended 30 June 2018.

財務資源及流動資金

本集團經營活動的資金來源為經營活動產生的現金。於2018年6月30日，本集團錄得流動資產淨值約80.5百萬港元。

於2018年6月30日，本集團的流動資產約為92.3百萬港元，而本集團的流動負債則約為11.8百萬港元。於2018年6月30日，流動比率約為7.8倍。流動比率乃根據期末的總流動資產除以期末的總權益計算。

於2018年6月30日，本集團可用的銀行融資上限約為20.0百萬港元，且概無銀行融資已獲動用。

資本架構

截至2018年6月30日止三個月，本集團的資本架構包括本公司擁有人應佔權益約90.9百萬港元。本集團的股本僅包括普通股。

股份於上市日期於聯交所GEM上市。自此，本集團資本架構概無發生變動。

外匯風險

本集團主要在香港經營，並面臨各種貨幣風險所引起的外匯風險，主要指以馬來西亞令吉結算的金融資產。當未來商業交易、已確認資產及負債以不是集團實體功能貨幣計值時，則會出現外匯風險。然而，於截至2018年6月30日止三個月，本集團並未涉及任何衍生工具協議及概無訂立任何金融工具以對沖外匯風險。

TREASURY POLICIES

The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy liquidity position throughout the three months ended 30 June 2018. The Group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

SIGNIFICANT INVESTMENTS AND FUTURE PLANS FOR MATERIAL INVESTMENTS AND CAPITAL ASSETS

On 17 May 2018, the Company and Virtue Ever Limited (“**Virtue Ever**”) entered into an acquisition agreement (the “**1st Acquisition Agreement**”), pursuant to which the Company has conditionally agreed to purchase and Virtue Ever has conditionally agreed to sell a 10% equity interest in the China Forest Food Limited, together with its subsidiaries, at an aggregate consideration of RMB1.5 million (including the earnest money of RMB1.0 million which has been paid in cash) (the “**Acquisition**”). The completion of the Acquisition under the Acquisition Agreement was subject to certain customary conditions precedent to be fulfilled. Details are set out in the announcements of the Company date 17 May 2018 and 11 July 2018; and the “Events after the Reporting Period” of this report.

During the three months ended 30 June 2018, the Group did not have any significant investment, material acquisitions nor disposals of subsidiaries and affiliated companies save as disclosed from above and for those reorganisation activities done for the purpose of Listing as set out in the paragraph headed “Reorganisation” under the section headed “History and Development, Reorganisation and Group Structure” in the Prospectus.

MATERIAL ACQUISITIONS AND DISPOSAL OF SUBSIDIARIES, ASSOCIATES OR JOINT VENTURES

Save as disclosed above, there were no other significant investments held, material acquisitions or disposals of subsidiaries, associates or joint ventures during the three months ended 30 June 2018.

EMPLOYEES AND REMUNERATION POLICIES

As at 30 June 2018, the Group engaged a total of 24 employees (22 as at 31 March 2018) including the Directors. For the three months ended 30 June 2018, total staff costs amounted to approximately HK\$1.6 million (three months ended 30 June 2017: approximately HK\$1.6 million). Remuneration (including employees’ benefits) is maintained within the market level and reviewed on a periodic basis. Employees’ salary and relevant benefits are determined on the basis of performance, qualification, experience, positions and the Group’s business performance.

ENVIRONMENT POLICIES AND PERFORMANCE

The principal activity of the Group is governed by Hong Kong environmental laws and regulations including the Air Pollution Control Ordinance and the Water Pollution Control Ordinance in Hong Kong. These laws and regulations cover a broad range of environmental matters, including air pollution, noise and gas emissions, leakage of oil products or other hazardous substances. The Group recognises the importance of environmental protection and has implemented various environmental protection measures in order to minimise the operation impact on the environment and natural resources.

EVENTS AFTER THE REPORTING PERIOD

On 11 July 2018, the Company and Virtue Ever has entered into the 2nd acquisition agreement (the "2nd Acquisition Agreement") for the acquisition of 90% equity interest in the China Forest Food Group at an aggregate consideration of RMB10.5 million in which RMB3.5 million shall be payable upon the completion of the 2nd Acquisition Agreement and RMB7 million shall be payable upon the fulfillment of the profit guarantee for the years ending 30 June 2020 (the "2nd Acquisition"). The completion of the 2nd Acquisition under the 2nd Acquisition Agreement was subject to certain customary conditions precedent to be fulfilled. Details are set out in the announcement of the Company dated 11 July 2018.

All the conditions under the 2nd Acquisition Agreement have been satisfied and the completion of the 2nd Acquisition took place on 31 July 2018. As a result, China Forest Food has become a wholly-owned subsidiary of the Company and the financial statements of China Forest Food will be consolidated into the consolidated financial statements of the Group. Details are set out in the announcement of the Company dated 3 August 2018.

As from 30 June 2018 to the date of this report, save as disclosed in this report, the Board is not aware of any significant events requiring disclosure that have occurred.
