UPDATE ON STATUS OF THE COMPANY

This announcement is made by China Nonferrous Metals Company Limited (the “**Company**”) pursuant to Rule 17.10 of the GEM Listing Rules and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

References are made to the Company’s announcements dated 9 November 2017, 21 May 2018, 29 June 2018, 30 July 2018, 15 August 2018 and 18 September 2018 (the “**Announcements**”) in relation to, among others, the submission of the Resumption Proposal, the Reverse Takeover, the Possible Change in Control of the Company and the New Listing Application. Further announcement(s) will be made by the Company on major development relating to the Resumption Proposal, the New Listing Application and status of the Company as and when appropriate.

Dealing in the Shares on the Stock Exchange has been suspended since 1 April 2015 and will remain suspended until further notice.

Shareholders and potential investors of the Company should note that the resumption of trading in the Shares is subject to various conditions which may or may not be fulfilled.
