The Offer Price is expected to be fixed on or around Thursday, 6 December 2018. Applicants are required to pay the maximum Offer Price of HK\$0.64 for each Public Offer Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Company, and the Sole Lead Manager and the Co-Lead Managers (for itself and on behalf of the Underwriters) on or before the Price Determination Date, the Share Offer will not proceed.

Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.
