- the Share Consolidation whereby every forty (40) issued and unissued ordinary shares of HK\$0.02 each in the share capital of the Company be consolidated into one (1) Consolidated Share of HK\$0.80 each;
  - the Capital Reduction whereby the par value of the then issued Consolidated Shares reduced from HK\$0.80 each to HK\$0.01 each by cancelling the paid-up capital of the Company to the extent of HK\$0.79 each; and
  - the Share Subdivision whereby each of the authorized but unissued Consolidated Shares of HK\$0.80 each be subdivided into eighty (80) New Shares of HK\$0.01 each.
