(1) On 12 July 2019 (after trading hours of the Stock Exchange), the Company entered into the placing agreement with the placing agent pursuant to which the placing agent has conditionally agreed, as agent of the Company, to procure on a best effort basis to not less than six placees who and whose ultimate beneficial owners shall be independent third parties to subscribe for up to 408,000,000 placing shares at the placing price of HK\$0.016 per placing share. Further details are disclosed in the announcements dated 12 July 2019 and 25 July 2019.

(2) The Board proposes to implement the share consolidation on the basis that every ten (10) issued and unissued shares of par value of HK\$0.001 each in the share capital of the Company will be consolidated into one (1) consolidated share of par value of HK\$0.01 each. Further details are disclosed in the announcement date 15 July 2019 and 17 July 2019 and the circular dated 29 July 2019.
