This announcement is made by Basetrophy Group Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the potential investors and the shareholders of the Company (the “**Shareholders**”) that, based on a preliminary review on the unaudited consolidated management accounts of the Group for the eight months ended 31 August 2019, the Group is expected to record a net loss for the nine months ended 30 September 2019, as compared with a net profit for the corresponding period in 2018. The Board considers that the net loss was primarily attributable to (i) the decrease in revenue due to lower value of contracts awarded to the Group and delay in progress of certain projects; and (ii) the decrease in gross profit margin due to competitive project pricing arising from intense market competition and projects delays as mentioned above.

The information contained in this announcement is based on the preliminary assessment made by the Board with reference to the information currently available and the unaudited consolidated management accounts of the Group for the eight months ended 31 August 2019, which have not been audited or reviewed by the Group’s auditors or audit committee and may be subject to adjustment. Further details of the Group’s performance will be disclosed in the Group’s third quarterly results announcement for the nine months ended 30 September 2019, which is expected to be published in November 2019.

Shareholders and potential investors are advised to exercise caution when dealing in the securities of the Company.
