Reference is made to the announcements (the “**Announcement**”) of **China Trends Holdings Limited** (the “**Company**”) about the false news reports dated 24 November 2019, 25 November 2019 and 5 December 2019. Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcements.

On 12 December 2019, the Company received a notice from executive Director Mr. **Xiang Xin** (“**Mr. Xiang**”) and the alternate Director Mrs. **Kung Ching** (“**Mrs. Kung**”), in which Mr. Xiang and Mrs. Kung have again commissioned lawyers today to submit the second petition to the Taipei Prosecutors Office for lifting the departure restrictions due to not receiving response from the Taipei Prosecutors Office to their petition filed on 5 December 2019, and currently are continually awaiting the review of the Taipei Prosecutors Office.

The Company will make further announcements in any material developments in this matter or in accordance with other requirements of the GEM Listing Rules.
