## CHANGE IN USE OF PROCEEDS

This announcement is made by Xi'an Haitian Antenna Technologies Co., Ltd\* (西安海天天綫科技股份有限公司) (the "Company") pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the "GEM Listing Rules") and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the circular of the Company dated 2 February 2018 (the "Circular") in relation to, among other things, the issue of the New Domestic Shares under the Specific Mandate (the "New Issue"). Capitalised terms used in this announcement shall have the same meanings as those used in the Circular unless the context requires otherwise.

In June 2019, The Ministry of Industry and Information Technology of the PRC has granted 5G licences for commercial use to China Telecom, China Mobile, China Unicom and China Broadcast Network, which introduced the official commercial use of the 5G technology in the PRC. The mobile communication industry has been widely recognized as one of the markets with largest and fastest growth in the next few years. It is expected that mobile communication operators will start large-scale network construction in 2020. Leveraging on the artificial medium lens multi-beam antenna (人工介質透鏡多波束天線) products of the Group following the acquisition of Suzhou Haitian New Antenna Technologies Co., Ltd.\* (蘇州海天新天綫科技有限公司) in December 2019, the Group would actively seize the substantial opportunities in the 5G market. The Group would fully integrate its resources, and make full use of its operation and production experience and sales network in the communications industry to promote the mobile communication antenna products. At the same time, the Group would continue to develop a series of new materials antenna products in different frequency bands that can be widely used in 5G mobile communication, W-LAN and other industries and scenarios. Accordingly, the Group's focus in the next few years will be on mobile communications related businesses.

The net proceeds from the New Issue are approximately RMB41.0 million (the "**Net Proceeds**"). With a view to accommodating the Group's development and strategies and meeting the needs of its production and operation, the Board had resolved on 26 December 2019 to reallocate the Net Proceeds as follows:
