The Group is currently in negotiation with other potential customers for placing advertisements on the rest of the remaining 400 billboards.

In view of the above-mentioned project delay, Chiuchow Consultant has also agreed to delay the commencement of the Sub-agency Agreement, with revision of the Contract Period as the same as the Main Agency Agreement, i.e. from 1 March 2020 to 28 February 2022, also with no change in the original contract amount and other details.
