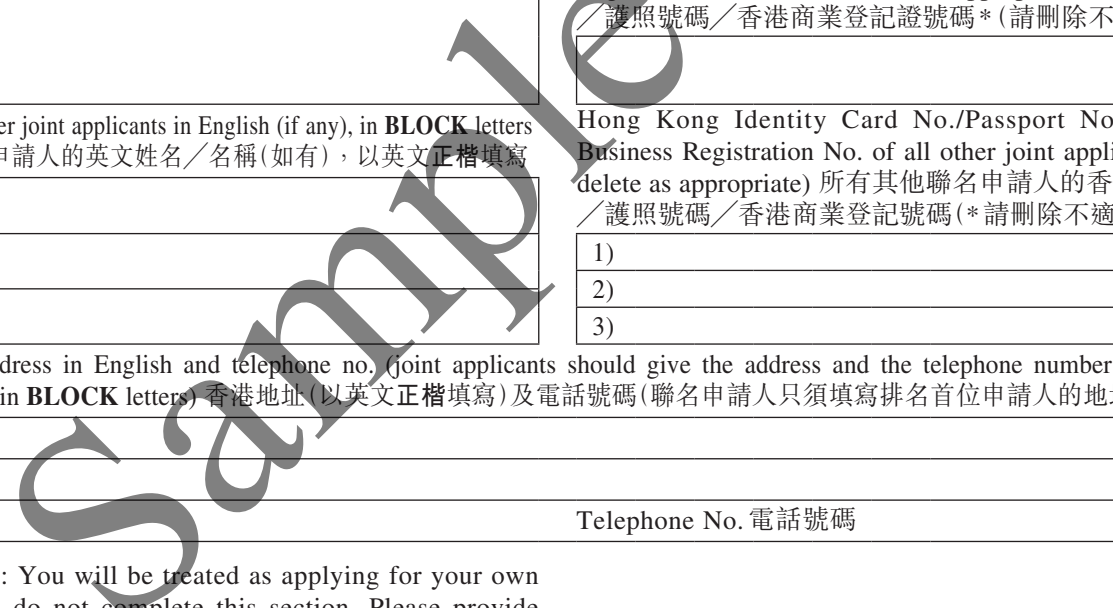

5. You must be outside the United States, not be a United States Person (as defined in Regulation S under the U.S. Securities Act) and not be a legal or natural person of the PRC.
6. Unless permitted by the GEM Listing Rules, you cannot apply for any Public Offer Shares if you:
 - are an existing beneficial owner of Shares in the Company and/or any of its subsidiaries;
 - are a Director or chief executive of the Company and/or its subsidiaries;
 - are a connected person (as defined in the GEM Listing Rules) of the Company or will become a connected person of the Company immediately upon completion of the Share Offer;
 - are an associate (as defined in the GEM Listing Rules) of any of the above; or
 - have been allocated or have applied for any Placing Shares under the Placing or otherwise participated in the Placing.

B. If you are a nominee

C. Effect of completing and submitting this Application Form

D. Power of attorney

Determination of Offer Price and Allocation of Public Offer Shares

The Offer Price is expected to be fixed on or around Monday, 6 July 2020. Applicants are required to pay the maximum Offer Price of HK\$0.60 for each Public Offer Share together with 1% brokerage fee, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Company and the Joint Bookrunners (for themselves and on behalf of the Underwriters) on or before Tuesday, 7 July 2020, the Share Offer will not proceed.

Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close. The Company expects to announce the final Offer Price, the indication of level of interest in the Placing, the level of applications under the Public Offer and the basis of allotment of the Public Offer Shares, and the number of Offer Shares reallocated, if any, between the Public Offer and the Placing, on Friday, 10 July 2020 on the website of the Stock Exchange at www.hkexnews.hk and the Company's website at www.yikwo.cn. Results of allocations in Public Offer, and the Hong Kong Identity Card/passport/Hong Kong business registration numbers of successful applicants (where applicable) will be available on the above websites.

The allocation of the Offer Shares between the Public Offer and the Placing will be subject to reallocation as described in the section headed "Structure and Conditions of the Share Offer" in the Prospectus. In particular, the Joint Bookrunners may, in certain circumstances, reallocate the Offer Shares from the Placing to the Public Offer to satisfy valid applications under the Public Offer. With reference to Guidance Letter HKEx-GL91-18, if such reallocation is done other than pursuant to Practice Note 6 of the GEM Listing Rules the maximum total number of Offer Shares that may be allocated to the Public Offer following such reallocation shall be not more than double the initial allocation to the Public Offer i.e. 30,000,000 Offer Shares, representing 20% of the number of the Offer Shares initially available for subscription under the Share Offer.
