To our Shareholders

CHAIRMAN'S STATEMENT

After 15 years of establishment in Hong Kong, our Group is one of the leading lifestyle furniture and home furnishing companies in Hong Kong and China. In Hong Kong, we operate under the brand name "TREE", and engage in (i) the sale and distribution of furniture and home accessories; (ii) the sale and distribution through licensing in China and USA; (iii) the operation of TREE Café at the Group's flagship store in Hong Kong; (iv) the provision of styling and consulting services; and (v) the provision of a furniture rental business.

New endeavours during the financial year included adding a new online e-commerce platform in May 2019 which eases our reliance on our three retail stores and provides an additional shopping channel for our customers. Moreover, we launched a new furniture rental business for the Hong Kong market in August 2019 to diversify our offering and services to our customers.

Our wholly-owned subsidiary, Hong Kong Italive International Co. Limited ("HK Italive") focuses on the sourcing and distribution of high-end Italian made furniture in China. HK Italive has offices in Hong Kong and Italy to maintain a unique merchandising network with Italian furniture manufacturers, and offers a wide variety of furniture products to individuals and wholesale customers, as well as renovation projects throughout China.

FINANCIAL RESULTS

For the year ended 31 March 2020, the total revenue of the Company was approximately HK\$91.1 million, an increase of approximately HK\$5.7 million, mainly attributable to an increase of commission income from HK Italive which was acquired by the Group in December 2018. The gross profit margin of the Group increased slightly from approximately 67.8% to 71.6%.

The economy and retail business in Hong Kong has been hard hit since the middle of 2019 due to the political unrest, followed by the unexpected COVID-19 outbreak happening at the end of 2019.

The Group's furniture agency service revenue was also negatively affected since the COVID-19 outbreak which saw a complete lockdown of certain Chinese cities. Unfortunately, Italy which is a major source of furniture products for the China market was also in lockdown for a number of months in early 2020.

Amidst all these challenges, we are pleased to report that the Group has achieved a net profit of HK\$5.2 million, which is HK\$4.1 million or 377.7% higher than the last financial year of HK\$1.1 million.

各位股東：

主席報告

本集團紮根於香港，經過十五年發展，現已成為香港及中國領先的生活時尚傢俱及家飾公司之一。在香港，我們以「TREE」品牌名稱經營業務，從事(i)銷售及分銷傢俱及家居配飾；(ii)透過授出許可權在美國及中國銷售及分銷產品；(iii)於本集團香港旗艦店內經營TREE Café；(iv)提供設計及諮詢服務；及(v)提供傢俱租賃服務。

本財政年度的新猷包括於2019年5月推出全新網上電子商務平台，讓我們可減少倚賴旗下三間零售店，同時為客戶增添選購渠道。此外，我們於2019年8月針對香港市場開展新的傢俱租賃業務，為客戶提供更多元化的產品及服務。

旗下全資附屬公司香港意享世家國際貿易有限公司(「香港意享世家」)在中國專注於搜羅及分銷高級意大利製傢俱。香港意享世家於香港及意大利設有辦事處，維繫與意大利傢俱製造商的獨有採購網絡，於全中國為個人及批發客戶提供多元化的傢俱產品及進行裝修項目。

財務業績

截至2020年3月31日止年度，本公司總收益約為91.1百萬港元，增加約5.7百萬港元，主要是由於來自本集團於2018年12月收購的香港意享世家的佣金收入增加所致。本集團毛利率由約67.8%微升至71.6%。

自2019年中以來政治形勢動蕩不定，至2019年底更突然爆發COVID-19，香港經濟及零售業務受到重挫。

本集團傢俱代理服務收益自COVID-19爆發起亦因若干中國城市全面封城而受到負面影響。禍不單行，作為中國市場傢俱產品主要來源國的意大利亦於2020年初封城數月。

即使面對上述種種挑戰，我們亦欣然呈報，本集團錄得純利5.2百萬港元，較上一財政年度的1.1百萬港元增加4.1百萬港元，增幅為377.7%。

CHAIRMAN'S STATEMENT 主席報告

THE FUTURE

While I am writing this statement, we continue to see the political and social unrest happening in Hong Kong and we are still hard fighting with COVID-19. Our industry continues to be challenged with highly competitive retail market conditions and the prevalence of weak consumer confidence and spending in Hong Kong. However, we will continue to take advantage of growth opportunities to improve our competitive positioning. For example, the outbreak of the COVID-19 heightened internal awareness of the importance of e-commerce as a 'remote' revenue driver and, as a result, we are focused on strengthening the operation of our online shopping platform.

Our sales team is working hard to revive the Italian furniture business, and we are glad to see that Italy is slowly recovering from the COVID-19 crisis.

THE FINAL NOTE

The Group is proud of the TREE brand that was founded in Hong Kong and has grown with heart and integrity over the last fifteen years. Now, as a much loved and trusted source of beautiful, high quality home furnishings in Hong Kong, we are pleased to extend the reach of the TREE brand into the US and China.

On behalf of the Board, we would like to thank all TREE staff members, our suppliers, partners and, of course, our customers for their continuous support of TREE.

BUSINESS REVIEW

Headquartered in Hong Kong and operating under the brand name “TREE”, we engage in (i) the sale and distribution of furniture and home accessories; (ii) the distribution and licencing of our intellectual property rights; (iii) the operation of TREE Café in our flagship store in Ap Lei Chau (the “**Flagship Store**”); (iv) consignment sales of home accessories and furniture agency services; (v) the provision of styling and consulting services and (vi) provision of furniture rental business. We offer a variety of (i) furniture including tables, chairs, storage solutions, sofas and beds; and (ii) home accessories including kitchenware, bed and bathroom related products, jars, cushions, mattresses, utensils and baskets. In addition, we acquired, Hong Kong Italiveing International Company Limited (“**HK Italiveing**”) in December 2018, and it is principally engaged in the provision of furniture agency service. Furthermore, a subsidiary, Shanghai Italiveing International Co., Ltd. (“**Shanghai Italiveing**”), was incorporated in July 2019.

As at the date of this report, we operated three “TREE” retail stores in Hong Kong namely, our Flagship Store, our Sha Tin store, and our Yuen Long store which we opened in May 2018. We have commercial online sales since May 2019.

During the year ended 31 March 2020, we generated revenue from the (i) sale of furniture and home accessories; (ii) distribution and license fee income; (iii) operation of TREE Café; (iv) consignment sales of home accessories and furniture agency service; and (v) provision of styling and consulting services. The table below sets forth a breakdown of our revenue for the years ended 31 March 2020 and 2019:

For the year ended 31 March 2020 (“**FY2020**”), our revenue amounted to approximately HK\$91.1 million, representing an increase of approximately HK\$5.7 million or 6.7% from approximately HK\$85.4 million for year ended 31 March 2019 (“**FY2019**”). Such increase was mainly attributable to the increase in the commission income, partly offset by the decrease in sale of furniture and home accessories and consulting income.

業務回顧

我們的總部位於香港，以「TREE」品牌名稱經營業務，從事(i)傢俱及家居配飾銷售及分銷；(ii)使用知識產權分銷及許可；(iii)在鴨脷洲的旗艦店（「**旗艦店**」）內經營TREE Café；(iv)家居配飾寄售及傢俱代理服務；(v)提供設計及諮詢服務及(vi)提供傢俱租賃業務。我們提供多種(i)傢俱，包括桌椅、收納解決方案、沙發及床；及(ii)家居配飾，包括廚房用品、床及浴室相關產品、罐子、靠墊、床墊、餐具及籃子。此外，我們於2018年12月收購香港意享世家國際貿易有限公司（「**香港意享世家**」），其主要從事提供傢俱代理服務。此外，附屬公司上海意塔美致貿易有限公司（「**上海意塔美致**」）於2019年7月註冊成立。

於本報告日期，我們於香港經營三間「TREE」零售店，即旗艦店、沙田店及於2018年5月開設的元朗店。我們於2019年5月開展網上銷售。

於截至2020年3月31日止年度，我們的收益來自(i)傢俱及家居配飾銷售；(ii)分銷及許可權費收入；(iii)經營TREE Café；(iv)家居配飾寄售及傢俱代理服務；及(v)提供設計及諮詢服務。下表載列我們截至2020年及2019年12月31日止年度的收益明細：

截至2020年3月31日止年度（「**2020財政年度**」），我們的收益約為91.1百萬港元，較截至2019年3月31日止年度（「**2019財政年度**」）約85.4百萬港元增加約5.7百萬港元或6.7%，主要是源於佣金收入增加，惟部分因傢俱及家居配飾銷售以及諮詢收入減少而被抵銷。

Sale of furniture and home accessories

TREE primarily sells its products to (i) retail customers who visited our retail stores, being the Direct Sales; and (ii) our distributor in the PRC, being the Distribution Sales. The following table sets forth a breakdown of our sale of furniture and home accessories by the Direct Sales and Distribution Sales for FY2020 and FY2019, respectively.

For FY2020, revenue generated from the Direct Sales maintained at approximately HK\$69.0 million, representing a slight decrease of approximately HK\$2.6 million or 3.6% from approximately HK\$71.6 million for FY2019.

For FY2020, revenue generated from the Distribution Sales amounted to approximately HK\$1.7 million, which remains stable as compared to FY2019.

Distribution and license fee income

We entered into distribution agreements with our PRC distributor, and we are entitled to receive annual non-refundable fees of HK\$2.4 million and HK\$0.8 million from our PRC distributor for the distribution of our products in Beijing and Hainan province, the PRC, respectively.

We entered into licence agreements with American Tree, Ltd. (“**American Tree**”), pursuant to which, we granted an exclusive licence to American Tree to use certain trademarks and intellectual property of our Group in the United States and Canada for a term of three years from the Listing on 25 January 2018, for a license fee based on the revenue of American Tree. We recognised license fee income of approximately HK\$86,000 from American Tree for FY2020 and HK\$0.2 million in FY2019.

Our distribution and license fee income was approximately HK\$3.3 million for FY2020 and HK\$3.4 million for FY2019, respectively, representing approximately 3.6% and 4.0% of our total revenue for FY2020 and FY2019, respectively.

Food and beverage income

Our food and beverage income generated from operating TREE Café in our Flagship Store was approximately HK\$2.6 million and HK\$2.8 million for FY2020 and FY2019, respectively. The decrease was mainly due to less customers as a result of the outbreak of the COVID-19 since December 2019.

Commission income

Our commission income comprised income generated from (i) the furniture agency service by HK Italiving and (ii) the sales of consignment goods. The increase of approximately HK\$10.8 million was mainly contributed by HK Italiving, which was acquired in December 2018.

Consulting income

Our consulting income comprised income generated from providing styling ideas, advising on furniture to be used and conducting site visits and sourcing trips for projects. During FY2020, the Group provided less styling and consulting services in relation to Hong Kong residential show flats as compared to FY2019.

2020財政年度的直接銷售所得收益維持於約69.0百萬港元，較2019財政年度約71.6百萬港元微跌約2.6百萬港元或3.6%。

2020財政年度的分銷銷售所得收益約為1.7百萬港元，與2019財政年度相比維持穩定。

分銷及許可權費收入

我們與中國分銷商訂立多份分銷協議，並有權就於中國北京市及海南省分銷產品向中國分銷商分別收取2.4百萬港元及0.8百萬港元的不可退還年度費用。

我們與American Tree, Ltd. (「**American Tree**」)訂立多份許可協議，據此，我們向American Tree授出一項可於美國及加拿大使用本集團若干商標及知識產權的獨家許可權，自2018年1月25日上市起為期三年，並基於American Tree的收益收取許可權費。我們於2020財政年度自American Tree確認許可權費收入約86,000港元，而2019財政年度則確認0.2百萬港元。

2020財政年度及2019財政年度，我們的分銷及許可權費收入分別約為3.3百萬港元及3.4百萬港元，分別佔2020財政年度及2019財政年度的總收益約3.6%及4.0%。

食品及飲品收入

2020財政年度及2019財政年度，於我們的旗艦店內經營TREE Café產生的食品及飲品收入分別約為2.6百萬港元及2.8百萬港元。該跌幅主要是源自2019年12月以來爆發COVID-19令客戶減少。

佣金收入

我們的佣金收入包括下列項目產生的收入：(i)香港意享世家的傢俱代理服務；及(ii)銷售寄售貨品。約10.8百萬港元的增長主要來自於2018年12月收購的香港意享世家。

諮詢收入

我們的諮詢收入包括為項目提供設計創意、就將予使用的傢俱提供意見以及出差進行實地考察及採購所產生的收入。於2020財政年度，本集團相比2019財政年度向香港住宅物業展銷廳提供較少設計及諮詢服務。

FINANCIAL REVIEW

Revenue

The Group's revenue increased to approximately HK\$91.1 million for FY2020 from approximately HK\$85.4 million for FY2019, representing a growth of approximately 6.7%. Such increase was mainly due to the increase in the commission income generated from HK Italiving for providing furniture agency service in FY2020 as compared to FY2019.

Gross profit and gross profit margin

Our overall gross profit increased to approximately HK\$65.3 million for FY2020 from approximately HK\$57.9 million for FY2019. Our overall gross profit margin improved to approximately 71.6% for FY2020 from approximately 67.8% for FY2019.

Our gross profit margin for the sale of furniture and home accessories remained stable at approximately 66.7% for FY2020 and approximately 66.5% for FY2019, the gross profit margin remained relatively stable. Our gross profit margin for the Distribution Sales was approximately 50.0% for FY2019 and approximately 50.1% for FY2020, which remained relatively stable.

Our gross profit margin for the sale of food and beverages remained relatively stable at approximately 64.3% for FY2020 and approximately 64.0% for FY2019.

Selling and marketing expenses

Our selling and marketing expenses comprise (i) rental payments and depreciation of right-of-use assets; (ii) staff costs attributable to the salary of our staff engaged in sales and marketing activities; (iii) marketing expenses; (iv) payment gateway charges attributable to fees for our payment channels such as credit cards or EPS; and (v) electricity and water expenses.

Our selling and marketing expenses amounted to approximately HK\$33.7 million for FY2020, representing a decrease of approximately HK\$3.3 million or approximately 9.0% from approximately HK\$37.0 million for FY2019. Such decrease was mainly due to the decrease in staff costs resulting from the decrease in bonus to salespersons for FY2020.

財務回顧

收益

本集團的收益由2019財政年度約85.4百萬港元增至2020財政年度約91.1百萬港元，增長約6.7%，主要是由於相比2019財政年度，香港意享世家於2020財政年度提供傢俱代理服務所產生的佣金收入增加。

毛利及毛利率

我們的整體毛利由2019財政年度約57.9百萬港元增至2020財政年度約65.3百萬港元。我們的整體毛利率由2019財政年度約67.8%改善至2020財政年度約71.6%。

我們銷售傢俱及家居配飾的毛利率維持穩定，分別為2020財政年度約66.7%及2019財政年度約66.5%。毛利率維持相對穩定。我們分銷銷售的毛利率於2019財政年度約為50.0%，而2020財政年度則約為50.1%，維持相對穩定。

我們銷售食品及飲品的毛利率維持相對穩定，2020財政年度約為64.3%，而2019財政年度約為64.0%。

銷售及市場推廣開支

我們的銷售及市場推廣開支包括(i)租金及使用權資產折舊；(ii)我們從事銷售及市場推廣活動員工的薪金所佔的員工成本；(iii)市場推廣開支；(iv)由信用卡或易辦事等付款通道費用所引起的付款通道開支；及(v)水電開支。

2020財政年度，我們的銷售及市場推廣開支約為33.7百萬港元，較2019財政年度約37.0百萬港元減少約3.3百萬港元或約9.0%，主要因2020財政年度銷售人員花紅減少令員工成本下降。

Administrative expenses

Our administrative expenses comprised (i) staff costs for our administrative staff and Directors' emoluments; (ii) professional fees which included legal fees, consultancy fees and auditor's remuneration; (iii) travel expenses; (iv) office expenses; (v) depreciation of our property, plant and equipment, and amortisation of our intangible assets; (vi) repairs and maintenance for our trucks and retail stores; (vii) insurance expenses which included business insurance, vehicle insurance and medical insurance; (viii) recruitment expenses which included fees to the recruitment agents and advertisements on websites; (ix) bank charges; (x) handling fee; and (xi) others which included motor vehicle expenses, net foreign exchange losses and entertainment expenses.

For FY2020, our administrative expenses amounted to approximately HK\$19.4 million, representing an increase of approximately HK\$0.5 million or approximately 2.9% as compared to approximately HK\$18.8 million for FY2019. Such increase was primarily due to the handling fee for the operation of HK Itliving acquired on December 2018, partially offset by the decrease in recruitment cost.

Fair value change on contingent consideration payable

Fair value change on contingent consideration payable amounted to HK\$3.4 million is the fair value recognised in profit or loss on contingent consideration payable for FY2020.

The fair value of the contingent consideration payable may be affected by the post-acquisition performance of the HK Itliving. The fair value was determined by the management with reference to the valuation performed by an independent external valuer. We will assess the valuation of the contingent consideration payable annually, and there would be a potential fair value loss on the contingent consideration payable with a maximum exposure of HK\$3.2 million for FY2021.

Finance costs

Finance costs mainly comprised interest expenses on interest-bearing borrowings and finance charges on lease liabilities. Finance costs were approximately HK\$0.7 million and HK\$0.3 million for FY2020 and FY2019, respectively. The increase was primarily due to the adoption of HKFRS 16 since 1 April 2019.

Income tax expense

Income tax expense for the Group increased to approximately HK\$2.4 million for FY2020 from approximately HK\$1.0 million for FY2019. The increase was mainly due to the increase in taxable profits.

我們的行政開支包括(i)我們行政人員及董事酬金的員工成本；(ii)專業費用，包括法律費用、諮詢費及核數師酬金；(iii)差旅開支；(iv)辦公室開支；(v)物業、廠房及設備折舊以及無形資產攤銷；(vi)我們的卡車及零售店的維修及保養；(vii)保險開支，包括商業保險、車輛保險及醫療保險；(viii)招聘開支，包括招聘代理費及網站廣告費；(ix)銀行手續費；(x)處理費；及(xi)包括汽車開支、淨外匯虧損及應酬開支等的其他費用。

2020財政年度，我們的行政開支約為19.4百萬港元，較2019財政年度約18.8百萬港元增加約0.5百萬港元或約3.2%，主要是源於經營於2018年12月收購的香港意享世家的處理費，惟有關費用部分被招聘成本的跌幅抵銷。

應付或然代價的公允價值變動

2020財政年度，應付或然代價的公允價值變動3.4百萬港元為於損益就應付或然代價確認的公允價值。

應付或然代價的公允價值可能會受到香港意享世家的收購後表現的影響。公允價值由管理層參考獨立外部估值師進行的估值釐定。我們將每年評估應付或然代價的估值，而2021財政年度應付或然代價的潛在公允價值虧損可能會高達3.2百萬港元。

財務成本

財務成本主要包括計息借貸的利息開支及租賃負債的財務支出。2020財政年度及2019財政年度的財務成本分別約為0.7百萬港元及0.3百萬港元。財務成本增加主要是由於自2019年4月1日起採納香港財務報告準則第16號所致。

所得稅開支

本集團的所得稅開支由2019財政年度約1.0百萬港元增至2020財政年度約2.4百萬港元，主要是由於應課稅溢利增加所致。

Profit for the year

Our Group recorded an increase in profit by approximately 377.7% from approximately HK\$1.1 million for FY2019 to approximately HK\$5.2 million for FY2020.

KEY FINANCIAL POSITION ITEMS

Inventories

Our inventories consisted of finished goods and goods in transit which we purchased from our suppliers. The inventories balance decreased to HK\$11.6 million as at 31 March 2020 from approximately HK\$13.8 million as at 31 March 2019, which was mainly in line with the drop of the sales of furniture and home accessories.

Trade and other receivables

Our trade receivables consisted of trade receivables from customers and payment vendors. As at 31 March 2020 and 2019, our trade receivables amounted to approximately HK\$43.1 million and HK\$24.7 million, respectively. The increase of approximately HK\$18.4 million was mainly due to the increase in trade receivables of HK Italiving.

Our other receivables consisted of rental deposits, utilities deposits, trade deposits, prepayments, and prepayment to a related company. As at 31 March 2020 and 2019, our other receivables amounted to approximately HK\$9.4 million and HK\$11.0 million, respectively.

Bank balance and cash

Bank balance and cash include cash at bank and in hand. As at 31 March 2020 and 2019, our bank balance and cash amounted to approximately HK\$16.8 million and HK\$22.8 million, respectively. For the details of cash movement, please refer to the consolidated statement of cash flows on pages 86 to 87.

年內溢利

本集團錄得溢利由2019財政年度約1.1百萬港元增加約377.7%至2020財政年度約5.2百萬港元。

主要財務狀況項目

存貨

我們的存貨包括我們向供應商購買的成品及在途貨品。存貨結餘由2019年3月31日約13.8百萬港元減至2020年3月31日的11.6百萬港元，大致與傢俱及家居配飾銷售額的減幅一致。

貿易及其他應收款項

我們的貿易應收款項包括來自客戶及支付服務供應商的貿易應收款項。於2020年及2019年3月31日，貿易應收款項分別約為43.1百萬港元及24.7百萬港元。增加約18.4百萬港元乃主要由於香港意享世家的貿易應收款項增加。

我們的其他應收款項包括租金按金、公用按金、貿易按金、預付款項及預付一間關聯公司款項。於2020年及2019年3月31日，其他應收款項分別約為9.4百萬港元及11.0百萬港元。

銀行結餘及現金

銀行結餘及現金包括於銀行及手頭的現金。於2020年及2019年3月31日，銀行結餘及現金分別約為16.8百萬港元及22.8百萬港元。有關現金變動的詳情，請參閱第86至87頁的綜合現金流量表。

Trade and other payables

Our trade payables consisted of trade payables to suppliers in relation to the purchase of goods. There were no credit periods granted by our suppliers. As at 31 March 2020 and 2019, our trade payables amounted to approximately HK\$7.3 million and HK\$4.2 million, respectively.

Our other payables comprised accrued charges, consideration payable which represent the unpaid cash consideration for the acquisition of HK Itliving, and provision for long service payments. As at 31 March 2020 and 2019, our other payables amounted to approximately HK\$15.5 million and HK\$7.6 million, respectively. The increase was mainly due to the redesignation of contingent consideration payable as consideration payable of HK\$12.3 million based on the audited results of HK Itliving for FY2019 which remained unpaid as at 31 March 2020.

Contract liabilities

Our contract liabilities mainly represented unrecognised revenue from customers where delivery of products is required and pending. As at 31 March 2020 and 2019, our contract liabilities amounted to approximately HK\$4.7 million and HK\$10.6 million, respectively. The decrease was mainly due to a drop in our retail sales during February and March 2020 as compared to the same period in 2019.

Bank borrowings

As at 31 March 2020 and 2019, our Group recorded bank borrowings of approximately HK\$5.7 million and HK\$0.5 million, respectively. The increase in bank borrowings was mainly due to the drawdown of a new bank facility granted to HK Itliving.

Lease liabilities/ Finance lease liabilities

As at 31 March 2020 and 2019, our Group recorded lease liabilities/ finance lease liabilities of approximately HK\$20.2 million and HK\$1.1 million, respectively. Such increase was due to the adoption of the HKFRS 16 "Leases" since 1 April 2019. Our Group recognised lease liabilities relating to leases which were previously classified as operating leases under HKAS 17 "Leases". As at 31 March 2020, our Group has entered into leases for warehouse, office, shop premises and motor vehicles.

貿易及其他應付款項

我們的貿易應付款項包括就購買貨品應付供應商的貿易款項。我們的供應商並無授出任何信貸期。於2020年及2019年3月31日，我們的貿易應付款項分別約為7.3百萬港元及4.2百萬港元。

我們的其他應付款項包括應計費用、應付代價（指收購香港意享世家的未付現金代價）及長期服務金撥備。於2020年及2019年3月31日，我們的其他應付款項分別約為15.5百萬港元及7.6百萬港元。其他應付款項增加主要是由於基於香港意享世家2019財政年度的經審核業績將應付或然代價12.3百萬港元重新指定為應付代價而該款項於2020年3月31日仍未支付。

合約負債

我們的合約負債主要指來自產品需要付運而有代發送的客戶的未確認收益。於2020年及2019年3月31日，我們的合約負債分別約為4.7百萬港元及10.6百萬港元。合約負債減少主要是由於2020年2月及3月的零售銷售較2019年同期下降所致。

銀行借貸

於2020年及2019年3月31日，本集團錄得銀行借貸分別約5.7百萬港元及0.5百萬港元。銀行借貸增加主要是由於提取香港意享世家獲授的新銀行融資所致。

租賃負債／融資租賃負債

於2020年及2019年3月31日，本集團錄得租賃負債／融資租賃負債分別約20.2百萬港元及1.1百萬港元。租賃負債／融資租賃負債增加乃由於自2019年4月1日起採納香港財務報告準則第16號「租賃」所致。本集團就之前根據香港會計準則第17號「租賃」分類為經營租賃的租賃確認租賃負債。於2020年3月31日，本集團已就倉庫、辦公室、店舖及汽車訂立多份租賃。

LIQUIDITY AND FINANCIAL RESOURCES

As at 31 March 2020, the Group had total assets of approximately HK\$129.1 million, which is financed by total liabilities and Shareholders' equity of approximately HK\$73.6 million and HK\$55.5 million, respectively. The Group's current ratio at 31 March 2020 was approximately 1.8 compared to approximately 3.1 at 31 March 2019.

Gearing ratio

The gearing ratio of the Group as at 31 March 2020 was approximately 46.7% while as at 31 March 2019 was approximately 3.2%. The gearing ratio increased significantly as a result of the increased bank borrowings and the adoption of HKFRS 16 during FY2020.

The gearing ratio is calculated based on the total interest-bearing borrowings and lease/finance lease liabilities divided by total equity at each reporting date.

Capital expenditure

Total capital expenditure for FY2020 was approximately HK\$0.6 million, which was mainly used for the purchase of furniture and fixtures and leasehold improvements.

Contingent liabilities

As at 31 March 2020, there were no significant contingent liabilities for the Group.

Commitments

As at 31 March 2020, the Group has no operating lease commitments (2019: HK\$13.7 million).

As at 31 March 2020, there were no capital commitments of the Group related to purchase of property, plant and equipment (2019: Nil).

Charges on Group assets

As at 31 March 2020, right of use assets with net book value of approximately HK\$20.5 million were held under lease arrangements (2019: motor vehicles with net book value of approximately HK\$1.1 million were held under finance leases).

Segment information

Segment information is presented for the Group as disclosed on Note 4 to the consolidated financial statements.

2020財政年度的資本開支總額約為0.6百萬港元，主要用於購買傢俱及固定裝置以及租賃物業裝修。

CAPITAL STRUCTURE

The shares of the Company were successfully listed on GEM of the Stock Exchange on 25 January 2018. There has been no change in the capital structure of the Group since then. The share capital of the Group only comprises of ordinary shares.

As at 31 March 2020, the Company's issued share capital was HK\$15,840,000 and the number of its issued ordinary shares was 1,584,000,000 of HK\$0.01 each.

DIVIDENDS

The Board does not recommend the payment of a final dividend for FY2020 (FY2019: Nil).

SIGNIFICANT INVESTMENTS, MATERIAL ACQUISITIONS OR DISPOSALS OF SUBSIDIARIES AND ASSOCIATED COMPANIES

There was no significant investments, material acquisitions or disposals of subsidiaries and associated companies during FY2020.

FUTURE PLAN FOR MATERIAL INVESTMENTS AND CAPITAL ASSETS

Save as disclosed herein, the Group did not have any concrete plan for material investments or capital assets for the coming year.

PRINCIPAL RISKS AND UNCERTAINTIES

In the course of conducting business, our Group is exposed to various types of risks, including operational risks, credit risks, liquidity risk and interest rate risks. Our Group has established a set of risk management policies and measures to identify, evaluate and manage risks arising from our operations.

The followings set out some of the primary operational risks our Group faces that may materially and adversely affect our Group's business, financial condition and results of operation and our risk management measures:

1. Risk of remaining competitive in a highly fragmented and competitive market

The lifestyle furniture and home furnishing market is highly fragmented and competitive with low barriers to entry, and there are no specific market leaders. Our competitors may have greater financial, marketing, personnel and other relevant resources compared to us. In particular, the pricing strategies implemented by our competitors may affect the pricing of our products. If our competitors significantly reduce their product prices, we may have to reduce our selling prices or engage in further marketing to remain competitive. This would likely reduce our revenue and profitability.

資本架構

主要風險及不確定因素

在進行業務的過程中，本集團會面對各種風險，包括經營風險、信貸風險、流動性風險及利率風險。本集團已建立一套風險管理政策及措施，以識別、評估及管理因營運而產生的風險。

下文載列本集團面對而可能對本集團業務、財務狀況及經營業績造成重大不利影響的部分主要經營風險及風險管理措施：

1. 於高度分散且競爭激烈的市場保持競爭力的風險

生活時尚傢俱及家飾市場高度分散且競爭激烈，進入門檻低，市場中並無明確的市場領先者。與我們相比，我們的競爭對手可能擁有更多財務、市場推廣、人員及其他相關資源。尤其是，競爭對手實行的定價策略或會影響我們產品的定價。倘競爭對手大幅降低其產品價格，則我們可能不得不降低售價或進行進一步市場推廣以保持競爭力，而這可能會削減我們的收益及盈利能力。

2. Risk of dependent on the shift in customer's tastes and preferences

Due to the nature of the furniture retail industry, the customers generally purchase our products on an infrequent basis. Apart from the PRC distributor, there is no purchase commitments from our customers and there is no obligation for them to purchase any products from us in the future. There is a risk that we may not be able to attract new customers or existing customers to purchase our products if we fail to successfully track changing customers tastes and preferences and market trends.

3. Risk of failure in expanding sales network to new locations in Hong Kong or through online platform

It may take longer than expected for the new stores to reach breakeven or achieve investment payback, if at all. There is no guarantee that we will execute our expansion plans according to business strategies in the prospectus of the Company dated 12 January 2018 (the "Prospectus") successfully, or that we will be able to attract more customers from our expansion. If we fail to execute our expansion plans, our operations and results of operations will be materially and adversely affected.

4. Risk of not entering into any long-term contracts with our major suppliers

We rely on our major suppliers to supply products to us and we do not have any long-term contracts with these suppliers. As such, we are exposed to the risks such as unexpected price fluctuation, shortage of supply of products, failure to meet our agreed delivery time and refusal to supply products. In such case, we would have to look for alternative suppliers and we may not be able to do so in a timely manner and/or at a similar price with comparable quality. Further, if we fail to replace our major suppliers when our business relationship is disrupted or terminated, we may face a shortage in supply of certain products and our business and results of operations may be adversely affected as a result.

The Group is also exposed to a variety of financial risks which comprise credit risk, liquidity risk and interest rate risk.

2. 倚賴客戶品味及喜好轉變的風險

由於傢俱零售行業的性質使然，客戶一般不經常購買我們的產品。除中國分銷商以外，我們並無客戶的購買承諾且彼等並無責任日後向我們購買任何產品。倘我們未能成功緊跟不斷變化的客戶品味及喜好以及市場趨勢，則面對我們可能無法吸引新客戶或現有客戶購買產品的風險。

3. 無法將銷售網絡擴大至香港的新地點或透過網上平台擴大銷售網絡的風險

新店要達到收支平衡或實現投資回本可能需要比預期更長的時間或根本無法達到收支平衡或實現投資回本。概不保證我們將根據本公司日期為2018年1月12日的招股章程（「招股章程」）內的業務策略成功執行擴張計劃，或我們將能透過擴張吸引更多客戶。倘我們未能執行擴張計劃，則我們的營運及經營業績將受到重大不利影響。

4. 並無與主要供應商訂立任何長期合約的風險

我們倚賴主要供應商向我們供應產品，且並未與該等供應商訂立任何長期合約。因此，我們面對意外價格波動、產品供應不足、未能滿足約定交付時間及拒絕供應產品等風險。在此情況下，我們須尋找替代供應商，而我們可能無法及時及／或按相若價格找到品質相若的替代供應商。此外，當我們的業務關係中斷或終止時，倘我們未能替換主要供應商，則我們可能面對若干產品供應不足的情況。因此，我們的業務及經營業績或會受到不利影響。

本集團亦面對各種財務風險，包括信貸風險、流動性風險及利率風險。

FOREIGN CURRENCY RISK

As our Group's revenue and expenses are mainly denominated in HK\$ and most of our Group's assets and liabilities are denominated in HK\$, which is our functional currency, except for certain overseas purchases, bank balances, bank borrowings which are denominated in Euro or USD. During FY2020, the Group has net exchange loss of approximately HK\$0.8 million (FY2019: approximately HK\$0.1 million).

EMPLOYEES AND REMUNERATION POLICY

As at 31 March 2020, the Group had a total of 73 employees. Total staff costs, (including Directors' emoluments) of approximately HK\$21.9 million for FY2020 (FY2019: approximately HK\$24.1 million).

The Group's remuneration policies were determined with reference to the performance, qualification and experience of individual employee, as well as the results of the Group and the market conditions. We have also adopted the share option scheme which is designed to provide incentives and rewards to our employees.

SIGNIFICANT INVESTMENTS HELD

Except for investments in subsidiaries, the Group did not hold any significant investments during FY2020.

FUTURE PROSPECTS

This forthcoming financial year will continue to be challenging as retail market conditions remain competitive and weak consumer confidence and spending in Hong Kong prevails while impacted by the outbreak of the COVID-19. These factors will continue to impact our performance adversely for the forthcoming year. In addition to running our three TREE retail stores in Hong Kong, the management recognises the need to expand our revenue streams. The Group has already seen growth in additional opportunities in styling and consulting services and will continue to focus on the development of this area of the business. The Group has also launched our e-commerce store which enables the opportunity to auto-generate sales 24/7, in addition to establishing a new furniture rental business, with the view to becoming a key player in this sector. Both of these ventures are important developments, and investments, by which the business can enjoy sustainable growth.

The Group has also strengthened its income base and expended the products offered within its portfolio by providing furniture agency services for furniture imported from Italy, primarily to customers in the PRC. The Group continues to look for ways to provide comprehensive services to customers in Hong Kong and the PRC.

僱員及薪酬政策

於2020年3月31日，本集團共有73名僱員。2020財政年度的員工成本總額(包括董事酬金)約為21.9百萬港元(2019財政年度：約24.1百萬港元)。

本集團的薪酬政策乃參照個別僱員表現、資歷及經驗以及本集團業績及市況而釐定。我們亦已採納旨在為僱員提供獎勵及報酬的購股權計劃。

所持重大投資

除於附屬公司投資外，於2020財政年度，本集團並無持有任何重大投資。

未來前景

由於零售市況仍競爭激烈，香港消費者信心及開支疲弱，加上COVID-19爆發的影響，故未來財政年度將繼續充滿挑戰。此等因素將於未來一年繼續影響我們的表現。除在香港經營三家TREE零售店外，管理層瞭解到擴大我們收益流的需要。本集團在設計及諮詢服務方面已看到更多增長機遇，並將繼續專注於該業務領域的發展。本集團亦已推出我們的電子商務店，使其有機會全天候自動產生銷售，除建立新的傢俱租賃業務外，我們期望成為該行業的主要參與者。該兩項風險投資均為重要的發展及投資，藉此業務可取得可持續增長。

本集團亦通過為從意大利進口傢俱(主要向中國客戶)提供傢俱代理服務，加強收入基礎，並擴大產品組合。本集團繼續尋找為香港及中國客戶提供全面服務的途徑。

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論與分析

USE OF PROCEEDS

The net proceeds from the Listing in January 2018, after deducting the underwriting fees, the Stock Exchange trading fee and the Securities and Futures Commission of Hong Kong (the “SFC”) transaction levy and other listing-related expenses in connection with the Share Offer, were approximately HK\$20.3 million.

The actual net proceeds from the issue of new shares of the Company under the Share Offer was different from the estimated net proceeds of approximately HK\$22.7 million as set out in the Prospectus. The Group adjusted the use of proceeds in the same manner and in the same proportion as shown in the Prospectus, which is (i) approximately 71.5% of the total actual net proceeds, or approximately HK\$14.5 million will be used to expand our sales network, (ii) approximately 10.1% of the total actual net proceeds, or approximately HK\$2.1 million, will be used to promote and strengthen brand image and recognition, (iii) approximately 9.1% of the total actual net proceeds, or approximately HK\$1.8 million, will be used to enhance our styling and consulting services and distribution sales, and (iv) approximately 9.3% of the total actual net proceeds, or approximately HK\$1.9 million, will be used to enhance operational efficiencies.

During the period from the Listing Date to 31 March 2020, the Group has utilised HK\$12.3 million, or 60.6% of the actual net proceeds from the Listing for the staff costs of an interior designer; the establishment of an e-commerce platform; the enhancement of the POS system; and for the leasehold improvement, marketing, deposit and rental of the Yuen Long store opened in May 2018.

As disclosed in our Group’s announcement dated 19 June 2020, the Board resolved to change the use of unutilised net proceeds. The revised proposed change of use of the unutilised net proceeds would be for the settlement of the future consideration payable in relation to the acquisition HK Italiving, which was completed on 31 December 2018.

所得款項用途

於2018年1月上市的所得款項淨額(經扣除包銷費、聯交所交易費及香港證券及期貨事務監察委員會(「證監會」)交易徵費以及有關股份發售的其他上市相關開支後)約為20.3百萬港元。

本公司根據股份發售發行新股份的實際所得款項淨額與招股章程所載的估計所得款項淨額約22.7百萬港元有所不同。本集團已按招股章程所示方式及比例調整所得款項用途，即(i)全部實際所得款項淨額中約71.5%或約14.5百萬港元將用於擴大我們的銷售網絡；(ii)全部實際所得款項淨額中約10.1%或約2.1百萬港元將用於提升並加強品牌形象及知名度；(iii)全部實際所得款項淨額中約9.1%或約1.8百萬港元將用於改善我們的設計及諮詢服務以及分銷銷售工作；及(iv)全部實際所得款項淨額中約9.3%或約1.9百萬港元將用於提升營運效率。

於上市日期至2020年3月31日期間，本集團已動用上市實際所得款項淨額中12.3百萬港元或60.6%，用於僱用一名室內設計師的員工成本；建立電子商務平台；提升銷售點系統；以及於2018年5月開業的元朗店的租賃物業裝修、市場推廣、按金及租金。

誠如本集團日期為2020年6月19日的公告所披露，董事會議決更改未動用所得款項淨額的用途。經修訂建議更改未動用所得款項淨額用途為就收購香港意享世家(已於2018年12月31日完成)支付未來應付代價。

To enable the Directors to be properly briefed on issues arising at the Board meetings and to make informed decisions, an agenda and the accompanying Board papers together with all appropriate and relevant information in relation to the matters of the meetings are sent to all Directors at least three days before the intended date of each regular Board meeting and three days or such other period as agreed before each other Board meeting.

The Company Secretary is responsible for keeping all Board meetings' minutes. Draft and final versions of the minutes will be circulated to the Directors for comments and record within a reasonable time after each meeting and the final version is open for the Directors' inspection. According to the GEM Listing Rules, any Directors and their associates (as defined in the GEM Listing Rules) with a material interest in the transactions to be discussed at the Board meetings will abstain from voting on resolutions approving such transactions and are not counted in the quorum of the meetings.

TERMS OF APPOINTMENT AND RE-ELECTION OF DIRECTORS

Each of our Executive Directors has entered into a service contract with our Company on 25 January 2018 and we signed letters of appointment with each of our Independent Non-Executive Directors on the same day. The service contracts with our Executive Directors are for an initial term of three years commencing from the listing date on 25 January 2018 (the “**Listing Date**”) and can be terminated by either party giving not less than three months’ notice in writing. The letter of appointment with each of our Independent Non-Executive Directors are for an initial term until 24 January 2021 commencing from 25 January 2018 and can be terminated by either party giving not less than three months’ notice in writing.

The service contracts and letters of appointment are subject to termination in accordance with their respective terms. The service contracts can be renewed in accordance with our articles of association (the “**Articles**”) and the applicable GEM Listing Rules.

According to our Articles, one-third of the Directors for the time being shall retire from office by rotation at every AGM of the Company, provided that every Director shall retire from office by rotation and are subject to re-election at AGM at least once every three years. Directors who are appointed to fill casual vacancies shall hold office only until the next following general meeting after their appointment, and are subject to re-election by Shareholders of the Company.

The Company has taken out directors and officers liability insurance to cover liabilities arising from legal action against the Directors.

BOARD DIVERSITY POLICY

The Board has adopted a policy of the Board diversity (the “**Board Diversity Policy**”) which sets out the approach to achieve a sustainable and balanced development of the Company and also enhance the quality of performance of the Company.

The Company recognises and embraces the benefits of a diversity of Board members. It endeavours to ensure that the Board has a balance of skills, experience and diversity of perspectives that are required to support the execution of its business strategy. All Board appointments will continue to be made on a merit basis with due regard for the benefits of diversity of the Board members. Selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills and knowledge.

CHAIRMAN AND CHIEF EXECUTIVE

Pursuant to the Code Provision A.2.1 of the CG Code, the roles of the chairman and the chief executive should be separate and performed by different individuals.

Mr. Tong Tang Joseph currently assumes the role of both chairman of the Company and chief executive of the Company. In view that Mr. Tong has been assuming day-to-day responsibilities in operating and managing our Group and the rapid development of our Group, the Board believes that with the support of Mr. Tong's extensive experience and knowledge in the business of the Group, vesting the roles of both Chairman and chief executive officer of our Company in Mr. Tong strengthens the solid and consistent leadership and thereby allows for efficient business planning and decision which is in the best interest to our Group. Mr. Tong delegates the role and responsibilities including operations, management, business development and strategy planning of the Group to other Executive Directors. The Board will review the need of appointing suitable candidate to assume the role of chief executive when necessary.

INDEPENDENT NON-EXECUTIVE DIRECTORS

Each of our Independent Non-Executive Directors has entered into a letter of appointment with our Company for a term of three years commencing from the Listing Date, which may terminated by not less than three months' notice in writing served by either party on the other. Each of the Independent Non-Executive Directors is subject to retirement by rotation and re-election at AGM in accordance with the Articles.

BOARD COMMITTEES

The Board has established three Board committees, namely the Audit Committee, the Remuneration Committee and the Nomination Committee to oversee particular aspects of the Company's affairs. The Board committees are provided with sufficient resources to discharge their duties.

All Board committees are provided with sufficient resources to perform their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstance, at the Company's expense.

The Board is responsible for performing the corporate governance duties set out in the CG Code which included developing and reviewing the Company's policies and practices on corporate governance, training and continuous professional development of Directors, and reviewing the Company's compliance with the code provision in the CG Code and disclosures in this report.

Audit Committee

We established our Audit Committee with written terms of reference in compliance with Rule 5.28 of the GEM Listing Rules and paragraph C3.2 and C3.3 of the CG Code Practices pursuant to a resolution of our Directors passed on 5 January 2018. The terms of reference were amended and restated on 4 January 2019, with respect to the update of the GEM Listing Rules. The primary duties of our Audit Committee are, among other things, to make recommendations to our Board on the appointment, reappointment and removal of external auditor, review the financial statements and provide advice in respect of financial reporting, oversee our financial reporting process, internal control, risk management systems and audit process, and perform other duties and responsibilities assigned by our Board.

At present, our Audit Committee comprises Mr. Yeung Man Chung Charles, Mr. Tsang Wai Yin and Mr. Sit Hoi Wah Kenneth, all being Independent Non-Executive Directors. Mr. Yeung Man Chung Charles is the Chairman of our Audit Committee.

During FY2020, the Audit Committee held four meetings, at which the Audit Committee has reviewed and discussed the Company's consolidated financial results, including the accounting principles and practice adopted by the Group, the Company's compliance with the CG Code, the effectiveness of the Group's internal control and risk management systems and the Group's internal audit function and recommended to the Board for consideration the same and the re-appointment of Grant Thornton Hong Kong Limited ("**Grant Thornton**") as the Company's external independent auditor at the forthcoming AGM.

COMPANY SECRETARY

The primary duties of the Company Secretary include, but are not limited to, the following: (i) to ensure the Board procedures are followed and that the activities of the Board are carried out efficiently and effectively; (ii) to assist the Chairman to prepare agendas and Board papers for meetings and disseminate such documents to the Directors and Board committees in a timely manner; (iii) to timely disseminate announcements and information relating to the Group; and (iv) to maintain formal minutes of the Board meetings and other Board committee meetings.

During FY2020, the Company Secretary of the Company had confirmed that he had taken no less than 15 hours of relevant professional training in accordance with Rule 5.15 of the GEM Listing Rules.

SHAREHOLDERS' RIGHTS

The general meetings of the Company provide an opportunity for communication between the Shareholders and the Board. An AGM of the Company shall be held in each year and at the place as may be determined by the Board. Each general meeting, other than an AGM, shall be called an extraordinary general meeting (the “EGM”).

Procedures for Shareholders to convene an extraordinary general meeting

Pursuant to the Article 64 of the Articles, EGMs shall be convened on the requisition of one or more Shareholders holding, at the date of deposit of the requisition, not less than one tenth of the paid up capital of the Company having the right of voting at general meetings. Such requisition shall be made in writing to the Board or the Secretary for the purpose of requiring an EGM to be called by the Board for the transaction of any business specified in such requisition. Such meeting shall be held within two months after the deposit of such requisition. If within 21 days of such deposit, the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

The requisition must state clearly the name of the Shareholder(s) concerned, his/her/their shareholding in the Company, the reason(s) to convene the EGM and the proposed agenda.

Procedures for Shareholders to send enquires to the Board

Shareholders may send their written enquiries and concerns to the Board by addressing them to the principal place of business of the Company in Hong Kong.

The Company's dividend policy aims to allow Shareholders to participate in the Company's profit and for the Company to retain adequate reserves for its future growth. In proposing any dividend, the Company would consider various factors including but not limited to (i) the Group's financial results, (ii) the financial condition of the Group, (iii) the Group's working capital requirements, capital expenditure requirements and future expansion plans, (iv) the Group's liquidity position, (v) economic conditions and other internal or external factors that may have an impact on the business or financial performance and position of the Group and (vi) any other factors that our Board may consider appropriate.

There is no assurance that dividends will be paid in any particular amount for any given period.

According to the Company's Articles and the Companies Ordinance, dividends must be paid in cash or be satisfied wholly or partly in the form of allotment of shares of the Company. The Board may consider the issuance of bonus shares on a basis permitted by the applicable laws and regulations.

The Board will continually review the dividend policy and reserves the right in its sole and absolute discretion to update, amend, modify and/or cancel the dividend policy at any time.

SCOPE OF THE REPORT

The Environmental, Social and Governance (“ESG”) Report has been prepared in accordance with the “Environmental, Social and Governance Reporting Guide” in Appendix 20 to the GEM Listing Rules of the Stock Exchange of Hong Kong Limited (the “Stock Exchange”). The ESG Report summarizes our ESG performance, and covers our management policies, mechanisms and measures in place during FY2020 with respect to environmental protection, emission reduction, safe workplace, personal training and drills, supply chain management and community investment and engagement. Focuses are placed on certain aspects closely relevant to our Shareholders and other stakeholders, and our full commitment to sustainable development of the Group as a whole.

ENVIRONMENTAL, SOCIAL AND GOVERNANCE REPORT

Our Group believe a sustainable business should have a positive social, economic and environmental impact to the local community in which we operate.

Section A: Environmental

Reducing carbon footprint of our business operations to protect our environment is the core values of our Group. Our dedicated effort was proven effective as there was no material issue of non-compliance with relevant laws and regulations related to the environment for FY2020.

Emissions

Our business is closely related to the environment. Environmental protection and emission reduction are always the top priority at the Group. The emissions data, which includes both the air emissions and greenhouse gas emissions, is measured for better understanding of our environmental impacts and taking meaningful decisions in the future. To present a comprehensive emission overview, we compared the emission figures and emission intensity in FY2019 to those of FY2020.

報告範圍

環境、社會及管治報告已根據香港聯合交易所有限公司(「聯交所」)的GEM上市規則附錄二十「環境、社會及管治報告指引」編製。本環境、社會及管治報告概述我們的環境、社會及管治表現，並涵蓋我們於2020財政年度內在環境保護、減排、工作環境安全、人才培訓及訓練、供應鏈管理以及社區投資與參與等方面的管理政策、機制及措施。有關報告主要集中匯報對我們的股東及其他權益人有切身關係的若干層面，致力在本集團整體營運全面履行可持續發展。

環境、社會及管治報告

本集團認為，可持續發展的企業應對我們業務所在地的社區產生積極的社會、經濟及環境影響。

A部分：環境

致力減少業務運營的碳足跡，以保護我們的環境，是本集團的核心價值。於2020財政年度並無發現涉及環境相關法律及規例的重大不合規情況，證明本集團所付出的努力並無白費。

排放

我們的業務與環境息息相關。環保與減排一直是本集團的首要任務。為更了解本集團對環境的影響，以便日後可作出有意義的決定，本集團已計量排放物數據，當中包括廢氣排放及溫室氣體排放。為呈列全面的排放概覽，我們亦已比較2019財政年度與2020財政年度的排放數據及排放密度。

Air Emissions

The Group's emissions of air pollutants, which include nitrogen oxides ("NO_x"), sulphur oxides ("SO_x") and respiratory suspended particles ("RSP"), are mainly generated by usage of vehicles for delivery. In measurable terms, our operations produced approximately 212 kg of air emissions in FY2020¹ (FY2019: 220 kg), which shows a reduction of approximately 4% compared with FY2019. The corresponding air emission intensity² of FY2020 was approximately 3 kg per employee (FY2019: 3 kg per employee), which approximately remained constant compared with FY2019. The overall decrease in air emissions was mainly attributed to the shrink in the Group's sales and the corresponding drop in shipping and delivery services, caused by low consumer sentiment due to the ongoing social movement in Hong Kong, as well as the novel coronavirus situation started in early 2020. Meanwhile, the reduction was partially offset by the operation of new storage room in Ap Lei Chau. Although the reduction in air emissions in FY2020 was primarily a result of external factors, the Group has put continuous effort in cutting down its emissions, such as delivering its products in bulk, so as to better utilize the capacity of vehicles and reduce unnecessary emissions.

Greenhouse Gas Emissions

Global warming is mainly attributable to greenhouse gas (GHG) emissions. In an effort to reduce GHG emissions and carbon footprint, we embrace green practices in our day-to-day business operations, contributing to environmental conservation, natural resource preservation and waste reduction.

As an environmentally-friendly enterprise, we uphold the 3Rs principle, namely reduce, reuse and recycle. In our daily operation, we promote the reduction of consumptions in paper, water resources, electricity and stationery. Employees are encouraged to adopt double-sided printing, while single-side-printed paper is collected for reuse. To further reduce the production of paper waste, we have been engaging an external recycling company since January 2018 to collect paper waste from our office for recycling purpose. Waste sorting is also performed at our office and shops to facilitate the recycling program.

廢氣排放

本集團排放的空氣污染物包括氮氧化物 ("NO_x")、硫氧化物 ("SO_x") 及可吸入懸浮粒子 ("RSP")，主要因使用汽車交付貨物而產生。從可計量角度來看，我們的業務於2020財政年度產生約212公斤廢氣排放¹，與2019財政年度的約220公斤廢氣排放相比減少約4%。2020財政年度按每名僱員計算的廢氣排放密度²約為3公斤，與2019財政年度的3公斤相比大致持平。廢氣排放整體有所減少主要源於香港社會運動持續，加上2020年初爆發新型冠狀病毒，消費市道低迷，導致本集團的銷售額下跌，運輸及送貨服務相應減少。與此同時，有關減幅部分為鴨洲新貨倉投入運作所抵銷。儘管2020財政年度的廢氣排放減幅主要源於外部因素，惟本集團亦已不斷努力削減排放，例如大批量送貨，從而善用車輛載貨量，減少不必要的排放。

溫室氣體排放

溫室氣體排放乃全球暖化的罪魁禍首。為減少溫室氣體排放及碳足跡，我們在日常業務運作中融入環保措施，以保護環境、珍惜自然資源及減廢。

身為環保企業，我們恪守3R原則，即減少(Reduce)、重用(Reuse)及回收(Recycle)。在日常運作中，我們推動減少紙張、水資源、電力及文具消耗，鼓勵僱員使用雙面打印，而單面打印紙會被收集重用。為進一步減少產生廢紙，我們自2018年1月起聘請外部回收公司收集辦公室廢紙，以作回收。我們的辦公室及店舖亦進行廢物分類，以推動回收計劃。

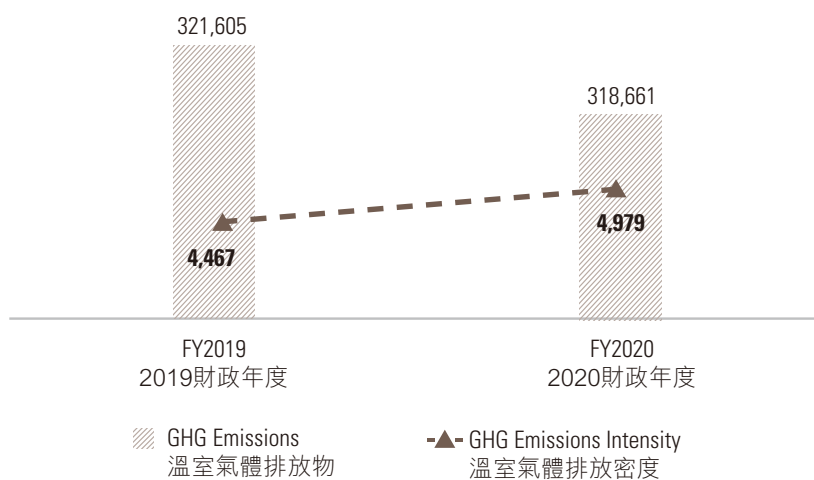

With the 3Rs principle, we are pleased to report that our effort in continuous monitoring and control of GHG emissions paid off. During FY2020, our operations produced approximately 319 tonnes of carbon dioxide equivalent (FY2019: 322 tonnes³), with the corresponding emission intensity amounted to approximately 5.0 tonnes of carbon dioxide per employee (FY2019: 4.5 tonnes per employee). While our GHG emission has reduced by 1% compared with FY2019, our corresponding carbon intensity has increased by approximately 11% mainly due to the reduction in number of employees this year. In view of the 1% slightly difference, we successfully controlled the GHG emissions to remain constant when compared to FY2019.

根據3R原則，我們欣然呈報我們在持續監測及控制溫室氣體排放方面的努力已取得成效。於2020財政年度，我們的業務產生約319噸(2019財政年度：322噸³)二氧化碳當量，按每名僱員計算的排放密度約為5.0噸(2019財政年度：4.5噸)二氧化碳。雖然我們的溫室氣體排放與2019財政年度相比減少1%，惟相應的碳密度卻上升約11%，主要是由於年內僱員人數減少所致。鑑於僅有1%的些微差距，我們成功將溫室氣體排放控制於與2019財政年度一致的水平。

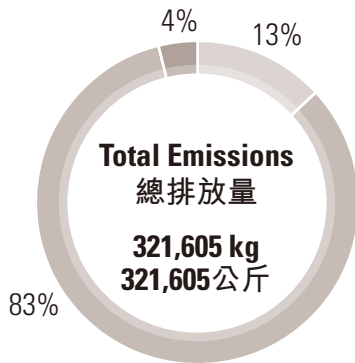

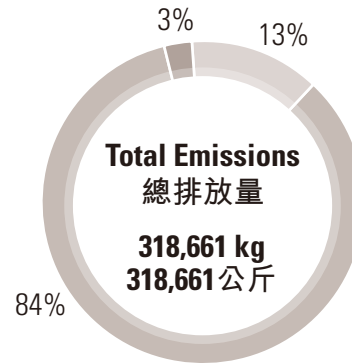

We experienced reduction of approximately 4% and 19% in category 1 and 3 emissions respectively; while a slightly increase of less than 1% in category 2 emission when compared to FY2019. In total, the GHG emissions for FY2020 has been reduced for approximately 1%. In view of the 1% slightly difference, we successfully controlled the GHG emissions to remain constant when compared to FY2019.

We have continued to implement a range of measures to promote electricity-saving in our office, retail stores and warehouse, including the introduction of energy-saving options (e.g. compact fluorescent lamps) and display of reminders to employees to switch of idle electronic appliances.

Waste Management

The principal business activities of the Group include (i) sales and distribution of furniture and home accessories; (ii) consignment sales (being products consigned from Independent Third Parties for sale in the Group's retail stores); (iii) distribution and licencing of the Group's intellectual property rights; (iv) provision of styling and consulting services; and (v) operation of TREE Café in the Flagship Store. The business operations of the Group produce no hazardous waste, e.g. chemical wastes, clinical wastes and hazardous chemicals.

One of the major non-hazardous waste produced by the Group in FY2020 was paper waste, which amounted to approximately 721 kg (FY2019: 733 kg), with a corresponding intensity of 11 kg per employee (FY2019: 10 kg per employee). With our continuous effort in waste reduction, the total paper waste produced decreased by approximately 2%, while the corresponding intensity was approximately the same as FY2019.

As logging is involved in the paper production process, it provokes both direct and indirect negative impacts on the environment. TREE Limited have implemented a range of measures to reduce paper waste, such as encouraging double-sided printing, as well as collecting single-side-printed paper for re-use. On top of that, an external recycling company has been engaged since January 2018 to collect part of our paper waste for recycling purpose, so as to further cut down our paper waste. Recycling performance report is provided by the service provider, detailing amount of paper waste collected by month and the total carbon emissions avoided through recycling. This helps us to further monitor our paper consumption and motivate our employees to cut down the consumption of resources. We will continue to monitor and reduce our paper consumption in the future in a bid to lower our carbon emissions.

與2019財政年度相比，類別1及3的排放分別減少約4%及19%，而類別2的排放則微升少於1%。2020財政年度的溫室氣體排放總量減少約1%。鑑於僅有1%的些微差距，我們成功將溫室氣體排放控制於與2019財政年度一致的水平。

我們持續推行一系列措施，促進辦公室、零售店及倉庫節約用電，包括選用節能電器（例如慳電膽），並張貼告示提醒僱員關閉閒置電器。

廢棄物管理

本集團的主要業務活動包括(i)銷售及分銷傢俱及家居配飾；(ii)寄售（由獨立第三方委託在本集團零售店寄售產品）；(iii)分銷及許可使用本集團的知識產權；(iv)提供設計及諮詢服務；及(v)於旗艦店內經營TREE Café。本集團經營業務時，不會產生化學廢料、醫療廢物及有害化學品等有害廢棄物。

本集團於2020財政年度產生的主要無害廢棄物之一是廢紙，約為721公斤（2019財政年度：733公斤），按每名僱員計算的密度為11公斤（2019財政年度：10公斤）。通過不斷努力減廢，我們產生的廢紙總量減少約2%，而密度則與2019財政年度大致相同。

由於造紙涉及伐木，故同時會對環境造成直接及間接影響。大樹有限公司已實施一系列措施減少廢紙，例如鼓勵雙面打印，而單面打印紙會被收集重用。除此之外，為進一步減少廢紙，我們自2018年1月起聘請外部回收公司收集部分廢紙，以作回收。該名服務供應商已提供回收績效報告，詳列每月廢紙收集量及回收所減省的碳排放總量。此舉有助我們進一步監察用紙量，並激勵僱員減少耗用資源。我們日後將繼續監察並減少紙張消耗，以期降低我們的碳排放。

While plastic and metal waste only accounted for a minority of non-hazardous waste generated by the Group, they are also collected by the recycling bins in our office and TREE Café, so as to further minimize the waste directly disposed of in landfills. In FY2020, approximately 60 kg of plastic and 77 kg of metals were collected and recycled⁷ by the service provider. We will continue to advocate the importance of recycling among our employees and customers, and put more effort into waste reduction.

Use of Resources

The Group pledges to become an environmentally-friendly and sustainable enterprise. We understand that while the use of resources has significant impacts on resources preservation, it also involves indirect emissions to the environment. As such, to reduce carbon emission and footprint, we have undertaken a range of carbon reduction measures in our daily operations. Reducing, which is one of the 3Rs principles, is promoted and communicated to our employees for better use of resources.

Energy Consumption

The total energy consumption for FY2020 was approximately 337,561 kWh (FY2019: 336,894 kWh), which saw a slight increase of approximately 0.2% compared with FY2019. The corresponding electricity consumption intensity was 5,274 kWh per employee for FY2020 (FY2019: 4,679 kWh per employee), with a increase of approximately 13% compared with FY2019, which was mainly a result of the decrease in number of employees by 11%. In general, the electricity consumption remained constant in FY2020.

To reduce unnecessary electricity consumption, the Group encourages every employee to switch off all idle appliances and ensure that all electronic appliances had been switched off before they left the office. Apart from this, the Group will purchase energy-efficient electronic appliances in the future, as well as upgrading current ones for energy-efficient alternatives in long run. We promise to put in more efforts in the aspect of energy conservation to further reduce our carbon footprint.

雖然廢塑膠及金屬僅佔本集團所產生無害廢棄物的一小部分，但我們的辦公室及TREE Café亦設有回收箱收集廢塑膠及金屬，從而進一步減少直接於堆填區處置的廢棄物。於2020財政年度，該服務供應商已收集並回收約60公斤塑膠及77公斤金屬⁷。我們將繼續在僱員及客戶之間提倡回收的重要性，並加大力度減廢。

資源使用

本集團銳意成為一家可持續的環保企業。我們明白資源使用與珍惜資源唇齒相依，亦造成間接環境排放。因此，我們於日常運作中採取一系列減碳措施，以減少碳排放及足跡。為更妥善使用資源，我們向僱員提倡及灌輸3R原則中的減少(Reduce)。

耗能

2020財政年度的能源總耗量約為337,561千瓦時，與2019財政年度的336,894千瓦時相比微升約0.2%。2020財政年度按每名僱員計算的耗電密度為5,274千瓦時，與2019財政年度的4,679千瓦時相比上升約13%，主要是由於僱員人數減少11%所致。整體而言，2020財政年度的耗電量保持穩定。

為減省不必要的用電，本集團鼓勵全體僱員關閉所有閒置電器，並確保於離開辦公室前關閉所有電器。除此之外，本集團日後亦將選購節能電器，長遠亦會將現有電器升級為節能型號。我們承諾將加倍努力節約能源，以進一步減少碳足跡。

Water Consumption

Water is one of the most precious natural resources. High consumption of water could undermine the water resources available. In the meantime, processing of freshwater and sewage require electricity, indirectly resulting in more carbon emissions. As TREE Café is one of the major businesses of the Group, it places much emphasis on conservation of water resources. Café staff are educated not to keep the tap open when doing the washing. In FY2020, the Group's water consumption was approximately 259⁸ cubic meters (FY2019: 333 cubic meters), showing a reduction of approximately 22% compared with FY2019. The corresponding water consumption intensity was approximately 4 cubic meters per employee (FY2019: 5 cubic meters per employee), with a significant decrease of approximately 20% compared with FY2019. As our water is sourced from the Water Supply Department, there was no water supply issue identified in FY2020. Effective use of water can significantly whittle down the indirect consumption of electricity during water processing. The Group encourages its staff to save and use less water by promoting water conservation among its staff. We will also continue to monitor our use of water closely, so as to minimize the corresponding carbon footprint.

Paper Usage

To advocate a paperless work environment, we encourage our employees to use electronic systems and documents instead of printed documents. Effective use of paper and double-sided printing have been promoted and communicated to our staff, while single-sided-printed paper is collected for reuse. The Group consumed approximately 721 kg of paper in FY2020 (FY2019: 733 kg), which has decreased by approximately 2% compared with that of FY2019. The corresponding consumption intensity was approximately 11 kg per employee this Year (FY2019: 10 kg per employee).

Packaging Materials

Generally, no packaging materials are used for the furniture and home accessories sold at shops. There are only small amount of plastic films used during the delivery process. However, the usage of packaging materials is hard to estimate due to the limited availability of relevant data, with the usage of packaging materials being considered as immaterial. Hence, no disclosure is made regarding the usage of packaging materials.

Shopping Bags

To further promote environmental sustainability, we promote "bring your own bag" at shops. However, in case customers do not have their own bags with them, we would provide them with tote bags, which were in 100% cotton.

耗水

水是最珍貴的天然資源之一。用水過多可影響水資源供應。與此同時，處理食水及污水亦須用電，間接造成更多碳排放。作為本集團主要業務之一，TREE Café非常重視珍惜水資源。咖啡店員工已接受培訓，在清洗餐具時不會長開水龍頭。本集團於2020財政年度的耗水量約為259⁸立方米，與2019財政年度的333立方米相比減少約22%。按每名僱員計算的耗水密度約為4立方米，與2019財政年度的5立方米相比大減約20%。由於我們的用水源自水務署，故2020財政年度在求取水源上並無任何問題。有效用水可大幅削減處理用水的間接用電。本集團在員工之間推動節水，鼓勵員工珍惜及減少用水。我們亦持續密切監察耗水，從而減少相關碳足跡。

用紙

為提倡無紙化工作環境，我們鼓勵僱員使用電子系統及文件代替印刷文件，亦向員工推廣並傳達善用紙張及雙面打印的訊息，而單面打印紙會被收集重用。本集團於2020財政年度耗用約721公斤紙張，與2019財政年度的733公斤相比減少約2%。本年度按每名僱員計算的用紙密度約為11公斤（2019財政年度：10公斤）。

包裝材料

一般而言，商店出售的傢俱及家居配飾不使用包裝材料。送貨過程僅使用少量塑膠薄膜。然而，由於可得資料有限，難以估計包裝材料的使用量，且包裝材料的使用量被視為不重大，因此並無披露包裝材料的使用情況。

購物袋

為進一步提升環境可持續性，我們在店內提倡「自備購物袋」。然而，如顧客並無自備購物袋，我們亦會提供全棉的大手提袋。

The Environment and Natural Resources

The Group believes that business development should not come at the expense of the environment. Therefore, we have been adopting environmentally-friendly practices in various aspects. For example, we invested in the acquisition of compact fluorescent lamps (CFLs) for replacing the traditional light bulbs, engaged an external recycling company to uphold recycling of wastes, and educated our employees on the importance of environmental protection.

To further contribute to environmental preservation, not only do we make continuous donations for planting trees in Indonesia, we also support Earth Hour by turning off all non-essential lights for one hour every year.

With our determination in minimizing the impacts of our operations on the environment, we have successfully achieved the following:

環境及天然資源

Our Group consisted of 73 staff members as at 31 March 2020 (31 March 2019: 72), and the composition of our staff members is set out below:

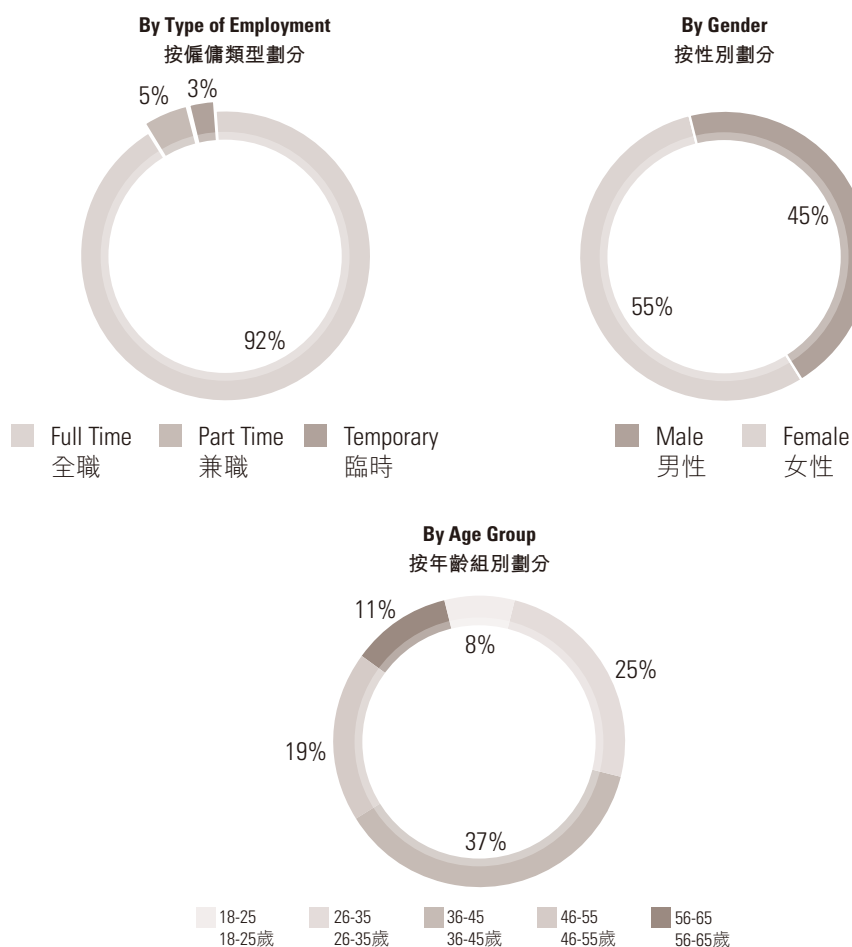

We believe that our diverse, but yet, inclusive workforce enhances our creativity, decision-making, as well as communication both among our employees and with our customers, which are essential to a successful and sustainable business.

For recruitment and dismissal process, the Group will go through the procedures according to the policies stated internally. For recruitment, equal opportunities are provided to all applicants with regards of the considerations of their experience, knowledge and skills only. The Human Resources Department will strictly process every application in terms of bringing the best inputs for the Group. For compensation and dismissal, those employees acting improperly or breaching of contract terms and code of conduct will be warned or even terminated, in terms of protecting the Group's interests. Compensations are provided to those dismissed employees when applicable according to the relevant laws and regulations.

Employee Benefits

We offer comprehensive employee benefits package to our dedicated and talented Group members. Compensations are provided fairly according to their contribution to our business with reference to market practice. We also award bonus to our employees depending on their performance, which is reviewed and assessed semi-annually, in a bid to enhance our employees' performance and address their needs in terms of career development. Through this, our employees are able to excel in their jobs and build a career with us. Promotion decisions are made by the management with careful consideration of a range of factors, ranging from the employee's job responsibilities, qualifications, relevant experience and performance, to his/her conduct and potential. Promotion and salary increment are also rewarded to all the staff who make contribution to the Group based on their semi-annual assessment.

In addition, we contribute to the Mandatory Provident Fund and acquire employees' compensation insurance with reference to the requirements of the Employment Ordinance of Hong Kong. We also provide medical fee reimbursements to our employees for the sake of reducing their financial burden.

本集團的招聘及解僱程序恪守內部既定政策。招聘方面，所有應徵者均獲得平等機會，只考慮經驗、知識及技能。人力資源部嚴謹處理所有申請，致力為本集團招攬頂尖人才。補償及解僱方面，為保障本集團的利益，行為失當或違反合約條款及行為守則的僱員將被警告甚至解僱。本集團會按照相關法律及法規向遭解僱的僱員作出補償(如適用)。

僱員福利

我們為所有勤勉盡責及才華洋溢的本集團成員提供全面的僱員福利。彼等根據各自為我們的業務所作貢獻，並參照市場慣例獲得公平補償。我們亦每半年檢討及評估僱員表現，根據有關表現向彼等發放花紅，以提升僱員表現並滿足彼等各自的事業發展需要，從而使僱員可於崗位上發揮所長並與我們一起發展事業。晉升決定乃由管理層於審慎考慮工作職責、資格、相關經驗及表現、行為及潛力等因素後作出。按照每半年的評估結果，所有曾為本集團作出貢獻的員工亦可獲得晉升及加薪以作獎勵。

此外，根據香港僱傭條例的規定，我們向強制性公積金作出供款並購買僱員補償保險。我們亦為僱員提供醫療費用報銷，以減輕其經濟負擔。

Harmonious Workspace

As an employee-oriented business, we strive for a harmonious and inclusive working environment, which is free from any harassment and discrimination. We actively promote and cultivate the understanding of Non-Discrimination, Anti-Harassment and Non-Bully Policies by communicating these with our employees through staff handbook and during team meetings. Our employees are also recruited regardless of their race, color, religion, age, gender, sexual orientation, national origin, citizenship, health condition, marital status or any other characteristics. Such equal employment opportunity policy is applicable towards our staff recruitment, training and development, recognition and reward, as well as termination and dismissal.

If our employees believe that they are experiencing discrimination and/or bullying, they are encouraged to lodge their complaint with the management, who will investigate thoroughly and confidentially. We will take this matter in a serious manner and continue to strive for a harmonious workplace for our employees.

We also recognize and support our employees' religious and cultural beliefs by extending their break time to accommodate their religious needs on specific occasions. Employees who are legally married or entering into a formal civil union / partnership are both entitled to an additional paid marriage leave. Both maternity leave and paternity leave are provided to our employees as well, so that they can strike a balance between family and work with our full support.

The Group also regularly organizes different types of employee activities such as annual dinner and Christmas celebration to foster bonding between our employees. We believe that a harmonious workplace is beneficial to our employees' well-being, which in turn enhances productivity at work and promote long term relationships between our employees and us.

Work-life Balance of Employees

The Group understands that it is necessary for its staff to take a break from time to time, which helps to facilitate the process of accomplishing the long-term goals of the Group. As such, the Group strives to provide a work-life balance to all its employees. Our employees are also entitled to a number of special leaves to meet their families' needs, including marriage leave, family bereavement leave, maternity leave and paternity leave, etc. Through these policies, a good work-life balance can be provided to our employees.

作為以僱員為本的企業，我們致力營造和諧包容的工作環境，不存在任何騷擾及歧視。我們積極通過員工手冊及小組會議向僱員傳達並促進彼等了解及認識不歧視、反騷擾及不欺凌政策。我們於招聘時亦不論種族、膚色、宗教、年齡、性別、性取向、原有國籍、公民身份、健康狀況、婚姻狀態或任何其他特徵。有關平等就業機會政策適用於員工招聘、培訓及發展、表彰及獎勵、以及解聘及解僱。

如果僱員認為彼等面對歧視及／或欺凌，我們鼓勵彼等向管理層投訴，管理層將徹底調查並保密。我們將嚴正處理有關事件，不遺餘力地為僱員營造和諧的工作環境。

我們亦尊重並支持僱員的宗教及文化信念，在特定情況下提供休息時間滿足其信仰需要。訂立法定婚姻、民事結合／伴侶關係的僱員均享有額外有薪婚假。僱員亦享有產假及侍產假，全力支持他們在家庭與工作之間取得平衡。

本集團亦定期安排不同類型的僱員活動，例如春茗和聖誕聯歡會，以加強僱員之間的情誼。我們相信，和諧的工作環境對僱員身心健康有益，能夠提升生產力，長遠促進僱員與我們之間關係。

本集團明白員工需要不時休息，此舉有助本集團達成長遠目標。因此，本集團致力於全體僱員的作息平衡。我們的僱員亦享有若干特別假期，以滿足家庭所需，包括婚假、恩恤假、產假及侍產假等。此等政策讓僱員取得良好的作息平衡。

Talent Retention

With the adoption of employee-oriented approach in our internal policies, we successfully achieved a total retention rate at approximately 91% (FY2019: 96%) in FY2020. While it has dropped slightly by 5% compared with the FY2019, our retention rate has continued to remain at a high level above 90%.

Moreover, the number of employees serving the Group for 5 to 10 years, as well as over 10 years, have increased compared with the FY2019. Our effort in building a family TREE with a strong and deep root was proven effective with a high employee retention rate, particularly those who has served our Group for a longer time. With our dedicated employees, our Group can continue to grow and prepare itself for future challenges.

Health and Safety

The Group is committed to safeguarding the safety, health and welfare of all its employees, and it aims to not only meet the minimum occupational health and safety standards required by the law, but to exceed them. To realize our commitment, we have implemented a range of policies with regard to workplace safety.

Staff handbook, which is distributed to all employees at the commencement of work, outlines safety requirements and guidelines for accident and injury management, so that our staff can familiarize themselves with the protocols. Smoking is strictly prohibited in TREE premises or any of the TREE delivery trucks. The Group has also equipped its office and shops with adequate resources for potential accidents. Sufficient fire equipment, such as fire extinguishers and fire hydrants, have been placed in both back office and shops. These equipment are under regular checks to ensure that they are in good condition.

We have two registered First Aiders working at the Flagship Store. In case of occurrence of accident or injury, they can provide emergency assistance immediately. The Group's employees' compensation insurance policies are closely monitored and regularly adjusted according to the headcounts. In case of work injury, our employees are entitled to sick leave and/or reimbursements of medical expenses by the insurance company, so that they can receive the necessary medical assistance and have adequate rest for recovery.

During FY2020, 7 employees were involved in work injuries, and a total of 907 working hours lost was recorded (FY2019: 3 employees; 79 working hours lost). Compared with the figures of the FY2019, the number of work injuries and working hours lost have both increased. In order to minimize occupational hazard and work injuries, we promise to put continuous effort into promoting our employees' awareness of workplace safety. The Group will also strengthen the education by reminding its employees the correct ways of lifting and handling materials regularly. As aforementioned, our employees are of our Group's top priority, so we pledge to monitor workplace safety closely and prevent any work injury or accident by all practicable means.

挽留人才

憑藉以僱員為本的內部政策，我們於2020財政年度成功取得約91%(2019財政年度：96%)的整體留任比率。雖然與2019財政年度相比微跌5%，但我們的留任率仍處於逾90%的高水平。

再者，効力本集團5至10年以及超過10年的僱員人數與2019財政年度相比均有所上升。僱員(尤其是於本集團年資較長者)的留任率高企，我們為TREE此一大家庭建立穩固根基的成果有目共睹。僱員全情投入工作，本集團則可繼續成長，克服未來挑戰。

健康與安全

本集團承諾保障全體僱員的安全、健康與福祉，其目標不僅是符合法律要求的最低職業健康及安全標準，而是超越該等標準。為履行承諾，我們已實施一系列工作環境安全政策。

我們於僱員入職時向彼等分發員工手冊，概述安全要求、發生意外時的指引及傷亡管理辦法，令員工熟知有關程序。TREE的場所及運輸車輛均嚴禁吸煙。本集團的辦公室和商店亦備有充足的裝備，以防隱患，而後勤辦公室及商店亦已安裝滅火器、消防喉等足夠消防設備，並定期檢查設備，保證全部狀況良好。

我們的旗艦店駐有兩名註冊急救員。一旦發生意外或傷亡事故，彼等可立即提供緊急協助。本集團密切監察並定期按照僱員人數調整僱員補償保險政策。僱員如因工作關係而受傷，可享有病假及／或獲得保險公司的醫療費用賠償，以便接受所需治療並充份休息，早日康復。

於2020財政年度，有7名僱員因工作關係而受傷，損失工作時數合共為907個小時(2019財政年度：3名僱員；損失工作時數為79小時)。與2019財政年度數字相比，工傷數目及損失工作時數均有所上升。為盡量減少職業危害及工傷事故，我們承諾竭力提高僱員的工作場所安全意識。本集團亦強化教育，定期提醒僱員起重及搬運材料的正確方法。一如上文所述，僱員乃本集團的至寶，所以我們矢志密切監察工作場所的安全，竭盡一切可行辦法避免工傷或意外發生。

The Group strictly complied with the Employees' Compensation Ordinance in Hong Kong to report any accident to the Commissioner for Labour. The Group also strictly complied with others relevant health and safety laws and regulations, such as the local fire services regulations, to provide a safe working environment to its employees by protecting them from occupational hazards.

Development and Training

We encourage our employees to continue learning and growing, as we believe that their personal career development goes hand in hand with our business development. Employees are encouraged to learn by reviewing their own performance and setting goals for themselves to achieve.

From time to time, internal training sessions are held to improve our employees' knowledge about our products, customer services, marketing and corporate management etc. This helps to equip our staff with the necessary skills for their job, as well as to keep abreast of the market trends. Prior to product promotion and new events, training sessions are organized to brief all the responsible staff the logistics, so as to ensure quality services provided to our customers.

Apart from internal training, if employees identify learning needs, they are welcomed to share their needs with their managers. Employees' initiatives to learn are highly appreciated, and we accommodate to their learning needs as far as we can. If our employees wish to take external training courses or examinations relevant to their employment, we can provide corresponding assistance in the form of flexible working hours, financial assistance and/or tuition reimbursement. We hope to support all our employees in achieving their personal career development as we value them as a family member, and this will benefit our business in the long term ultimately.

In FY2020, we achieved 27% training rate, of which middle management accounted for the majority of the trained staff. A total of 67 training hours were provided to our employees, with the average training hours received per employee amounting to approximately 1 hour. The Group will continue to invest more resources into its employees' training and development, so that its staff can grow together with the Group.

本集團恪守香港的僱員補償條例，向勞工處處長呈報所有意外事故。本集團亦嚴格遵守其他相關健康與安全法律及法規，例如地方消防規定，為僱員提供安全的工作環境，保護彼等免受職業危害。

發展及培訓

我們深信，僱員個人事業發展與我們的業務增長相輔相成，故鼓勵彼等持續進修及成長，並鼓勵僱員從檢討自身表現中學習，為自己設定目標。

為提高僱員對產品、客戶服務、市場推廣及企業管理等的知識，我們不時舉辦內部培訓課程，協助員工裝備工作所需技能，同時緊貼市場趨勢。每當我們有新的促銷項目及新的活動時，會舉辦培訓課程，向所有負責的員工簡介有關安排，以確保我們向客戶提供優質服務。

除內部培訓外，如僱員發現進修需要，可與其經理分享所想。我們非常歡迎僱員進修的要求，會盡可能配合其進修需要。僱員如欲參與與其受聘有關的外部培訓課程或考試，我們可予以相應協助，形式包括彈性上班時間、財務援助及／或學費資助。我們視全體僱員為重要的家庭成員，希望支持彼等達成個人事業發展目標，相信總會令我們的業務長遠受惠。

於2020財政年度，我們取得27%的受訓比率，大多數受訓僱員為中級管理層。我們合共為僱員提供67小時培訓，每名僱員完成受訓的平均時數約為1小時。本集團將繼續投放更多資源進行僱員培訓及發展，讓員工與本集團並肩成長。

Labour Standards

The Group complies with all immigration laws and regulations. During the course of our recruitment process, documents authenticating the applicants' identity and eligibility to work in Hong Kong are obtained and verified, so as to ensure compliance with relevant laws and regulations in the aspect of employment.

Respecting human rights has always been an integral part of the Group's mission towards sustainability. The Group fully complies with labour laws and other relevant legislation that prohibit child labour and forced labour. No person below the age of eighteen has been hired or forced to work at the Group. Any act of violence, with the purposes of deliberately causing discomfort, threats and/or bodily harm, as well as forcing employees to work, is strictly prohibited by the Group. Our employees are welcomed to report to the management through the whistleblowing mechanism, if they notice any potential violation, or if they are experiencing forced labour. The management will investigate the matter and take follow-up actions in serious manner,

In FY2020, there was no material non-compliance with applicable laws and regulations in relation to labour standards.

Supply Chain Management

The Group recognizes that proper management of its supply chain brings positive impacts to the social environment. The Group has implemented a number of measures to ensure appropriate supply chain management.

Before entering a contractual relationship with a supplier, merchandising team of the Group conduct site visits and sample testing to ensure the quality of products provided by the supplier. Only suppliers with satisfactory result of the initial assessment will be added to our approved list of suppliers and engage in business with us. An official list of approved suppliers meeting the Group's procurement requirements is kept and regularly reviewed by the merchandising team through annual assessment. The Group will consider terminating business relationship with suppliers who are unable to meet our standard.

勞工準則

本集團恪守所有入境法律及法規。在招聘過程中，我們索取申請人身份及在香港工作資格的證明文件並予以核實，確保符合僱傭相關法律及法規。

尊重人權一直是本集團可持續發展使命中不可或缺的一部分。本集團全面遵守勞工法律及其他相關法例，禁止童工及強制勞工。本集團不會僱用或強迫未滿18歲的人士為其工作。本集團亦嚴禁以故意造成不適、威脅及／或人身傷害以及強迫僱員工作為目的的任何暴力行為。如僱員注意到任何潛在違規行為，或被強迫工作，我們歡迎彼等透過舉報機制向管理層舉報。管理層將嚴肅調查事件並採取跟進行動。

於2020財政年度，本集團並無嚴重違反與勞工準則有關的適用法律及法規。

供應鏈管理

本集團明白，妥善管理供應鏈可對社會環境產生積極影響。本集團已實施若干措施確保執行恰當的供應鏈管理。

在與供應商建立合約關係前，本集團的採購團隊會進行實地視察及抽樣測試，確定供應商所提供產品的品質。只有初步評估結果令人滿意的供應商方可進入我們的核準供應商名單，從而與我們進行業務往來。採購團隊存置符合本集團採購要求的正式核準供應商名單，並通過年度評估定期檢討名單。本集團會考慮與未能符合我們的標準的供應商終止商業關係。

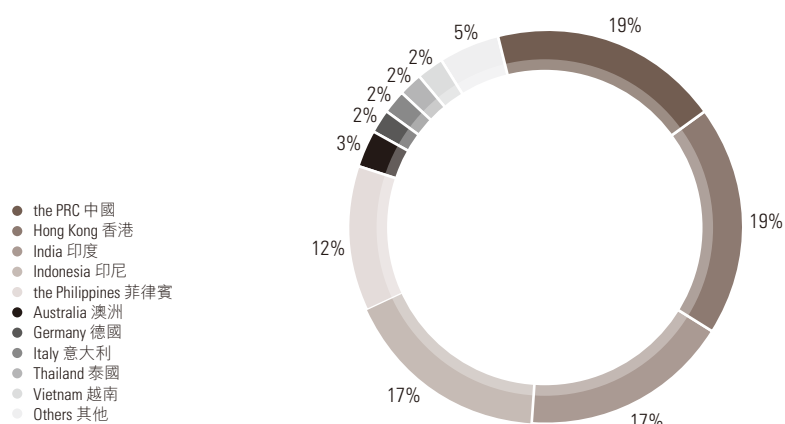

During FY2020, the Group had a total of 42 suppliers, which are mainly located in Southeast Asia, the PRC and Western Europe. With diversified sources of supply, the Group aims to achieve stable supplies to support its business operations.

To mitigate the risk of supply chain disruptions, the Group also maintains a stock level which is sufficient to meet its customers' demand for at least three months.

The Group's suppliers are encouraged to demonstrate corporate social responsibilities by complying with the relevant codes and business ethics with respect to workplace operations, marketing activities, social contacts and environmental responsibilities. On the other hand, any forms of bribery are strictly prohibited by the Group. Employees are forbidden from providing or acceptance benefits from suppliers and customers.

Product Responsibility

Product Quality Control

TREE Limited is committed to providing products and services of high quality and reliability. For the wooden furniture, FSC certificates of products are obtained by our merchandising team in order to verify the materials used for the products. The Company is also a trademark license holder promoting and selling FSC-certified finished goods. To ensure the quality of goods supplied, all our suppliers are required to perform quality check on every product prior to their delivery. A quality control label is then attached to every product as a proof of satisfactory result of the quality assurance test, which is further verified by the Group after the products have been shipped over. In our retail stores, our merchandising team and delivery team are responsible for conducting another round of inspections on all the furniture and home accessories. If material defects are found in any of the products, full inspection of the batch of products will be performed. In serious cases, the Managing Director may consider requesting replacement of the products delivered by the suppliers, or making claims for compensation against the suppliers.

After the delivery of products from suppliers, our carpenters will further polish, fine-tune the design of, and coat the product with OSMO upon customers' requests, which further enhances the quality of our products and maintain the unique brand of TREE.

In FY2020, there was no material non-compliance with applicable laws and regulations relating to product liability.

Not only does the Company focus on the product quality, the Company also places huge importance on the customers' health and safety issue. The Company has incorporated health concerns, such as choosing the products manufactured with qualified materials.

In addition, our advertisements are mainly based on our actual finished products and word-of-mouth. Not only do they help provide our customers with confidence towards our products, they also help our customers familiarise with our brand image.

Customer Service Management

To uphold the quality of its customer service, the Group has established various channels for its customers to communicate its team and provide feedback. Customers can approach us through our customer hotline, email, or leave their comments on our webpage via livechat or feedback form. Feedbacks pertinent to the attitude of staff, variety of products provided, and the environment of our stores etc. are all welcomed. The Group's customer service hotline, email address and website can be found in every postcard of its products. All the comments received are recorded by our customer service team, who will then share the feedback with the corresponding team members.

產品責任

產品品質監控

大樹有限公司致力提供優質且可靠的產品及服務。就木製傢俱而言，我們的採購團隊會索取產品的FSC認證，以驗證產品所使用的材料。本公司亦為推廣並銷售FSC認證成品的商標許可持有人。為保證獲供應商品的品質，本集團要求所有供應商在每件產品交付前進行品質檢查，然後在每件產品上貼上品質監控標籤作為品質保證測試結果令人滿意的憑證。本集團會進一步驗證所有付運產品的品質監控標籤。此外，採購團隊及送貨團隊負責再次檢查零售店所儲存的所有傢俱及家居配飾。如發現產品有任何材料瑕疵，將全面檢查該批產品。在嚴重情況下，董事總經理可能考慮要求供應商更換所交付的產品或向供應商索償。

在供應商交付產品後，我們的木匠將應客戶要求進一步打磨、美化設計及為產品上木蠟油，進一步提升產品品質，維持TREE品牌的獨特性。

於2020財政年度，本集團並無嚴重違反與產品責任有關的適用法律及法規。

本公司不單注重產品品質，亦極為重視客戶的健康與安全。本公司已將健康因素納入考慮範圍內，例如嚴選以合資格材料製造的產品。

此外，我們的廣告聚焦於真實的成品和口碑，不僅有利於鞏固客戶對旗下產品的信心，亦有助客戶認識我們的品牌形象。

客戶服務管理

為保持本集團客戶服務的品質，本集團已建立不同渠道讓客戶與團隊溝通並提供反饋。客戶聯絡我們的途徑包括客戶熱線、電子郵件或透過即時對話或反饋表格在我們的網站留言。與員工態度、產品種類及商店環境等有關的反饋均無任歡迎。我們每一件產品的明信片上均印有本集團的客戶服務熱線、電子郵件地址及網址。我們的客戶服務團隊會記錄所接獲的一切意見，並向相關團隊成員分享反饋。

In FY2020, there were 134 cases of customer complaints received, most of which were concerned with the imperfections in products upon delivery. The Group's customer service team is responsible for handling customers' enquiries and complaints.

A customer complaint handling policy has been established and circulated to the customer service team to ensure that standardised procedures are in place and properly maintained to handle customer complaints in appropriate manner. Customers' complaints are summarised in the customer complaint register, which are then reviewed by our customer service team with follow-up actions taken by the corresponding staff. All the follow-up actions are also recorded in the register, so that our staff can keep track of the progress and status of each complaint. This ensures that all the customers' complaints are attended to in appropriate manner, and the management can investigate the matter if necessary. We will continue to maintain good relationship with our customers and uphold our current practice of customer service management.

Confidentiality

TREE Limited has established an Employees' Manual which is circulated to all its employees to ensure that they are well aware of the importance of protection over customers' and suppliers' information. Customer and supplier data must only be used for the sole purpose of the Group's operations in a bid to provide adequate service to its customers. Customers' data must not be shared with any other parties outside the Group without prior written approval from the customers concerned. Verbal or written warning will be given to the relevant employee who has breached the listed regulations. The employee concerned may be subject to dismissal in the case of serious misconduct or repeated acts of misconduct.

Intellectual Property Rights

The Group understands the importance of protecting its intellectual property rights and patent. During the course of patent application, we have examined whether the patent has already been applied for by third party companies. The Group has registered its trademarks in Hong Kong, the PRC, the United States and Canada, with trademark summary established for monitoring the progress of trademark application and renewals required for the trademarks. We also conduct regular checks to see if our intellectual property rights have been infringed by other companies.

Anti-corruption

All forms of bribery and corruption are strictly prohibited by the Group. Employees should not offer, solicit or accept anything of material value to or from their colleagues, customers, suppliers or other business partner of TREE Limited, unless consent has been given by the Managing Director. Directors and staff should avoid conflicts of interest, in which the Group's interests can be potentially undermined. Employees are required to report to the management in case of potential conflicts of interest, declaring that the Group's interest will be upheld without the influence of their personal interests, in case of any actual or potential events of conflicts of interest.

於2020財政年度，本集團接獲134宗客戶投訴，大部分涉及所交付的產品有缺陷。本集團的客戶服務團隊負責處理客戶查詢及投訴。

本集團已制訂一項客戶投訴處理政策，並分發予客戶服務團隊，以確保落實及妥為存置標準程序，以合適方式處理客戶投訴。客戶投訴於客戶投訴登記冊概述，其後由客戶服務團隊檢討及安排負責人員採取跟進行動。所有跟進行動亦會記入登記冊，員工可藉此追蹤每宗投訴的進展及狀況。此舉確保所有客戶投訴得到合適處理，而管理層可於有需要時調查相關事宜。我們將繼續與客戶維持良好關係，秉持現行客戶服務管理常規。

保密

大樹有限公司已制定一份僱員手冊，並分發予所有僱員，以確保彼等熟知保障客戶及供應商資料的重要性。客戶及供應商資料僅供本集團營運之用，旨在為客戶提供優質服務。未經客戶事先書面批准，不得與本集團以外的任何其他人士共享客戶資料。本集團會對違反明文規例的僱員給予口頭或書面警告。僱員如嚴重行為不當或屢次行為不當可被開除。

知識產權

本集團深明保護知識產權及專利權的重要性。於申請專利權的過程中，我們已審查是否已有第三方公司申請有關專利權。本集團已於香港、中國、美國及加拿大註冊商標，並已建立商標概要以監察商標申請進度及需要續新的商標。此外，我們會定期檢視其他公司有否侵犯我們的知識產權。

反貪污

本集團嚴禁一切形式的賄賂及貪污。未經董事總經理同意，僱員不應向或從同僚、大樹有限公司的客戶、供應商或其他業務夥伴提供、索取或收取任何有重大價值的東西。董事及員工應避免利益衝突，即可能令本集團利益受損的情況。在發生潛在利益衝突的情況下，僱員須向管理層匯報，聲明不論在任何實際或潛在利益衝突的事件中，彼等均會維護本集團的利益，不受其個人利益所影響。

In addition to bribery and corruption, our employees are strictly prohibited from engaging in any illegal acts, including extortion, fraud, money laundering, etc. Identified cases will be followed-up with applicable legal actions. It is the Group's core values for reminding its employees to uphold their integrity and professionalism as aforementioned.

Whistleblowing

Whistleblowing policies are stated in the Employees' Manual, outlining the guidelines for employees to report cases of misconduct. Employees are welcomed to report suspected misconduct of their colleagues, subordinates, senior management or even suppliers. They can express their concerns through various channels, including face-to-face conversation, email or phone call with the manager, the Human Resources Manager or the Managing Director. Our management will review and take follow-up actions to investigate every reported case in serious manner. In case of serious misconduct, the management will consider reporting to the police or the Independent Commission Against Corruption ("ICAC").

In FY2020, there was no concluded legal case regarding corrupt practices brought against the Group or its employees.

Community Investment

"Putting our heart into everything we do" is what TREE Limited is committed to. Not only do we put our hearts into giving back to our employees and customers, but also into contributing to the environment and community. In light of this, the Company has actively participated in various charitable activities, and encouraged our employees to invest in the community. In FY2020, TREE Limited has mainly participated in the following activities.

Trees4Trees – supporting reforestation and improving lives of local families

TREE has consistently made donations to Trees4Trees, a non-profit foundation that empowers local community with reforestation initiatives through educational programmes. In FY2020, the Company donated approximately HK\$67,300 to Trees4Trees. Not only does the donation support reforestation, but also help improve the lives of the local community through employing locals to assist reforestation and educating them about sustainable forest management. We value tree resources in the environment, so we put our hearts into giving back to our mother nature through participating in reforestation.

除賄賂及貪污外，僱員嚴禁參與任何非法行為，包括勒索、欺詐、洗黑錢等。已識別的案件將以適用法律行動跟進。本集團的核心價值乃提醒僱員堅守上述誠信及專業。

舉報

舉報政策載於僱員手冊內，概括僱員匯報不當行為事件的指引。本集團鼓勵僱員匯報同僚、下屬、高級管理層甚至供應商的懷疑不當行為。彼等可循面談、電郵或電話等不同渠道向經理、人力資源經理或董事總經理表達彼等的關注。我們的管理層將進行審閱並採取跟進行動，嚴肅調查每宗報告事件。倘有嚴重不當行為，管理層將會考慮向警察或廉政公署（「廉署」）報案。

於2020財政年度，概無針對本集團或其僱員所提起的已審結貪污行為法律案件。

社區投資

「全心全意，全情投入」乃大樹有限公司的承諾。我們不單真誠對待僱員及客戶，同時傾力貢獻環境及社區。就此，本公司一直積極參與不同慈善活動，鼓勵僱員投入社區。於2020財政年度，大樹有限公司主要參與以下活動：

Trees4Trees — 支持造林以及改善當地家庭生活

TREE一直捐贈Trees4Trees。Trees4Trees為非牟利基金會，通過教育項目賦予當地社區造林倡議的權利。於2020財政年度，本公司捐贈約67,300港元予Trees4Trees。該筆捐款不僅支持造林，亦藉僱用當地人協助造林並教育彼等可持續森林管理，協助當地社區家庭改善生活。我們珍惜環境內的樹木資源，全心全意參與造林回饋萬物之母。

NSW Rural Fire Service & Brigades Donations Fund – helping alleviate bushfire in Australia

In FY2020, the Company donated approximately HK\$5,100 to NSW Rural Fire Service and Brigades Donations Fund in light of the bushfire in Australia in second half of 2019, in which millions of people and animals were affected, with plenty of valuable resources lost to the fire. All the donations will be used to support fire service in the area, as well as rebuilding lost homes for both humans and animals. We hope that through this donation, we can all contribute to the alleviation of natural hazard and create a sustainable environment again.

World Wide Fund for Nature (Australia) – helping animals affected by bushfire

On top of supporting NSW Rural Fire Service, TREE Limited also donated approximately HK\$5,200 to World Wide Fund for Nature in Australia to support koalas in need of medical attention. The donation was also used for reforestation in the affected areas, restoring natural habitats for many of the wild animals in Australia. We believe that every step matters in creating a better environment for both humans and animals for the long run.

Redress – promoting sustainable consumption and production

As a dedicated enterprise that upholds environmental sustainability, TREE Limited actively participates in local events and partner up with other companies to promote sustainable consumption and production – one of United Nations' sustainable development goals. In FY2020, TREE Limited donated furniture with a total value of approximately HK\$45,600 to Redress, which is an environmental charity with a mission to prevent and transform textile waste to promote circular economy. Redress has collaborated with multiple enterprises to generate and showcase values in existing waste, raising environmental awareness among the local community in Hong Kong. By donating our furniture to Redress, we hope to support their initiative and promote the idea of sustainable living.

Earth Hour – letting nature shine

TREE Limited is committed to leading a sustainable lifestyle and it has been supporting Earth Hour every year since 2016 by switching off lights at 8:30pm on a designated date. In FY2020, we also participated in Earth Hour on 28 March 2020 to show our commitment to letting nature shine. Apart from this yearly event, TREE Limited is dedicated to minimising its adverse impacts on the environment in its daily operations. This is achieved through reduction in emissions and resource consumption, as well as waste recycling.

REGULATORY COMPLIANCE

The Group was not aware of any non-compliance with laws and regulations that has a significant impact on the Group in the aspects of emissions, employment, health and safety, labour standards, product responsibility and anti-corruption during FY2020.

NSW Rural Fire Service & Brigades Donations Fund (新南威爾斯鄉郊消防服務隊慈善基金) – 協助澳洲山火賑災

The Board is pleased to present its report and the audited consolidated financial statements of the Group for FY2020.

PRINCIPAL ACTIVITIES

Headquartered in Hong Kong and operating under the brand name “TREE”, we engage in (i) the sale and distribution of furniture and home accessories; (ii) distribution and licence fee income; (iii) operation of TREE Café; (iv) consignment sales of home accessories and furniture agency services and (v) provision of styling and consulting services. We offer a variety of furniture including tables, chairs, storage solutions, sofas and beds; and home accessories including kitchenware, bed and bathroom related products, jars, cushions, mattresses, utensils and baskets.

At date of this Annual Report, we operated three “TREE” retail stores in Hong Kong namely, our Flagship Store, our Sha Tin store, and our Yuen Long store.

In addition, we acquired, Hong Kong Italiving International Company Limited (“HK Italiving”) in December 2018, and it is principally engaged in the provision of furniture agency service.

BUSINESS REVIEW

The business review of the Group for FY2020 is set out in the “Management Discussion and Analysis” of this Annual Report.

FINANCIAL RESULTS AND DIVIDENDS

The results of the Group for FY2020 and the financial position of the Company and the Group as at 31 March 2020 are set forth in the consolidated financial statements on pages 83 to 171 of this Annual Report.

The Board does not recommend the payment of a final dividend for FY2020.

SHARE CAPITAL

As at 31 March 2020, the Company’s issued share capital was HK\$15,840,000 and the number of its issued ordinary shares was 1,584,000,000 of HK\$0.01 each.

PRE-EMPTIVE RIGHTS

There is no provision for pre-emptive rights under the Company’s Articles or the laws of the Cayman Islands, which would oblige the Company to offer new shares on a pro-rata basis to existing Shareholders.

USE OF PROCEEDS FROM THE COMPANY'S SHARE OFFERING

The net proceeds from the Listing in January 2018, after deducting the underwriting fees, the Stock Exchange trading fee and SFC transaction levy and other listing expenses in connection with the Share Offer, were approximately HK\$20.3 million.

During the period from the Listing Date to 31 March 2020, the Group has utilised HK\$12.3 million, or 60.6% of the actual net proceeds from the Listing for the staff costs of an interior designer; the establishment of an e-commerce platform; the enhancement of the POS system; and for the leasehold improvement, marketing, deposit and rental of the Yuen Long store opened in May 2018.

As disclosed in our Group's announcement dated 19 June 2020, the Board resolved to change the use of unutilised net proceeds. The revised proposed change of use of the unutilised net proceeds would be for the settlement of the future consideration payable in relation to the acquisition HK Italiving, which was completed on 31 December 2018.

SHARE OPTION SCHEME

The Company adopted a share option scheme on 5 January 2018 (the “**Share Option Scheme**”). The terms of the Share Option Scheme are in accordance with the provisions of Chapter 23 of the GEM Listing Rules and set out below.

(a) Purpose of the Share Option Scheme

The purpose of the Share Option Scheme is to enable our Group to grant options to the eligible participants as incentives or rewards for their contribution to our Group and/or to enable our Group to recruit and retain high-calibre employees and attract human resources that are valuable to our Group or any entity in which any member of our Group holds any equity interest (the “**Invested Entity**”).

(b) Participants

Our Directors shall, in accordance with the provisions of the Share Option Scheme and the GEM Listing Rules, be entitled but shall not be bound at any time within a period of 10 years commencing from the date of the adoption of the Share Option Scheme to make an offer for the grant of an option to any person belonging to the following classes:

- (a) any employee (whether full time or part time, including the Directors (including any Non-Executive Director and Independent Non-Executive Director)) of our Company, any of our subsidiaries (within the meaning of Companies Ordinance) or any Invested Entity (an “**Eligible Employee**”);
- (b) any supplier of goods or services to any member of our Group or any Invested Entity;
- (c) any customer of any member of our Group or any Invested Entity;
- (d) any person or entity that provides research, development or other technological support to any member of our Group or any Invested Entity;
- (e) any Shareholder of any member of our Group or any Invested Entity or any holder of any securities issued by any member of our Group or any Invested Entity;
- (f) any adviser (professional or otherwise), consultant, individual or equity who in the opinion of our Directors has contributed or will contribute to the growth and development of our Group; and

and, for the purpose of the Share Option Scheme, the offer for the grant of an option may be made to any company wholly-owned by one or more eligible participants.

For the avoidance of doubt, the grant of any options by our Company for the subscription of shares or other securities of our Group to any person who falls within any of the above classes of eligible participants shall not, by itself, unless our Directors otherwise determine, be construed as a grant of option under the Share Option Scheme.

The eligibility of any of the eligible participants to an offer under the Share Option Scheme shall be determined by our Directors from time to time on the basis of our Directors' opinion as to such eligible participant's contribution to the development and growth of our Group.

(c) Maximum number of shares

- (a) The maximum number of shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the Share Option Scheme and any other share option schemes adopted by our Group shall not exceed 30% of our share capital in issue from time to time. No options may be granted under the Share Option Scheme or any other share option schemes adopted by our Group if the grant of such options will result in the limit referred herein being exceeded.
- (b) The total number of shares which may be issued upon exercise of all options (excluding, for this purpose, options which have lapsed in accordance with the terms of the Share Option Scheme and any other share option schemes of our Group) to be granted under the Share Option Scheme and any other share option schemes of our Group shall not in aggregate exceed 10% of our share capital in issue as at the date on which dealings in our shares first commence on the Stock Exchange, being 158,400,000 shares (the "General Scheme Limit").

(d) Subject to (a) above and without prejudice to (c) above, our Company may seek separate Shareholders' approval in general meeting to grant options under the Share Option Scheme beyond the General Scheme Limit or, if applicable, the extended limit referred to in (c) above to eligible participants specifically identified by our Company before such approval is sought.

(d) Maximum entitlement of each eligible participant

Subject to (v) below, the total number of shares issued and which may fall to be issued upon exercise of the options granted under the Share Option Scheme and any other share option schemes of our Group (including both exercised or outstanding options) to each eligible participant who accepts the offer for the grant of an option under the Share Option Scheme (a "grantee") in any 12-month period shall not exceed 1% of our issued share capital for the time being. Where any further grant of options under the Share Option Scheme to a grantee would result in our shares issued and to be issued upon exercise of all options granted and proposed to be granted to such person (including exercised, cancelled and outstanding options) under the Share Option Scheme and any other share option schemes of our Group in the 12-month period up to and including the date of such further grant representing in aggregate over 1% of our share capital in issue, such further grant shall be separately approved by our Shareholders in general meeting with such grantee and his close associates (or his associates if the grantee is a connected person) abstaining from voting.

(b) Without prejudice to (a) above, where any grant of options under the Share Option Scheme to a substantial Shareholder or our Independent Non-Executive Director or any of their respective associates, would result in our shares issued and to be issued upon exercise of all options under the Share Option Scheme already granted and to be granted (including options exercised, cancelled and outstanding) to such person in the 12-month period up to and including the date of such grant:

- (1) representing in aggregate over 0.1% of our share capital in issue; and
- (2) having an aggregate value, based on the closing price of our shares at the offer date of each offer, in excess of HK\$5 million;

such further grant of options shall be approved by our Shareholders in general meeting. The proposed grantee, his associates and all our core connected persons shall abstain from voting in favour at such general meeting.

For the purpose of seeking the approval of our Shareholders under paragraphs (iii), (iv) and (v) above, our Company shall send a circular to our Shareholders containing the information required under the GEM Listing Rules and where the GEM Listing Rules shall so require, the vote at the Shareholders' meeting convened to obtain the requisite approval shall be taken on a poll with those persons required under the GEM Listing Rules abstaining from voting.

(f) Time of acceptance and exercise of an option

An offer under the Share Option Scheme shall remain open for acceptance by the eligible participant concerned (and by no other person) for a period of up to 21 days from the date, which shall be a business day, on which the offer is made to the eligible participant.

An offer shall have been accepted by an eligible participant in respect of all shares which are offered to such eligible participant when the duplicate letter comprising acceptance of the offer duly signed by the eligible participant together with a remittance in favour of our Company of HK\$1.00 by way of consideration for the grant thereof is received by our Company within such time as may be specified in the offer (which shall not be later than 21 days from the offer date). Such remittance shall in no circumstances be refundable.

Any offer may be accepted by an eligible participant in respect of less than the number of shares which are offered provided that it is accepted in respect of a board lot for dealings in our shares on GEM or an integral multiple thereof and such number is clearly stated in the duplicate letter comprising acceptance of the offer duly signed by such eligible participant and received by our Company together with a remittance in favour of our Company of HK\$1.00 by way of consideration for the grant thereof within such time as may be specified in the offer (which shall not be later than 21 days from the offer date). Such remittance shall in no circumstances be refundable.

An option may be exercised in accordance with the terms of the Share Option Scheme at any time during a period to be determined and notified by our Directors to the grantee thereof (provided always that such period shall not be more than 10 years from the offer date of that option), and in the absence of such determination, from the date of the grant of such option to the earlier of (aa) the date on which such option lapses under the relevant provisions of the Share Option Scheme; and (bb) the date falling 10 years from the offer date of that option.

No share option has been granted since the adoption of the Share Option Scheme and there was no share option outstanding as at 31 March 2020.

EQUITY-LINKED AGREEMENTS

Other than the Share Option Scheme of the Company as disclosed above, there is no equity-linked agreement that will or may result in the Company issuing shares or require the Company to enter into any agreements that will or may result in the Company issuing shares were entered into by the Company during FY2020 or subsisted at the end of FY2020.

Management concluded that the goodwill was not impaired as at 31 March 2020. 貴集團須至少每年對商譽進行減值評估。為進行減值評估，商譽已分配至傢俱代理服務的現金產生單位。管理層已參照於報告期末進行的獨立外部估值評估相關現金產生單位的可收回金額。管理層的結論為於2020年3月31日，商譽並無減值。

1. GENERAL INFORMATION

Tree Holdings Limited (the “Company”) was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law (as revised) of the Cayman Islands. The address of the Company’s registered office is P.O. Box 1350, Clifton House, 75 Fort Street, Grand Cayman KY1-1108, Cayman Islands. The address of its principal place of business is 28/F., Horizon Plaza, 2 Lee Wing Street, Ap Lei Chau, Hong Kong.

The Company is an investment holding company and its subsidiaries (collectively, the “Group”) are principally engaged in the sale and distribution of furniture and home accessories, distribution and licencing of intellectual property rights, the provision of styling, consulting and furniture agency services and the operation of a café.

The directors consider the immediate and ultimate holding company of the Company to be Tiptop Honour Limited (“Tiptop”), a company incorporated in Samoa.

The consolidated financial statements for the year ended 31 March 2020 were approved for issue by the board of directors on 24 June 2020.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

2.1 Basis of preparation

These consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”) which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”) and the accounting principles generally accepted in Hong Kong.

The consolidated financial statements also comply with the applicable disclosure requirements of the Hong Kong Companies Ordinance and include the applicable disclosure requirements of the Rules Governing the Listing of Securities on GEM of the Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”).

The significant accounting policies that have been used in the preparation of these consolidated financial statements are summarised below. These policies have been consistently applied to all the years presented, unless otherwise stated. The adoption of new and amended HKFRSs and the impacts on the Group’s consolidated financial statements, if any, are disclosed in Note 2.2.

截至2020年3月31日止年度的綜合財務報表於2020年6月24日獲董事會批准刊發。

The consolidated financial statements have been prepared on the historical cost basis, except for cash surrender value of life insurance and contingent consideration payable which are carried at fair value. The measurement bases are fully described in the accounting policies below.

The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is the functional currency of the Company and its subsidiaries, and all values are rounded to the nearest thousands ("HK\$'000"), except when otherwise indicated.

It should be noted that accounting estimates and assumptions are used in preparation of the consolidated financial statements. Although these estimates are based on the management's best knowledge and judgment of current events and actions, actual results may ultimately differ from those estimates. The areas involving a higher degree of judgment or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in Note 3 below.

2.3 Consolidation

(a) Subsidiaries

Subsidiaries are entities (including structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. Subsidiaries are consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

The acquisition method of accounting is used to account for business combinations by the Group (refer to Note 2.4).

Intra-group transactions, balances and unrealised gains and losses on transactions between group companies are eliminated in preparing the consolidated financial statements. Where necessary, amounts reported by subsidiaries have been adjusted to conform with the Group's accounting policies.

(b) Separate financial statements

In the Company's statement of financial position, subsidiaries are carried at cost less any impairment loss. Cost also includes direct attributable costs of investment. The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable at the reporting date. All dividends whether received out of the investee's pre or post-acquisition profits are recognised in the Company's profit or loss.

Acquisitions of subsidiaries and businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are recognised in profit or loss as incurred.

Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity in the acquiree (if any) over the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed. If, after assessment, the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value on the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as bargain purchase gain.

Where the consideration the Group transfers in a business combination includes assets or liabilities resulting from a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and considered as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively, with the corresponding adjustments being made against goodwill or gain on bargain purchase. Measurement period adjustments are adjustments that arise from additional information obtained during the measurement period about facts and circumstances that existed as of the acquisition date. Measurement period does not exceed one year from the acquisition date. The subsequent accounting for changes in the fair value of the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not remeasured at subsequent reporting dates and its subsequent settlement is accounting for within equity. Contingent consideration that is classified as a financial liability is remeasured at subsequent reporting dates at fair value with corresponding gain or loss being recognised in profit or loss.

2.5 Foreign currency translation

(a) Functional and presentation currency

Items included in the financial information of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in HK\$, which is the Company's functional and presentation currency.

(b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss.

Property, plant and equipment (other than cost of right-of-use assets as described in Note 2.14) are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the assets to its working condition and location for its intended use. Depreciation of assets commences when the assets ready for intended use.

Depreciation on property, plant and equipment is provided to write off the cost less their residue values over their estimated useful lives, using the straight-line method, at the following rates per annum:

The assets' residual values, depreciation methods and useful lives are reviewed, and adjusted if appropriate, at each reporting date.

The gain or loss arising on retirement or disposal is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other costs, such as repairs and maintenance are charged to profit or loss during the financial period in which they are incurred.

2.7 Goodwill

Goodwill arising in a business combination is recognised as an asset at the date that control is acquired (the acquisition date). Goodwill is measured as the excess of the aggregate of the fair value of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the Group's interest in the net fair value of the acquiree's identifiable assets and liabilities measured as at the acquisition date.

If, after reassessment, the Group's interest in the fair value of the acquiree's identifiable net assets exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held equity interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Goodwill is stated at cost less accumulated impairment losses. Goodwill is allocated to cash-generating units and is tested annually for impairment (Note 2.18).

On subsequent disposal of a subsidiary, the attributable amount of goodwill capitalised is included in the determination of the amount of gain or loss on disposal.

2.8 Intangible assets (other than goodwill)

Website development costs

Cost directly associated with the development of specific websites, which include external direct costs of materials and services consumed in developing the website are capitalised. The capitalisation of such costs ceases no later than the point at which the websites are substantially completed and ready for its intended purpose. Website development costs are amortised on a straight-line basis over a period of 5 years, which represent the expected useful life of the website. Capitalised website development costs stated at cost less accumulated amortisation and accumulated impairment losses.

Research and other development costs relating to website development and website maintenance costs are expensed as incurred.

Trademarks

Trademarks are initially recorded at cost. After initial recognition, these trademarks have a finite useful lives and are carried at cost less accumulated amortisation and any accumulated impairment losses. Amortisation is calculated on a straight-line basis over a period of 10 years. Amortisation commences when the trademarks are available for use.

2.9 Financial instruments

Recognition and derecognition

Financial assets and financial liabilities are recognised when the Group becomes a party to the contractual provisions of the financial instrument.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and substantially all of its risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

(a) Financial assets

Classification and initial measurement of financial assets
Except for those trade receivables that do not contain a significant financing component and are measured at the transaction price in accordance with HKFRS 15, all financial assets are initially measured at fair value, in case of a financial asset not at fair value through profit or loss, plus transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at fair value through profit or loss are expensed in the consolidated statement of profit or loss and other comprehensive income.

Financial assets at fair value through profit or loss

Financial assets that are held within a different business model other than “hold to collect” or “hold to collect and sell” are categorised at fair value through profit or loss. The Group’s cash surrender value of life insurance falls into this category of financial assets.

Bank borrowings

Bank borrowings are recognised initially at fair value, net of transaction costs incurred. Bank borrowings are subsequently stated at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in profit or loss over the period of the bank borrowings using the effective interest method.

Bank borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least twelve months after the reporting date.

Trade and other payables

Trade and other payables are recognised initially at their fair value and subsequently measured at amortised cost, using the effective interest method.

Contingent consideration payable

Contingent consideration payable is recognised at fair value at the end of each reporting period with gain or loss on remeasurement to fair value is recognised immediately in profit or loss.

HKFRS 9's impairment requirements use more forward-looking information to recognise ECL — the "ECL model". Instruments within the scope included loans and other debt-type financial assets measured at amortised cost and trade receivables.

The Group considers a broader range of information when assessing credit risk and measuring ECL, including past events, current conditions, reasonable and supportable forecasts that affect the expected collectability of the future cash flows of the instrument.

銀行借貸

銀行借貸分類為流動負債，除非本集團擁有無條件權利可將負債延後至報告日後最少十二個月清償則另作別論。

貿易及其他應付款項初始按公允價值確認，其後使用實際利率法按攤銷成本計量。

In applying this forward-looking approach, a distinction is made between:

- financial instruments that have not deteriorated significantly in credit quality since initial recognition or that have low credit risk (“Stage 1”); and
- financial instruments that have deteriorated significantly in credit quality since initial recognition and whose credit risk is not low (“Stage 2”).

“Stage 3” would cover financial assets that have objective evidence of impairment at the reporting date.

“12-month ECL” are recognised for the Stage 1 category while “lifetime ECL” are recognised for the Stage 2 category.

Measurement of the ECL is determined by a probability-weighted estimate of credit losses over the expected life of the financial instrument.

Trade receivables

For trade receivables, the Group applies a simplified approach in calculating ECL and recognises a loss allowance based on lifetime ECL at each reporting date. These are the expected shortfalls in contractual cash flows, considering the potential for default at any point during the life of the financial assets. In calculating the ECL, the Group has established a provision matrix that is based on its historical credit loss experience and external indicators, adjusted for forward-looking factors specific to the debtors and the economic environment.

Other financial assets measured at amortised cost

The Group measures the loss allowance for other receivables equal to 12-month ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increase in the likelihood or risk of default occurring since initial recognition.

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial assets at the reporting date with the risk of default occurring on the financial assets at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant deterioration in the operating results of the debtor;
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the end of each reporting period. A debt instrument is determined to have low credit risk if it has a low risk of default, the borrower has strong capacity to meet its contractual cash flow obligations in the near term and adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfill its contractual cash flow obligations. For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collateral held by the Group).

Detailed analysis of the ECL assessment of trade receivables and other financial assets measured at amortised cost are set out in Note 34.2.

2.11 Inventories

Inventories are stated at the lower of cost and net realisable value. Cost, which comprises all costs of purchase and, where applicable, other costs that have been incurred in bringing the inventories to their present location and condition, is calculated using the weighted average method. Net realisable value is the estimated selling price in the ordinary course of business less applicable variable selling expenses.

2.12 Cash and cash equivalents

Cash and cash equivalents include cash at bank and in hand.

2.13 Contract liabilities

A contract liability is recognised when the customer pays consideration before the Group recognises the related revenue (Note 2.17). A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised (Note 2.9).

儘管有上述考慮，但如債務工具於各報告期末釐定為具有低信貸風險，則本集團假設債務工具的信貸風險自初始確認以來並未顯著惡化。如債務工具的違約風險低、借貸人可穩健地於短期內應付合約現金流義務，而經濟及商業環境的較長期的不利變動可能(但未必)削弱借貸人應付合約現金流義務的能力，則債務工具釐定為具有低信貸風險。就內部信貸風險管理而言，當內部制定或從外部來源取得的資料顯示債務人不大可能悉數向債權人(包括本集團)還款(未計及本集團持有的任何抵押品)，則本集團認為發生違約事件。

2.11 存貨

存貨按成本與可變現淨值的較低者列賬。成本(包括所有購買成本以及(在適當情況下)其他因將存貨送往現時地點及達至現時狀況所產生的成本)乃使用加權平均法計算。可變現淨值為日常業務過程中的估計售價減適用的可變銷售費用。

2.12 現金及現金等價物

現金及現金等價物包括於銀行及手頭的現金。

2.13 合約負債

合約負債在客戶於本集團確認相關收益前支付代價時確認(附註2.17)。倘本集團有無條件權利在本集團確認相關收益前收取代價，則亦會確認合約負債。在相關情況下，本集團亦會確認相應應收款項(附註2.9)。

For a single contract with the customer, either a net contract asset or a net contract liability is presented. For multiple contracts, contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

Definition of a lease

For any new contracts entered into on or after 1 April 2019, the Group considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an identified asset (the underlying asset) for a period of time in exchange for consideration'.

To apply this definition, the Group assesses whether the contract meets three key evaluations which are whether:

- the contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Group;
- the Group has the right to obtain substantially all of the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract; and
- the Group has the right to direct the use of the identified asset throughout the period of use. The Group assesses whether it has the right to direct 'how and for what purpose' the asset is used throughout the period of use.

For contracts that contain a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease and non-lease component on the basis of their relative stand-alone prices. However, for leases of warehouse, office and shop premises in which the Group is a lessee, the Group elected not to separate non-lease components and will instead account for the lease and non-lease components as a single lease component.

- 合約是否包含已識別資產，即該資產在合約中可明確識別，或在資產可供本集團使用時以隱含指定方式識別；
- 本集團是否有權在整段使用期內取得使用已識別資產的絕大部分經濟利益，當中會考慮其於合約界定範圍內的權利；及
- 本集團是否有權在整段使用期內指示已識別資產的用途。本集團評估其是否有權指示該資產在整段使用期內的使用「方式及目的」。

對於含有租賃成分及一個或以上額外租賃或非租賃成分的合約，本集團按租賃及非租賃成分的相對獨立價格將合約代價分配至各成分。然而，對於本集團為承租人的倉庫、辦公室及店舖租賃，本集團選擇不將非租賃成分分開，而將租賃與非租賃成分入賬列作單一租賃成分。

Measurement and recognition of leases as a lessee

At lease commencement date, the Group recognises a right-of-use asset and a lease liability on the consolidated statement of financial position. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Group, an estimate of any costs to dismantle and remove the underlying asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any lease incentives received).

The Group depreciates the right-of-use assets on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use assets or the end of the lease term unless the Group is reasonably certain to obtain ownership at the end of the lease term. The Group also assesses the right-of-use assets for impairment when such indicator exists.

At the commencement date, the Group measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Group's incremental borrowing rate.

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable payments based on an index or rate, and amounts expected to be payable under a residual value guarantee. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payment of penalties for terminating a lease, if the lease term reflects the Group exercising the option to terminate.

Subsequent to initial measurement, the liability will be reduced for lease payments made and increased for interest cost on the lease liability. It is remeasured to reflect any reassessment or lease modification, or if there are changes in in-substance fixed payments. The variable lease payments that do not depend on an index or a rate are recognised as expense in the period on which the event or condition that triggers the payment occurs.

於租賃開始日期，本集團於綜合財務狀況表確認使用權資產及租賃負債。使用權資產按成本計量，而成本乃包括租賃負債的初始計量、本集團產生的任何初始直接成本、租賃結束時拆除及移除相關資產的任何估計成本以及於租賃開始日期前作出的任何租賃付款（經扣除任何已收租賃獎勵）。

本集團的使用權資產於租賃開始日期至使用權資產的可使用年期結束或租期結束（以較早者為準）期間以直線基準計算折舊，除非本集團合理地確定於租期結束時可獲得擁有權則作別論。本集團亦於出現減值跡象時評估使用權資產的減值。

於開始日期，本集團按該日未支付租賃付款的現值計量租賃負債，並使用租賃中的隱含利率或（倘該利率不可釐定）本集團的增量借貸利率進行折現。

計量租賃負債時計入的租賃付款包括固定付款（包括實質固定付款）減任何應收租賃獎勵、基於某一指數或比率的可變付款及根據殘值保證應付的預期金額。倘本集團合理地確定將行使購買選擇權，則租賃付款亦包括購買選擇權的行使價，而倘租期反映本集團將行使終止選擇權，則租賃付款亦包括終止租賃的罰金。

The Group has elected to account for short-term leases using the practical expedients. Instead of recognising a right-of-use asset and lease liability, the payments in relation to these leases are recognised as an expense in profit or loss on a straight-line basis over the lease term. Short-term leases are leases with a lease term of 12 months or less.

On the consolidated statement of financial position, right-of-use assets have been included in property, plant and equipment.

Refundable rental deposits paid are accounted for under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

Policy applicable before 1 April 2019

An arrangement, comprising a transaction or a series of transactions, is or contains a lease if the Group determines that the arrangement conveys a right to use a specific asset or assets for an agreed period of time in return for a payment or a series of payments. Such a determination is made based on an evaluation of the substance of the arrangement and is regardless of whether the arrangement takes the legal form of a lease.

Assets that are held by the Group under leases which transfer to the Group substantially all the risks and rewards of ownership are classified as being held under finance leases. Leases which do not transfer substantially all the risks and rewards of ownership to the Group are classified as operating leases.

於綜合財務狀況表中，使用權資產計入物業、廠房及設備。

已付可退回租賃按金根據香港財務報告準則第9號入賬，且初始按公允價值計量。於初始確認時對公允價值的調整被視為額外租賃付款，並計入使用權資產的成本。

倘本集團決定作出包含一項或一連串交易的安排，讓渡在協定期間使用一項特定或多項資產的權利以換取一筆或一連串款項，則有關安排屬於或包括一項租賃。該項決定乃基於對安排內容的評估作出，不論有關安排是否採取租賃的法律形式。

Subsequent accounting for assets held under finance lease agreements corresponds to those applied to comparable acquired assets. The corresponding finance lease liability is reduced by lease payments less finance charges.

Finance charges implicit in the lease payments are charged to profit or loss over the period of the leases so as to produce an approximately constant periodic rate of charge on the remaining balance of the obligations for each accounting period. Contingent rentals are charged to profit or loss in the accounting period in which they are incurred.

Operating leases

When the Group has the right to use of assets held under operating leases, payments made under the leases are charged to profit or loss on a straight-line basis over the lease terms except where an alternative basis is more representative of the pattern of benefits to be derived from the leased assets. Lease incentives received are recognised in profit or loss as an integral part of the aggregate net lease payments made. Contingent rental, if any, are charged to profit or loss in the accounting period in which they are incurred.

融資租賃

在本集團根據融資租賃獲得資產使用權的情況下，相當於租賃資產公允價值或(如較低)該等資產最低租賃付款的現值計入「物業、廠房及設備」，而經扣除財務支出的相應負債乃記賬為「融資租賃負債」。

根據融資租賃協議持有的資產的其後會計處理與應用於可資比較的已購入資產者一致。相應融資租賃負債按租賃付款減財務支出扣除。

租賃付款隱含的財務支出於租期內自損益扣除，致使就各個會計期間產生一個有關承擔餘額的概約固定定期扣除比率。或然租金於產生的會計期間自損益扣除。

經營租賃

當本集團有權使用根據經營租賃持有的資產時，根據租賃作出的付款於租期內以直線基準從損益扣除，惟倘另一種更能反映租賃資產所衍生利益模式的基準則作別論。所獲租賃獎勵於損益入賬列為已作出淨租賃付款總額的主要部分。或然租金(如有)於產生的會計期間自損益扣除。

2.15 Provisions

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate of the amount of the obligation can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

All provisions are reviewed at each reporting date and adjusted to reflect the current best estimate.

2.16 Share capital

Ordinary shares are classified as equity. Share capital is determined using the nominal value of shares that have been issued. Any transaction costs associated with the issuing of shares are deduction from share premium (net of any related income tax benefit) to the extent they are incremental costs directly attributable to the equity transaction.

2.17 Revenue recognition

Revenue arises mainly from the sale and distribution of furniture and home accessories, distribution and licencing of intellectual property rights, the provision of styling, consulting and furniture agency services and the operation of a café.

To determine whether to recognise revenue, the Group follows a 5-step process:

1. Identifying the contract with a customer
2. Identifying the performance obligations
3. Determining the transaction price
4. Allocating the transaction price to the performance obligations
5. Recognising revenue when/as performance obligation(s) are satisfied

2.16 股本

In all cases, the total transaction price for a contract is allocated amongst the various performance obligations based on their relative stand-alone selling prices. The transaction price for a contract excludes any amounts collected on behalf of third parties.

Revenue is recognised either at a point in time or over time, when (or as) the Group satisfies performance obligations by transferring the promised goods or services to its customers.

Further details of the Group's revenue and other income recognition policies are as follows:

Sale of furniture and home accessories

Revenue from the sale of furniture and home accessories are recognised at a point in time when the Group transfers the control of the assets to the customers upon delivery.

Distribution and license fee income

Fixed upfront distribution and license fee is recognised over time on a straight-line basis over the terms of distribution agreement and license period. License fee income from the licensing arrangement is recognised over time on an accrual basis in accordance with the terms of agreements.

Revenue from café operation

Food and beverage income from the operation of a café is recognised at a point in time when the related services are rendered to the customers.

Commission income

Commission income from (i) consignment sales are recognised at a point in time when the goods are sold by the Group; and (ii) furniture agency service is recognised at a point in time when the services have been performed.

Consulting income

Consulting income is recognised at a point in time when the services have been performed.

Interest income

Interest income is recognised on a time proportion basis using the effective interest method. For financial assets measured at amortised cost that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of ECL allowance) of the asset.

2.18 Impairment of non-financial assets

Goodwill arising on acquisition of a subsidiary, other intangible assets, property, plant and equipment (including right-of-use assets) and the Company's investment in a subsidiary are subject to impairment testing.

Goodwill and other intangible assets with indefinite useful life or those not yet available for use are tested for impairment at least annually, irrespective of whether there is any indication that they are impaired. All other assets are tested for impairment whenever there are indications that the asset's carrying amount may not be recoverable.

An impairment loss is recognised as an expense immediately for the amount by which the asset's carrying amount exceeds its recoverable amount. Recoverable amount is the higher of fair value, reflecting market conditions less costs of disposal, and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessment of time value of money and the risk specific to the asset.

For the purposes of assessing impairment, where an asset does not generate cash inflows largely independent from those from other assets, the recoverable amount is determined for the smallest group of assets that generate cash inflows independently (i.e. a cash-generating unit). As a result, some assets are tested individually for impairment and some are tested at cash-generating unit level. Corporate assets are allocated to individual cash-generating units, when a reasonable and consistent basis of allocation can be identified, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified. Goodwill in particular is allocated to those cash-generating units that are expected to benefit from synergies of the related business combination and represent the lowest level within the Group at which the goodwill is monitored for internal management purpose and not be larger than an operating segment.

Impairment losses recognised for cash-generating units, to which goodwill has been allocated, are credited initially to the carrying amount of goodwill. Any remaining impairment loss is charged pro rata to the other assets in the cash-generating unit, except that the carrying value of an asset will not be reduced below its individual fair value less cost of disposal, or value in use, if determinable.

An impairment loss on goodwill is not reversed in subsequent periods. In respect of other assets, an impairment loss is reversed if there has been a favourable change in the estimates used to determine the asset's recoverable amount and only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

2.19 Employee benefits

Retirement benefit

Retirement benefits to employees are provided through defined contribution plans.

The Group operates a defined contribution retirement benefit plan under the Mandatory Provident Fund Schemes Ordinance (the "MPF Scheme"), for all of its employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries.

Contributions are recognised as an expense in profit or loss as employees render services during the year. The Group's obligations under these plans are limited to the fixed percentage contributions payable.

Short-term employee benefits

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the reporting date.

Non-accumulative compensated absences such as sick leave and maternity leave are not recognised until the time of leave.

Equity-settled share-based compensation

In January 2018, the Group adopted a Share Option Scheme (Note 28) under which the Group receives services from employees as consideration for equity instruments (options) of the Group. The fair value of the services received in exchange for the grant of the equity instruments is recognised as expense.

The total amount to be expensed is determined by reference to the fair value of options granted including any market performance conditions; excluding the impact of any service and non-market performance vesting conditions; and including the impact of any non-vesting conditions.

The total expense is recognised over the vesting period over which all of the specified vesting conditions are to be satisfied.

僱員的退休福利乃透過定額供款計劃提供。

本集團根據強制性公積金計劃條例為所有合資格參與的僱員施行一項定額供款退休福利計劃(「強積金計劃」)。供款乃基於僱員基本薪金的百分比作出。

供款於僱員提供服務時在年內損益入賬列為開支。本集團於該等計劃下的義務乃受限於固定比例的應付供款。

短期僱員福利

僱員享有年假的權利於僱員有權享用年假時確認。本集團就僱員直至報告日為止提供的服務所產生的估計年假負債作出撥備。

非累計有補償缺勤(如病假及產假)於僱員支取假期時方會確認。

以權益結算以股份為基礎的補償

於2018年1月，本集團採納購股權計劃(附註28)，據此，本集團獲僱員提供服務，作為本集團權益工具(購股權)的代價。為換取獲授權益工具所接受服務的公允價值乃確認為開支。

將支銷的費用總額乃參照所授出購股權的公允價值釐定；包括任何市場表現條件；不包括任何服務及非市場表現歸屬條件所產生的影響；惟包括任何非歸屬條件的影響。

費用總額於歸屬期內確認，所有指定歸屬條件須於該歸屬期內達成。

At the end of each reporting period, the Group revises its estimates of the number of options that are expected to vest based on the non-market vesting and service conditions. The Group recognises the impact of the revision to original estimates, if any, in profit or loss, with a corresponding adjustment to equity.

When the options are exercised, the Company issues new shares. The proceeds received net of any directly attributable transaction costs are credited to share capital (nominal value) and share premium.

2.20 Borrowing costs

Borrowing costs are expensed when incurred.

2.21 Accounting for income tax

Income tax comprises current tax and deferred tax.

Current income tax assets and/or liabilities comprise those obligations to, or claims from, fiscal authorities relating to the current or prior reporting period, that are unpaid at the reporting date. They are calculated according to the tax rates and tax laws applicable to the fiscal periods to which they relate, based on the taxable profit for the year. All changes to current tax assets or liabilities are recognised as a component of tax expense in profit or loss.

Deferred tax is calculated using the liability method on temporary differences at the reporting date between the carrying amounts of assets and liabilities in the financial statements and their respective tax bases. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, tax losses available to be carried forward as well as other unused tax credits, to the extent that it is probable that taxable profit, including existing taxable temporary differences, will be available against which the deductible temporary differences, unused tax losses and unused tax credits can be utilised.

Deferred tax assets and liabilities are not recognised if the temporary difference arises from goodwill or from initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither taxable nor accounting profit or loss.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax is calculated, without discounting, at tax rates that are expected to apply in the period the liability is settled or the asset realised, provided they are enacted or substantively enacted at the reporting date.

Changes in deferred tax assets or liabilities are recognised in profit or loss, or in other comprehensive income or directly in equity if they relate to items that are charged or credited to other comprehensive income or directly in equity.

When different tax rates apply to different levels of taxable income, deferred tax assets and liabilities are measured using the average tax rates that are expected to apply to the taxable income of the periods in which the temporary differences are expected to reverse.

The determination of the average tax rates requires an estimation of (1) when the existing temporary differences will reverse and (2) the amount of future taxable profit in those years. The estimate of future taxable profit includes:

- income or loss excluding reversals of temporary differences; and
- reversals of existing temporary differences.

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Estimation uncertainty

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below:

Estimation of goodwill impairment

The Group tests annually whether goodwill has suffered any impairment in accordance with the accounting policy stated in Note 2.18. The recoverable amounts of cash-generating units have been determined based on value in use calculations. These calculations require the use of estimates about future cash flows and discount rates. In the process of estimating expected future cash flows, management makes assumptions about future revenues and profits. These assumptions relate to future events and circumstances. The actual results may vary and may cause a material adjustment to the carrying amount of goodwill within the next financial year. Determining the appropriate discount rate involves estimating the appropriate adjustment for market risk and for asset specific risk factors. Details of the estimates of the recoverable amounts of cash-generating units containing goodwill are disclosed in Note 16.

Valuation of contingent consideration payable

For acquisitions accounted for under HKFRS 3, future anticipated payments to vendors in respect of earnouts are based on the management's best estimates of future obligations, which are dependent on future performance of the interests acquired and assume the operating companies improve profits in line with management's estimates and are included in liabilities greater or less than one year as appropriate. These estimates will likely differ from future actual results of operations and cash flows, and it is possible that these differences could be material. Changes to earnouts are recorded in the profit or loss. Details of contingent consideration payable are set out in Notes 32 and 34.6.

Allowance for inventories

Net realisable value of inventories (Note 18) is the actual or estimated selling price in the ordinary course of business, less the estimated costs necessary to make the sale. These estimates are based on the current market condition and the historical experience of selling products of similar nature. It could change significantly as a result of competitor actions in response to changes in market condition. Management reassesses these estimations at the end of each reporting period.

Estimation of impairment of trade receivables and other financial assets at amortised cost within the scope of ECL under HKFRS 9

The Group makes allowances on items subjects to ECL (including trade and other receivables) based on assumptions about risk of default and expected loss rates. The Group uses judgment in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward looking estimates at the end of each reporting period as set out in Note 2.10. As at 31 March 2020, the carrying amount of trade and other receivables amounted to HK\$47,901,000 (net of ECL allowance of HK\$700,000) (2019: HK\$29,626,000 (net of ECL allowance of HK\$nil)).

When the actual future cash flows are different from expected, such difference will impact the carrying amount of trade and other receivables within the scope of ECL under HKFRS 9 and credit losses in the periods in which such estimate has been changed.

The bank borrowings are denominated in the United States Dollars ("USD"), with effective interest rate of 2.7% (2019: 4.3%) per annum as at 31 March 2020. As at 31 March 2020 and 2019, the bank borrowings are secured by the Group's life insurance policy with sum insured of USD1,000,000 (Note 17).
- (ii) As at 31 March 2020, the bank borrowings of HK\$5,504,000 are unsecured, repayable within 3 months after the reporting date and bear fixed interest rate with effective interest rate of 4.5% per annum.

As at 31 March 2019, the bank borrowings of HK\$71,000 are unsecured, repayable by monthly instalments with terms of 5 years and bears interest at floating rates. The bank borrowings are denominated in HK\$, with effective interest rate of 4.1% per annum as at 31 March 2019. The bank borrowings was fully repaid during the year ended 31 March 2020.

The Group's banking facilities are subject to the fulfilment of covenants which are commonly found in lending arrangements with financial institutions. If the Group was to breach the covenants, the draw down facilities would become payable on demand. In addition, the bank loan agreements contain clauses which give the lender the right at its sole discretion to demand immediate repayment at any time irrespective of whether the Group has complied with the covenants and met the scheduled repayment obligations. The Group regularly monitors its compliance with these covenants, whether it is up to date with the scheduled repayments of the loans and does not consider it is probable that the bank will exercise its discretion to demand repayment so long as the Group continues to meet these requirements.

No options may be granted under the Share Option Scheme or any other share option schemes adopted by the Group if the grant of such options will result in the limit referred herein being exceeded.

The total number of shares which may be issued upon exercise of all options (excluding, for this purpose, options which have lapsed in accordance with the terms of the Share Option Scheme and any other share option schemes of the Group) to be granted under the Share Option Scheme and any other share option schemes of the Group shall not in aggregate exceed 10% of share capital in issue as at the date on which dealings in the Company's shares first commence on the Stock Exchange, being 158,400,000 shares (the "General Scheme Limit").

34.2 Credit risk

The Group is exposed to credit risk in relation to its cash and bank deposits and trade and other receivables. The Group's maximum exposure to credit risk in relation to financial assets is limited to the carrying amount at the reporting dates as summarised in Note 34.1.

(i) Trade receivables

The Group's policy is to deal only with credit worthy counterparties. Credit terms are granted to new customers after a credit worthiness assessment by the credit control department. When considered appropriate, customers may be requested to provide proof as to their financial position. Where available at reasonable cost, external credit ratings and/or reports on customers are obtained and used. Customers who are not considered creditworthy are required to pay in advance or on delivery of goods. Payment record of customers is closely monitored. It is not the Group's policy to request collateral from its customers.

In addition, as set out in Note 2.10, the Group assesses ECL under HKFRS 9 on trade receivables based on provision matrix, the expected loss rates are based on the payment profile for sales in the past 36 months as well as the corresponding historical credit losses during that period. The historical rates are adjusted to reflect current and forwarding looking macroeconomic factors affecting the customer's ability to settle the amount outstanding. At each reporting date, the historical default rates are updated and changes in the forward-looking estimates are analysed. However, given the short period exposed to credit risk, the impact of these macroeconomic factors has not been considered significant within the reporting period.

Trade receivables are written off (i.e. derecognised) when there is no reasonable expectation of recovery. Failure to make payments within 365 days from the invoice date and failure to engage with the Group on alternative payment arrangement amongst other is considered indicators of no reasonable expectation of recovery.

34.2 信貸風險

本集團就其現金及銀行存款以及貿易及其他應收款項承擔信貸風險。本集團就金融資產承擔的最大信貸風險不超過於報告日的賬面金額(如附註34.1所概述)。

(i) 貿易應收款項

本集團的政策是僅與信譽良好的交易對手進行交易。新客戶須通過信貸監控部門進行的信貸信用評估後，方可獲授信貸條款。在適當情況下，客戶可能會被要求提供有關其財務狀況的證明。在成本合理的情況下，會索取並使用客戶的外部信貸評級及／或報告。被視為信譽不佳的客戶須提前付款或貨到付款。本集團密切監察客戶的付款記錄。本集團的政策並無要求客戶提供抵押品。

此外，如附註2.10所載，本集團根據香港財務報告準則第9號按撥備矩陣評估貿易應收款項的預期信貸虧損，預期虧損率基於過去36個月的銷售付款情況以及該期間的相應歷史信貸虧損計算。本集團會調整歷史利率，以反映影響客戶結算未付金額的能力的當前及前瞻性宏觀經濟因素。於各報告日，本集團更新歷史違約率，並分析前瞻性估計的變化。然而，鑒於承擔信貸風險的時間較短，故該等宏觀經濟因素於報告期內的影響被視為並不重大。

當沒有合理的收回預期時，貿易應收款項會被撇銷(即終止確認)。未能於自發票日期起計365天內付款，以及未能與本集團就替代付款安排達成協定，均被視為沒有合理收回預期的指標。

As at 31 March 2019, assessed lifetime ECL rate of trade receivables is not material as there are no recent history of default and continuous payment received. Based on historical and forward-looking elements specific to the customers and the economic environment, it was determined that no loss allowance provision is necessary in respect of these balances as there has not been a significant changes in credit quality of the customers. As at 31 March 2020, ECL allowance of HK\$700,000 was recognised for trade receivables from the furniture agency service segment at ECL rate of 1.0% for trade receivables that are not yet past due and 2.4% for trade receivables that are past due within 90 days. While ECL allowance is not material for trade receivables from the furniture sale and consultancy services segment.

As at 31 March 2020, 70.2% (2019: 86.6%) of the total gross trade receivables was due from a customer arisen from the furniture agency service.

(ii) Other financial assets at amortised cost

Other financial assets at amortised cost include other receivables and bank balances and cash. In order to minimise the credit risk of other receivables, the management of the Group has designated a team responsible for determination of credit limits and credit approvals. The management would make periodic collective and individual assessment of the recoverability of other receivables based on historical settlement records and past experience as well as current external information. Other monitoring procedures are in place to ensure that follow-up action is taken to recover overdue debts. If the credit risk of debt instruments is considered to be high, collateral is required before granting the debts to debtors. In these regards, the credit risk of other receivables is considered to be low. Thus, no loss allowance provision was recognised during the year ended 31 March 2020 (2019: nil).

(i) 貿易應收款項 (續)

於2019年3月31日，由於最近沒有違約記錄及持續收到付款，故貿易應收款項的經評估全期預期信貸虧損率並不重大。根據客戶特定的歷史及前瞻性因素以及經濟環境，由於客戶的信貸質量沒有發生重大變化，故確定毋須為該等結餘作出虧損備抵撥備。於2020年3月31日，傢俱代理服務分部已按1.0%（未逾期的貿易應收款項）及2.4%（逾期90日內的貿易應收款項）的預期信貸虧損率就貿易應收款項確認預期信貸虧損備抵700,000港元，而傢俱銷售及諮詢服務分部的貿易應收款項預期信貸虧損備抵則並不重大。

於2020年3月31日，貿易應收款項總額中，70.2%（2019年：86.6%）為應收傢俱代理服務一名客戶的款項。

(ii) 按攤銷成本計量的其他金融資產

按攤銷成本計量的其他金融資產包括其他應收款項以及銀行結餘及現金。為盡量減低其他應收款項的信貸風險，本集團管理層已指定一個團隊負責釐定信貸限額及審批信貸。管理層將根據過往結算記錄及以往經驗以及當前外部資料，定期對其他應收款項的可收回性進行共同及個別評估。本集團亦已實施其他監控程序，以確保採取跟進行動收回逾期債務。倘債務工具的信貸風險被視為高，則債務人須於授出債務前提供抵押品。就此而言，其他應收款項的信貸風險被視為低。因此，截至2020年3月31日止年度並無確認虧損備抵撥備（2019年：無）。

While bank balances and cash are also subject to the impairment requirements of HKFRS 9, the Group only places deposits in reputable banks and financial institutions, the identified impairment loss was immaterial.

34.3 Liquidity risk

Liquidity risk relates to the risk that the Group will not be able to meet its obligations associated with its financial liabilities that are settled by delivering cash or another financial asset. The Group is exposed to liquidity risk in respect of settlement of trade payables and its financial obligations, and also in respect of its cash flow management. The Group's policy is to regularly monitor current and expected liquidity requirements and its compliance with lending covenants and its relationship with its bankers to ensure that the Group maintain sufficient reserves of cash and cash equivalents and committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term.

Analysed below is the Group's remaining contractual maturities for its financial liabilities as at 31 March 2020 and 2019, based on undiscounted cash flows (including interest payments computed using contractual rates or, if floating, based on rates current at the end of the reporting periods) and the earliest date the Group can be required to pay. When the creditor has a choice of when the liability is settled, the liability is included on the basis of the earliest date when the Group can be required to pay. Where the settlement of the liability is in instalments, each instalment is allocated to the earliest period in which the Group is committed to pay.

流動資金風險乃與本集團無法透過交付現金或另一金融資產結算金融負債而履行其責任的風險有關。本集團在償還貿易應付款項及其財務責任，以及在現金流量管理方面承擔流動資金風險。本集團的政策為定期監察當前和預期流動資金需求、遵守貸款契諾的情況及其與往來銀行的關係，以確保本集團維持充足的現金及現金等價物儲備以及從主要金融機構取得承諾融資額度，以應付其短期及長期的流動資金需求。

以下分析於2020年及2019年3月31日，本集團金融負債的剩餘合約到期日，乃根據未折現現金流量(包括以合約利率計算的利息付款，或若為浮動利率，則以報告期末的現行利率計算)以及本集團可被要求付款的最早日期呈列。倘債權人有權選擇償還負債的時間，有關負債將於本集團可被要求付款的最早日期入賬。倘有關負債須分期償還，則每筆還款將於本集團承諾付款的最早期間入賬。

Interest rate risk relates to the risk that the fair value or cash flows of a financial instrument will fluctuate because of changes in the market interest rates. The Group's interest rate risk arises primarily from bank borrowings and lease liabilities/finance lease liabilities. The Group's bank borrowings bearing variable rates and fixed rates expose the Group to cash flow interest rate risk and fair value interest rate risk respectively. 35. CAPITAL MANAGEMENT

The objectives of the Group when managing capital are to safeguard the ability of the Group in continuing as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to enhance shareholders' value in the long term.

The Group actively and regularly reviews its capital structure and makes adjustments in light of changes in economic conditions. The Group monitors its capital structure on the basis of the gearing ratio. The gearing ratio is calculated based on total interest-bearing borrowings divided by the total equity at each reporting date. In order to maintain or adjust the ratio, the Group may adjust the amount of dividends paid to shareholders, issue new shares, raise new debt financing or sell assets to reduce debt.

36. EVENTS AFTER THE REPORTING PERIOD

For the year ended 31 March 2020, the operating results has been affected by the outbreak of the Coronavirus Disease (the "COVID-19") in early 2020.
