This announcement is made pursuant to the requirements of Rule 17.10(2)(a) of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board of Directors (the “**Board**”) of CCID Consulting Company Limited* (the “**Company**”) together with its subsidiaries, the “**Group**”) wishes to inform the shareholders and potential investors of the Company that, based on the preliminary assessment of the latest unaudited consolidated management accounts of the Group and the information currently available to the Company, the Group expects to record a loss of approximately RMB15,233 thousand for the six months ended 30 June 2020 (the “**Current Period**”), compared to the corresponding period of last year’s profit of RMB13,656 thousand as shown in the Group’s unaudited interim report for the six months ended 30 June 2019 (the “**Last Period**”) published on 13 August 2019.

Turning profit into loss in this Current Period was mainly attributable to quarantine measures adopted in a number of cities in China because of the outbreak of the novel coronavirus (COVID-19) in the first half of 2020, which has adversely affected the business operation of the Group to a certain extent.

As at the date of this announcement, the Group has fully resumed its business and accelerated its business expansion. However, the acceptance of certain projects delivery of the Group has been delayed due to the impact of the quarantine measures, and no revenue has been recognized for the sake of prudence.

In view of the current global development of the COVID-19 pandemic, there are still uncertainties in the market demand and prospect in the future. The Group is closely monitoring market conditions and will adjust its strategies in due course.

As the Company is still finalizing the interim results for the Current Period, the information contained in this announcement is based on the preliminary assessment by the Company's management on the consolidated management accounts which have not been audited by the Group's auditor or reviewed by the audit committee of the Company. Shareholders and potential investors of the Company should read carefully the Group's interim results announcement for the Current Period scheduled to be published by the Company on 7 August 2020.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
