Your proxy will also be entitled to vote at his/her discretion on any resolutions properly put to the H Share Class Meeting other than those referred to in the notice of the H Share Class Meeting.
5. Any member entitled to attend and vote at the H Share Class Meeting shall be entitled to appoint another person as his/her proxy to attend and vote instead of him/her. A member who is the holder of two or more shares may appoint more than one proxy to represent him/her to attend and vote on his/her behalf at the H Share Class Meeting. A proxy needs not be a member. In addition, a proxy or proxies representing either a member who is an individual or a member which is a corporation shall be entitled to exercise the same powers on behalf of the member which he/she or they represent as such member could exercise.
6. This Form of Proxy shall be signed by the Shareholder or his/her attorney duly authorised in writing, or, if the Shareholder is a corporation, either under its seal or under the hand of an officer or its attorney duly authorised in writing. In the case of this Form of Proxy purporting to be signed on behalf of a corporation by an officer thereof it shall be assumed, unless the contrary appears, that such officer was duly authorised to sign this Form of Proxy on behalf of the corporation without further evidence of the facts.

To be valid, this Form of Proxy, together with the power of attorney (if required by the board of directors) or other authority (if any) under which it is signed or a notarially certified copy of such power of attorney or authority must be deposited in person or by mail to the Company's H share registrar, Tricolor Tengis Limited at Level 54, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not less than 24 hours before the time appointed for holding the H Share Class Meeting or 24 hours before the time appointed for holding any adjourned meeting.
8. For joint Shareholders, only the Shareholder named first in the Shareholders' register has the right to receive the notice of the Company, attend the H Share Class Meeting of the Company and exercise his voting right.
9. Completion and delivery of this Form of Proxy will not preclude you from attending and voting at the H Share Class Meeting if you so wish.
