On 14 September 2020, the Grand Court of the Cayman Islands ordered the Company be wound up under the provisions of section 92(d) of the Companies Law (2020 Revision) and Ms. Anita So of Ernst & Young Transactions Limited, together with Ms. Tammy Karina Fu of EY Cayman Ltd, have been appointed as the joint official liquidators of the Company.

Upon request of the Company, trading in the shares of the Company on The Stock Exchange of Hong Kong Limited has been suspended since 9:00 a.m. on 8 July 2019 (Monday). Trading in the shares of the Company will remain suspended until further notice.
