PROFIT WARNING

This announcement is made by Excalibur Global Financial Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the preliminary review and analysis of the unaudited financial information of the Group for nine months ended 30 September 2020, the Group is anticipated to record a loss attributable to equity shareholders of the Company of approximately HK\$12.6 million for the nine months ended 30 September 2020 as compared to a loss attributable to equity shareholders of the Company of approximately HK\$5.6 million for the nine months ended 30 September 2019. The Board attributed such deterioration in financial performance primarily to (1) the drop in revenue of the Group from approximately HK\$18.2 million for the nine months ended 30 September 2019 to approximately HK\$8.6 million for the nine months ended 30 September 2020; (2) payment of one-off bonus of HK\$2.0 million to executive directors of the Group for the nine months ended 30 September 2020 (nine months ended 30 September 2019: Nil), which was partly offset by the decrease in marketing expenses of approximately HK\$1.7 million for the nine months ended 30 September 2020.

The Company is in the process of finalising the quarterly results of the Group for the nine months ended 30 September 2020. The information contained in this announcement is only based on the information currently available to the Board, including the preliminary assessment by the Board of the unaudited consolidated financial information of the Group for nine months ended 30 September 2020, which has not been audited or reviewed by the independent auditors and the audit committee of the Company. Details of the quarterly results of the Group for the nine months ended 30 September 2020 is expected to be announced before 14 November 2020.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
