POSITIVE PROFIT ALERT

This announcement is made by BOSA Technology Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the preliminary review of the unaudited consolidated management accounts of the Group for the three months ended 30 September 2020, the Group expected that a substantial increase of not less than 150% in net profit after tax will be recorded in current period as compared to the same period in 2019. The aforesaid increase in net profit after tax is mainly due to increase in revenue from sales of couplers resulted from increase in new projects and customers and also the receipt of a special government subsidy under Employment Support Scheme.

As the Company is still in the process of finalizing the first quarterly results for the three months ended 30 September 2020 (the “**First Quarterly Results 2020/21**”), the information contained in this announcement is only based on the Board’s preliminary assessment of the unaudited consolidated management accounts of the Group for the three months ended 30 September 2020 which have not been finalized nor reviewed by the audit committee and audited by the auditor, and subject to adjustments. Details of the Group’s financial information and performance will be disclosed in the Group’s first quarterly results announcement for the three months ended 30 September 2020 which is expected to be released on 12 November 2020.

Shareholders of the Company and potential investors should exercise caution when dealing in the shares of the Company.
