Reference is made to the announcement issued by the Company dated 2 November 2020 in relation to the convening of a meeting (the “**Board Meeting**”) of the board (the “**Board**”) of directors (the “**Directors**”) of the Company held on Thursday, 12 November 2020 for the purposes of, amongst others, considering and approving the unaudited financial results of the Group for the nine months ended 30 September 2020 (the “**2020 Third Quarterly Results**”), and considering the payment of an interim dividend, if any.

### **DELAY IN PUBLICATION OF THE THIRD QUARTERLY RESULTS AND DELAY IN DESPATCH OF THE THIRD QUARTERLY REPORT FOR THE NINE MONTHS ENDED 30 SEPTEMBER 2020**

The Board announces that, additional time is required for the preparation of the financial information of the Group for the nine months ended 30 September 2020, the Company (i) will be unable to publish its 2020 Third Quarterly Results by 14 November 2020, and (ii) will be unable to despatch its third quarterly report for the nine months ended 30 September 2020 (the “**2020 Third Quarterly Report**”) to its Shareholders by 14 November 2020 as required under the GEM Listing Rules.

The delay in the publication of the 2020 Third Quarterly Results and the delay in the despatch of the 2020 Third Quarterly Report will constitute non-compliance with Rules 18.66 and 18.79 of the GEM Listing Rules.

## **POSTPONEMENT OF BOARD MEETING**

The Board announces that due to the delay in the finalisation of the 2020 Third Quarterly Results, the Board Meeting originally scheduled will be postponed to another date to be fixed by the Board immediately upon the finalization of the 2020 Third Quarterly Results.

It is expected that the publication of the 2020 Third Quarterly Results and despatch of the 2020 Third Quarterly Report will be in or around mid-December. The Company will publish further announcement(s) to inform the Shareholders of the date of the Board Meeting in accordance with the requirements of the GEM Listing Rules.

## **EXPECTED TRADING HALT**

Due to the delay in publication of the 2020 Third Quarterly Result and despatch of the 2020 Third Quarterly Report, it is expected that trading in the shares of the Company on the Stock Exchange will be halted with effect from 9:00 a.m. on Monday, 16 November 2020 until the publication of the 2020 Third Quarterly Results and the despatch of the 2020 Third Quarterly Report. Further announcement will be made by the Company in this respect as and when appropriate.
