PROFIT ALERT

This announcement is made by Zhejiang United Investment Holdings Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on information currently available to the Board, the Group expects to record a profit of approximately HK\$3.7 million for the six months ended 31 October 2020 as compared to a loss of approximately HK\$16.8 million for the six months ended 31 October 2019. The expected turnaround from loss to profit is mainly due to (i) absence of one-off equity-settled share-based payment expenses granted to employees in last period; (ii) significant decrease in depreciation of right-of-use assets; and (iii) increase in gross profit margin as a result of revenue generated from our new business of advertising in respect of the Company’s announcement dated 31 August 2020. Such turnaround was partially offset by provision of income tax expenses.

The Company is still in the process of finalising the interim results of the Group for the six months ended 31 October 2020. The information contained in this announcement is only based on the draft unaudited condensed consolidated financial statements of the Group for the six months ended 31 October 2020 and the information available for the time being, which have neither been reviewed by the audit committee of the Company nor audited by the Company's auditors. The above information may be subject to adjustment based on further updated information and the review by the Company's audit committee. Shareholders and potential investors are advised to read carefully the interim results announcement of the Group for the six months ended 31 October 2020, which is expected to be released on 23 December 2020.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
