On 14 September 2020, an indirectly wholly-owned subsidiary of the Company as the issuer entered into the placing agreement with Plutus Securities Limited (the "Arranger"), pursuant to which the Arranger has conditionally agreed to, on a best effort basis, procure placees to subscribe for the convertible bonds of an aggregate principal amount of up to HK\$198.0 million with the conversion price of HK\$0.11. The 1,800,000,000 conversion shares , in the event that all the Convertible Bonds are converted in full at the initial conversion price of HK\$0.11, will be issued and allotted under the specific mandate which will be sought from the shareholders at the special general meeting.
