This announcement is made by Hi-Level Technology Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) of Part XIVA of the Securities and Future Ordinance (Chapter 571, Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform shareholders of the Company and potential investors that, based on the information currently available to the Company, it expected that the consolidated profit attributable to owners of the Company for the year ended 31 December 2020 will be not less than HK\$30,000,000 representing an increase of not less than 105% as compared to the audited consolidated profit attributable to owners of the Company for the year ended 31 December 2019. Such increase was mainly attributable to, as compared to the same recorded during the year ended 31 December 2019, the increase in the Group’s revenue and the reduction in the Group’s overall expenses during the year ended 31 December 2020.

The Company is in the process of finalizing the consolidated financial results of the Group for the year ended 31 December 2020. The information contained in this announcement represents only a preliminary assessment by the Company of the unaudited consolidated management account of the Group for the year ended 31 December 2020 and the information currently available to the Company, which have not been audited or reviewed by the Company's auditor and/or the audit committee of the Company and may therefore be subject to changes. Shareholders of the Company and potential investors should read the Group's financial results announcement for the year ended 31 December 2020 carefully, which is expected to be published in the middle of March 2021.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
