**On 15 January 2021, at the extraordinary general meeting of China Information Technology Development Limited, the shareholders of the Company had approved to proceed with the capital reorganization involving, among others, (i) the share consolidation by which every twenty-four (24) issued and unissued existing shares of the Company consolidated into one (1) consolidated share (the “Consolidated Share(s)”) of HK\$2.40 (the “Share Consolidation”); (ii) the capital reduction by which (a) cancelled any fractional consolidated share in the issued share capital of the company arising from the Share Consolidation; and (b) reduced the par value of all then issued Consolidated Shares from HK\$2.40 each to HK\$0.01 each by cancelling the paid-up capital of the Company to the extent of HK\$2.39 on each of the then issued Consolidated Shares in issue; and (iii) the share subdivision of every authorized but unissued Consolidated Shares of par value of HK\$2.40 each into two hundred and forty (240) New Shares of par value of HK\$0.01 each.**
