This announcement is made by Hon Corporation Limited (the “**Company**”) in accordance with Rules 17.10 and 17.27 of the Rule Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong (the “**GEM Listing Rules**”) and the Inside Information Provision (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinances (Chapter 571) of the Laws of Hong Kong.

Reference is made to the announcements of the Company dated 2 February 2021 and 15 March 2021 (the “**Announcements**”) regarding several winding up petitions received by the Company on 10 November 2020, 15 December 2020, 20 January 2021, 27 January 2021 and 1 February 2021, respectively (collectively the “**Petitions**”).

Unless otherwise defined, capitalised terms used but not otherwise defined herein shall have the meaning ascribed to them in the Announcements.

The Company would like to provide update on the status of the Petitions as follow:

- (a) as disclosed in the Announcements, the hearing of Petition A was adjourned to 19 March 2021 and the High Court of the Supreme Court of the Republic of Singapore has ordered the hearing for Petition A be adjourned to 26 March 2021;
- (b) as disclosed in the Announcements, the hearing of Petition B was adjourned to 19 March 2021 and the High Court of the Supreme Court of the Republic of Singapore has ordered the hearing for Petition B be adjourned to 19 April 2021;
- (c) as disclosed in the Announcements, the hearing of Petition C was adjourned to 19 March 2021 and the High Court of the Supreme Court of the Republic of Singapore has ordered the hearing for Petition C be adjourned to 20 August 2021;

- (d) as disclosed in the Announcements, the hearing of Petition D was adjourned to 19 March 2021 and the High Court of the Supreme Court of the Republic of Singapore has ordered the hearing for Petition D be adjourned to 9 April 2021; and
- (e) as disclosed in the Announcements, the hearing of Petition E was adjourned to 19 March 2021 and the High Court of the Supreme Court of the Republic of Singapore has ordered the hearing for Petition E be adjourned to 9 April 2021.

The Company will make further announcements to update the shareholders of the Company and potential investors on the development of the Petitions as and when appropriate. As of the date of this announcement, the Company and its subsidiaries are still carrying out their day-to-day operations under the management of the board of the directors of the Company.
