The Company would like to clarify that the disclosure in the FY2020 Results Announcement is correct and the difference has no effect on the Group's consolidated statement of profit or loss, other comprehensive income and consolidated statement of financial position for the year ended 31 December 2019. Therefore, there is no effect to the entire financial performance of the Group.

Save for the above information, other content of the FY2019 Results Announcement and FY2020 Results Announcement has not been changed.

At the request of the Company, trading in the shares of the Company has been suspended since 9:00 a.m. on 11 March 2020 and will remain suspended until the Company fulfills the Resumption Guidance.
