PROFIT WARNING

This announcement is made by Super Strong Holdings Limited (the **“Company”**), and together with its subsidiaries, the **“Group”**) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the **“GEM Listing Rules”**) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the **“Board”**) of directors (the **“Directors”**) of the Company would like to inform the shareholders of the Company (the **“Shareholders”**) and potential investors that, based on information currently available to the Board and preliminary review of the unaudited consolidated management accounts of the Group for the nine months ended 31 March 2021 (the **“Period”**), the Group expects to record a loss attributable to owners of the Company of approximately HK\$33.0 million as compared to a profit attributable to owners of the Company of approximately HK\$4.6 million for the corresponding period in 2020. Such loss was mainly attributable to the decrease in the Group’s revenue of more than 60% as compared to the corresponding period in 2020, due to the delay of committed projects, failure in winning new tenders and the COVID-19 pandemic during the Period together with additional follow-up defects costs in closing the projects.

The information contained in this announcement is only based on preliminary review by the Company’s management on the unaudited consolidated management accounts of the Group and the information currently available. The Group is still in the process of finalizing the third quarterly results for the nine months ended 31 March 2021 which is expected to be announced on 11 May 2021.

As the Company is still in the course of finalising its third quarterly results for the Period, the information contained in this announcement is only based on the preliminary assessment by the Board of the information currently available to it including but not limited to the draft unaudited consolidated management accounts of the Group for the Period, which has not been reviewed nor audited by the auditors of the Company nor reviewed by the audit committee of the Board as at the date of this announcement and is subject to possible adjustments upon further review.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
