**CHARACTERISTICS OF THE GEM OF THE STOCK EXCHANGE OF HONG KONG LIMITED

HIGHLIGHTS

- The Group recorded a turnover of approximately RMB6,006,000 for the three months ended 31 March 2021, representing an increase of approximately 35.24% as compared with that of the corresponding period in 2020.
- The Group recorded a loss attributable to the owners of the parent of approximately RMB2,688,000 for the three months ended 31 March 2021. A loss attributable to the owners of the parent for the corresponding period in 2020 was approximately RMB9,705,000.
- The Directors do not recommend the payment of an interim dividend for the three months ended 31 March 2021 (2020: Nil).

1. BASIS OF PRESENTATION

The Financial statements has been prepared on the going-concern basis and transactions and events actually occurred in accordance with the “Accounting Standards for Business Enterprises” promulgated by the Ministry of Finance of the People’s Republic of China and relevant requirements (collectively, the “Accounting Standards for Business Enterprises”), and China Securities Regulatory Commission’s “Compilation Rules for Information Disclosure by Companies Offering Securities to the Public No. 15 – General Provisions on Financial Reports (2014 Revision)” and the provisions regarding disclosure pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Companies Ordinance of Hong Kong, as well as based on the accounting policies and accounting estimation as stated in “4. Significant Accounting Policies and Accounting Estimation” under the notes.

2. TURNOVER

Turnover represents revenue from the development and provision of business application solutions and application software, the installation and maintenance of network and data security products, and the sales of electrical products and accessories.

4. TAX EXPENSES

Pursuant to the Enterprise Income Tax Law of the People's Republic of China ("EIT") and its Implementation Regulations, the tax rate of the Company and its subsidiaries was 15% and 25% respectively from 1 January 2017 onwards.

For the three months ended 31 March 2021, there was no material unprovided deferred tax (2020: nil).

5. LOSS PER SHARE

The calculation of the basic loss per share for the three months ended 31 March 2021 is based on the unaudited loss attributable to the owners of the parent of approximately RMB2,688,000 (2020: loss attributable to the owners of the parent of approximately RMB9,705,000) and the weighted average number of shares during the period (three months ended 31 March 2021: 480,000,000 shares; three months ended 31 March 2020: 480,000,000 shares).

Diluted loss per share is not presented for the three months ended 31 March 2021 as there were no potential ordinary shares in issue during the relevant periods.

6. INTERIM DIVIDEND

The Directors do not recommend the payment of an interim dividend for the three months ended 31 March 2021 (2020: Nil).

MANAGEMENT DISCUSSION AND ANALYSIS

FINANCIAL REVIEW

For the three months ended 31 March 2021, the Group recorded a turnover of approximately RMB6,006,000, representing an increase of approximately RMB1,565,000 or 35.24% (2020: approximately RMB4,441,000) as compared to the corresponding period in 2020. The gross profit increased by approximately 74.93% to RMB3,063,000 as compared to the corresponding period in last year (2020: approximately RMB1,751,000). The Company continued to make loss for the first quarter of 2021 and recorded a loss of approximately RMB2,688,000. The loss has decreased by approximately RMB7,017,000 as compared with approximately RMB9,705,000 for the three months ended 31 March 2020.

BUSINESS REVIEW AND FUTURE PROSPECTS

In the sales review, revenue is mainly generated from the sales of electrical products and accessories. The sales amounted to RMB844,000, representing a decrease of RMB474,000 or 35.96% as compared to RMB1,318,000 in the corresponding period of last year. The decrease was mainly due to the influence from the epidemic.

Besides, for the sales of the business application solution and application software, its sales increased from RMB1,452,000 to RMB2,803,000, representing an increase of 93.04% over the corresponding period of last year. The decrease was mainly due to that the domestic epidemic was under control and the business volume gradually increased.

In terms of the sales of installation and maintenance of network and data security products, its sales increased from RMB1,671,000 to RMB2,359,000, representing an increase of 41.17% over the corresponding period of last year.

For the expenses management and control, administrative expenses amounted to RMB1,559,000, represented a decrease of RMB2,333,000 over the corresponding period of last year; and the expenses of marketing and sales amounted to RMB2,562,000, represented a decrease of RMB1,112,000 over the corresponding period of last year. The expenses of research and development amounted to RMB1,631,000, representing an increase of RMB402,000 over the corresponding period of last year.

In conclusion, the Company will take necessary proactive steps to monitor its financial condition. Meanwhile, it will also maintain its focus on cost control with the attempt to expand to new market areas, including acquiring new clients through the referrals by the existing clients and marketing initiatives by the management, so as to secure higher business volumes.

Shareholder of Jiaoda Industrial is Shanghai Jiaotong University (100%). Shanghai Jiaotong University is deemed to be interested in the aggregate of 114,000,000 domestic shares held by Jiaoda Industrial under the SFO.

These 60,000,000 domestic shares are registered and owned by Shanghai Xin Xuhui (Group) Company Limited, the registered capital of which will be owned as to approximately 88.57% by Xuhui District Industrial Association after the completion of certain capital reorganisation as referred to in the Prospectus. The Audit Committee comprises three independent non-executive Directors, Mr. Yuan Shumin, Dr. Ni Jing and Mr. Zhou Guolai. The Audit Committee has reviewed the unaudited results of the Company for the three months ended 31 March 2021.

PURCHASE, SALE OR REDEMPTION OF SECURITIES

Neither the Company nor any of its subsidiaries purchased, sold or redeemed any listed securities of the Company during the three months ended 31 March 2021.

CORPORATE GOVERNANCE
