2	To re-elect the following Directors of the Company: (a) Mr. Zhou Tianshu as an independent non-executive Director. (b) Ms. Wu Liyan as an independent non-executive Director.		
3	To authorise the board of Directors to fix the Directors' remuneration.		
4	To re-appoint HLB Hodgson Imprey Cheng Limited as the auditor of the Company and to authorise the board of directors to fix their remuneration.		
5	To grant a general mandate to the Directors of the Company to issue, allot and deal with new shares of the Company not exceeding 20% of the total number of the shares in issue of the Company as at the date of passing this resolution.		
6	To grant a general mandate to the Directors of the Company to buy back shares of the Company not exceeding 10% of the total number of the shares in issue of the Company as at the date of passing of this resolution.		
7	To extend the general mandate granted to the Directors of the Company to issue, allot and deal with new shares of the Company by the total number of issued shares bought back by the Company.

A proxy need not be a member of the Company. In addition, a proxy or proxies representing a member who is an individual or a member which is a corporation shall be entitled to exercise the same powers on behalf of the member which he/she/it or they represent as such member could exercise.

- The instrument appointing a proxy shall be in writing under the hand of the appointor or of his/her attorney duly authorised in writing, or, if the appointor is a corporation, either under seal, or under the hand of an officer or attorney duly authorised. In order to be valid, the instrument appointing a proxy and the power of attorney or other authority, if any, under which it is signed, or a notarially certified copy of such power or authority, shall be deposited at the share registrar and transfer office of the Company in Hong Kong, Union Registrars Limited, Suites 3301-04, 33/F., Two Chinachem Exchange Square, 338 King's Road, North Point, Hong Kong as soon as possible and in any event not less than 48 hours before the time appointed for holding of the AGM or any adjournment thereof.
- In the case of joint holders the vote of the senior who tenders a vote, whether in person or by proxy or by representative, shall be accepted to the exclusion of the votes of the other joint holders; and for this purpose seniority shall be determined by the order in which the names stand in the register of members of the Company in respect of the joint-holding.
- Delivery of an instrument appointing a proxy shall not preclude a member from attending and voting in person at the meeting concerned and in such event, the instrument appointing a proxy shall be deemed to be revoked.
- For the purpose of determining shareholders' entitlement to attend and vote at the AGM, the register of members of the Company will be closed from Friday, 11 June 2021 to Thursday, 17 June 2021 (both days inclusive) during which period no transfer of shares will be registered. In order to qualify for attending and voting at the AGM, all properly completed transfer forms accompanied by the relevant share certificates must be lodged for registration with the share registrar and transfer office of the Company in Hong Kong, Union Registrars Limited, Suites 3301-04, 33/F., Two Chinachem Exchange Square, 338 King's Road, North Point, Hong Kong not later than 4:00 p.m. on Thursday, 10 June 2021.
- Any alteration made in this form of proxy must be initialled by the person who signs it.
- All resolutions set out in the notice convening the AGM will be decided by poll at the AGM in accordance with the requirements of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited.
